Sec. 201. FOR THE DEPARTMENT OF SOCIAL AND HEALTH 3 NEW SECTION. 4 (1) Appropriations made in part II of this act to the SERVICES. 5 department of social and health services shall initially be allotted as required by this act. Upon the lapsing of any moneys 22 under this subsection, the office of financial management shall notify 23 the legislative fiscal committees. As used in this subsection, "unrestricted federal moneys" includes block grants and other funds 24 25 that federal law does not require to be spent on specifically defined 26 projects or matched on a formula basis by state funds.
- 27 (3) The appropriations in sections 202 through 208 of this act 28 shall be expended for the programs and in the amounts listed in those 29 sections.

- (1) \$176,525,000 is provided for a cost of living adjustment of 3.0 percent effective September 1, 1997, for state formula staff units. The appropriations include associated incremental fringe benefit allocations at rates of 19.58 percent for certificated staff and 15.15 percent for classified staff.
- (a) The appropriations in this section include the increased 13 14 portion of salaries and incremental fringe benefits for all relevant 15 state-funded school programs in part V of this act. Salary adjustments 16 for state employees in the office of superintendent of public instruction and the education reform program are provided in part VII 17 18 of this act.
