- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 65.04.045 and 1996 c 143 s 2 are each amended to read 5 as follows:
- 6 (1) When any instrument is presented to a county auditor or recording officer for recording, the first page of the instrument shall 8 contain:
- 9 (a) A top margin of at least three inches and a one-inch margin on 10 the bottom and sides, except that an instrument may be recorded if a 11 minor portion of a notary seal, incidental writing, or minor portion of 12 a signature extends beyond the margins;
- 13 (b) The top left-hand side of the page shall contain the name and 14 address to whom the instrument will be returned;
- (c) The title or titles, or type or types, of the instrument to be recorded indicating the kind or kinds of documents or transactions contained therein. The auditor or recording officer shall only be required to index the title or titles captioned on the document;

- (d) Reference numbers of documents assigned or released with 1 2 reference to the document page number where additional references can be found, if applicable; 3 4 (e) The names of the grantor(s) and grantee(s), as defined under 5 RCW 65.04.015, with reference to the document page number where additional names are <u>located</u>, if applicable; 6 7 (f) An abbreviated legal description of the property, including lot, block, plat, or section, township, and range, and reference to the 8 document page number where the full legal description is included, if 9 10 applicable; 11 (g) The assessor's property tax parcel or account number. (2) All pages of the document shall be on sheets of paper of a 12 weight and color capable of producing a legible image that are not 13 larger than fourteen inches long and eight and one-half inches wide 14 15 with text printed or written in eight point type or larger. Further, all instruments presented for recording must have a one-inch margin on 16 the top, bottom, and sides for all pages except page one, be prepared 17 in ink color capable of being imaged, and have all seals legible and 18 19 capable of being imaged, and no attachments may be affixed to the 20 pages. 21 The information provided on the instrument must be in substantially 22 the following form: 23 This Space Provided for Recorder's Use 24 When Recorded Return to: 25 26 Document Title(s) 27 Grantor(s) 28 Grantee(s)

- 4 If an instrument presented for recording does not contain the
- 5 information required by RCW 65.04.045(1) $((\frac{(a) \text{ through } (e)}{(a)}))$, the
- 6 person preparing the instrument for recording shall prepare a cover
- 7 sheet that contains the required information. The cover sheet shall be
- 8 attached to the instrument and shall be recorded as a part of the
- 9 instrument. An additional page fee as determined under RCW 36.18.010
- 10 shall be collected for recording of the cover sheet. Any errors in the
- 11 cover sheet shall not affect the transactions contained in the
- 12 instrument itself. The cover sheet need not be separately signed or
- 13 acknowledged. The cover sheet information shall be used to generate

- 22 recording instruments in the county records.
- 23 (2) "File," "filed," or "filing" means the act of delivering or
- 24 transmitting electronically an instrument to the auditor or recording
- 25 officer for recording into the official public records.
- 26 (3) "Record," "recorded," or "recording" means the process, such as
- 27 electronic, mechanical, optical, magnetic, or microfilm storage used by
- 28 the auditor or recording officer after filing to incorporate the
- 29 instrument into the public records.
- 30 (4) "Record location number" means a unique number that identifies
- 31 the storage location (book or volume and page, reel and frame,
- 32 instrument number, auditor or recording officer file number, receiving

- number, electronic retrieval code, or other specific place) of each instrument in the public records accessible in the same recording 2 3 office where the instrument containing the reference to the location is
- 4 found.
- 5 (5) "Grantor/grantee" for recording purposes means the names of the parties involved in the transaction used to create the recording index. 6
- There will always be at least one grantor and one grantee for any 7
- 8 document. In some cases, the grantor and the grantee will be the same
- individual(s), or one of the parties may be the public.
