- 1 AN ACT Relating to the filing of corporate documents by insurance 2 companies, health care service contractors, and health maintenance 3 organizations; amending RCW 48.06.060, 48.06.200, and 48.07.070; adding 4 a new section to chapter 23.86 RCW; adding a new section to chapter 5 23B.01 RCW; adding a new section to chapter 23B.02 RCW; adding new sections to chapter 23B.04 RCW; adding a new section to chapter 23B.10 6 7 RCW; adding a new section to chapter 23B.14 RCW; adding a new section to chapter 23B.15 RCW; adding new sections to chapter 24.03 RCW; adding 8 new sections to chapter 24.06 RCW; adding new sections to chapter 25.15 RCW; and adding a new section to chapter 48.02 RCW. 10
- 11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 12 **Sec. 1.** RCW 48.06.060 and 1947 c 79 s .06.06 are each amended to 13 read as follows:
- 14 Upon the filing of the bond required by RCW 48.06.110 after notice 15 by the commissioner, the commissioner shall:
- 16 (1)  $\underline{F}$ ile the articles of incorporation of the proposed incorporated
- 17 insurer or other corporation (( $with the secretary of state_{+}$ )); and
- 18 (2) <u>Issue</u> to the applicant a solicitation permit.

- 1 **Sec. 2.** RCW 48.06.200 and 1981 c 302 s 37 are each amended to read 2 as follows:

- 35 of not less than one dollar per share. If a mutual insurer, the
- 36 maximum contingent liability of its policyholders for the payment of

- Fifth: The duration of its existence, which may be perpetual.

If any other action is taken by 16 the insurance commissioner which affects a corporate or company name, 17 18 the insurance commissioner shall immediately notify the secretary of state of the action. The insurance commissioner shall cooperate with 19 the secretary of state to ascertain that there is no duplication of 20 21 corporate or company names.
