- 8 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 23B.14 RCW 9 to read as follows:
- 10 Any county, city, town, district, or other political subdivision of the state, or the state of Washington or any department 11 12 or agency of the state, may apply to the secretary of state for the administrative dissolution, or the revocation of a certificate of 13 14 authority, of any corporation using a name that is not distinguishable 15 from the name of the applicant for dissolution. The application must 16 state the precise legal name of the governmental entity and its date of 17 formation and the applicant shall mail a copy to the corporation's the name of 18 registered agent.
