In addition to the amounts appropriated in this act for revenues for distribution, state contributions to the 6 7 law enforcement officers' and fire fighters' retirement system, and 8 bond retirement and interest including ongoing bond registration and 9 transfer charges, transfers, interest on registered warrants, and certificates of indebtedness, there is also appropriated such further 10 amounts as may be required or available for these purposes under any 11 12 statutory formula or under chapters 39.94 and 39.96 RCW or any proper 13 bond covenant made under law.

- 14 **Sec. 902.** RCW 28D.02.065 and 1997 c 180 s 1 are each amended to 15 read as follows:
- 16 (1) The education technology revolving fund is created in the custody of the state treasurer. All receipts from billings under 17 18 subsection (2) of this section must be deposited in the revolving fund. 19 Only the director of the department of information services or the 20 director's designee may authorize expenditures from the fund. The 21 revolving fund shall be used only to pay for the acquisition of 22 equipment, software, supplies, and services, and other costs incidental to the acquisition, development, operation, and administration of 23 shared educational information technology services, telecommunications, 24 25 and systems. The revolving fund shall not be used for the acquisition, 26 maintenance, or operations of local networks or on-premises equipment specific to a particular institution or group of institutions. 27
- (2) The revolving fund and all disbursements from the revolving 28 29 fund are subject to the allotment procedure under chapter 43.88 RCW, but an appropriation is not required for expenditures. The department 30 31 of information services shall, in consultation with entities connected to the network under RCW 28D.02.070 and subject to the review and 32 33 approval of the office (([of])) of financial management, establish and implement a billing structure to assure that all network users pay an 34 35 equitable share of the costs in relation to their usage of the network.

(3) For the 1997-99 biennium, the education technology revolving 1 fund may be used for the allowable purposes set forth in subsection (1) 2 3 of this section and for network operations, transport, maintenance, and 4 depreciation of on-site data and shared infrastructure. During the 1997-99 biennium, the fund shall not be used for local 5 telecommunications infrastructure or the maintenance and depreciation 6 7 of local network services or other uses prohibited in subsection (1) of 8 this section. All federal moneys received for these services established by 47 U.S.C. Sec. 245(h) shall be deposited in this account 9 10 to be used for eliqible services as provided by federal law and federal communications commission rules. 11

Sec. 903. RCW 43.88.030 and 1997 c 168 s 5 and 1997 c 96 s 4 are each reenacted and amended to read as follows:

14 (1) The director of financial management shall provide all agencies 15 with a complete set of instructions for submitting biennial budget requests to the director at least three months before agency budget documents are due into the office of financial management. 18 director shall provide agencies that are required under RCW 44.40.070 to develop comprehensive six-year program and financial plans with a complete set of instructions for submitting these program and financial plans at the same time that instructions for submitting other budget requests are provided. The budget document or documents shall consist 22 23 of the governor's budget message which shall be explanatory of the 24 budget and shall contain an outline of the proposed financial policies of the state for the ensuing fiscal period, as well as an outline of the proposed six-year financial policies where applicable, and shall describe in connection therewith the important features of the budget. The message shall set forth the reasons for salient changes from the previous fiscal period in expenditure and revenue items and shall explain any major changes in financial policy. Attached to the budget message shall be such supporting schedules, exhibits and other 31 explanatory material in respect to both current operations and capital 33 improvements as the governor shall deem to be useful to the legislature. The budget document or documents shall set forth a 34 proposal for expenditures in the ensuing fiscal period, or six-year 35 period where applicable, based upon the estimated revenues and 37 caseloads as approved by the economic and revenue forecast council and 38 caseload forecast council or upon the estimated revenues and caseloads

of the office of financial management for those funds, accounts, 1 sources, and programs for which the forecast councils do not prepare an 2 3 official forecast, including those revenues anticipated to support the 4 six-year programs and financial plans under RCW 44.40.070. estimating revenues to support financial plans under RCW 44.40.070, the 5 office of financial management shall rely on information and advice 6 7 from the interagency revenue task force. Revenues shall be estimated 8 for such fiscal period from the source and at the rates existing by law 9 at the time of submission of the budget document, including the supplemental budgets submitted in the even-numbered years of a 10 biennium. However, the estimated revenues and caseloads for use in the 11 governor's budget document may be adjusted to reflect budgetary revenue 12 transfers and revenue and caseload estimates dependent upon budgetary 13 14 assumptions of enrollments, workloads, and caseloads. All adjustments 15 to the approved estimated revenues and caseloads must be set forth in the budget document. The governor may additionally submit, as an 16 appendix to each supplemental, biennial, or six-year agency budget or 17 to the budget document or documents, a proposal for expenditures in the 18 19 ensuing fiscal period from revenue sources derived from proposed changes in existing statutes. 20

Supplemental and biennial documents shall reflect a six-year expenditure plan consistent with estimated revenues from existing sources and at existing rates for those agencies required to submit six-year program and financial plans under RCW 44.40.070. Any additional revenue resulting from proposed changes to existing statutes shall be separately identified within the document as well as related expenditures for the six-year period.

- (f) A delineation of each agency's activities, including those 6 7 activities funded from nonbudgeted, nonappropriated sources, including 8 funds maintained outside the state treasury;
- 9 (g) Identification of all proposed direct expenditures to implement 10 the Puget Sound water quality plan under chapter 90.71 RCW, shown by agency and in total; and 11
- 12 (h) Tabulations showing each postretirement adjustment by 13 retirement system established after fiscal year 1991, to include, but not be limited to, estimated total payments made to the end of the 14 15 previous biennial period, estimated payments for the present biennium, and estimated payments for the ensuing biennium. 16
- 17 (2) The budget document or documents shall include detailed estimates of all anticipated revenues applicable to proposed operating 18 19 or capital expenditures and shall also include all proposed operating 20 or capital expenditures. The total of beginning undesignated fund balance and estimated revenues less working capital and other reserves 21 shall equal or exceed the total of proposed applicable expenditures. 22

- (c) A capital plan consisting of proposed capital spending for at least four biennia succeeding the next biennium;
- (d) A strategic plan for reducing backlogs of maintenance and repair projects. The plan shall include a prioritized list of specific facility deficiencies and capital projects to address the deficiencies for each agency, cost estimates for each project, a schedule for completing projects over a reasonable period of time, and identification of normal maintenance activities to reduce future backlogs;
 - (e) A statement of the reason or purpose for a project;
- (f) Verification that a project is consistent with the provisions set forth in chapter 36.70A RCW;

- 31 For purposes of this subsection (3), the term "capital project" the 32 defined subsequent to analysis, findings, 33 recommendations of a joint committee comprised of representatives from 34 the house capital appropriations committee, senate ways and means 35 committee, legislative transportation committee, legislative evaluation and accountability program committee, and office of financial 36 37 management.
- 38 (4) No change affecting the comparability of agency or program 39 information relating to expenditures, revenues, workload, performance

- and personnel shall be made in the format of any budget document or 1 report presented to the legislature under this section or RCW 2 43.88.160(1) relative to the format of the budget document or report 3 which was presented to the previous regular session of the legislature 4 during an odd-numbered year without prior legislative concurrence. 5 Prior legislative concurrence shall consist of (a) a favorable majority 6 vote on the proposal by the standing committees on ways and means of 8 both houses if the legislature is in session or (b) a favorable majority vote on the proposal by members of the legislative evaluation 9 10 and accountability program committee if the legislature is not in 11 session.
- NEW SECTION. Sec. 904. This act shall not be construed as affecting any right or cause of action asserted in Washington State Legislature v. State of Washington (Thurston county superior court cause no. 98-2-00105-1).
- Sec. 905. If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.
- Sec. 906. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
