1            AN ACT Relating to special parking privileges for disabled persons;  
2 amending RCW 46.16.381 and 46.61.581; reenacting and amending RCW  
3 46.63.020; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            **Sec. 1.** RCW 46.16.381 and 1995 c 384 s 1 are each amended to read  
6 as follows:

7            (1) The director shall grant special parking privileges to any  
8 person who has a disability that limits or impairs the ability to walk  
9 and meets one of the following criteria, as determined by a licensed  
10 physician:

11            (a) Cannot walk two hundred feet without stopping to rest;

12            (b) Is severely limited in ability to walk due to arthritic,  
13 neurological, or orthopedic condition;

14            (c) Is so severely disabled, that the person cannot walk without  
15 the use of or assistance from a brace, cane, another person, prosthetic  
16 device, wheelchair, or other assistive device;

17            (d) Uses portable oxygen;

18            (e) Is restricted by lung disease to such an extent that forced  
19 expiratory respiratory volume, when measured by spirometry is less than

1 one liter per second or the arterial oxygen tension is less than sixty  
2 mm/hg on room air at rest;

3 (f) Impairment by cardiovascular disease or cardiac condition to  
4 the extent that the person's functional limitations are classified as  
5 class III or IV under standards accepted by the American Heart  
6 Association; or

7 (g) Has a disability resulting from an acute sensitivity to  
8 automobile emissions which limits or impairs the ability to walk. The  
9 personal physician of the applicant shall document that the disability  
10 is comparable in severity to the others listed in this subsection.

11 (2) The applications for disabled parking permits and temporary  
12 disabled parking permits are official state documents. Knowingly  
13 providing false information in conjunction with the application is a  
14 gross misdemeanor punishable under chapter 9A.20 RCW. The following  
15 statement must appear on each application form immediately below the  
16 physician's signature and immediately below the applicant's signature:  
17 "A disabled parking permit may be issued only for a medical necessity  
18 that severely affects mobility (RCW 46.16.381). Knowingly providing  
19 false information on this application is a gross misdemeanor. The  
20 penalty is up to one year in jail and a fine of up to \$5,000 or both."

21 (3) Persons who qualify for special parking privileges are entitled  
22 to receive from the department of licensing a removable windshield  
23 placard bearing the international symbol of access and an individual  
24 serial number, along with a special identification card bearing the  
25 photograph, name, and date of birth of the person to whom the placard  
26 is issued, and the placard's serial number. The department shall  
27 design the placard to be displayed when the vehicle is parked by  
28 suspending it from the rearview mirror, or in the absence of a rearview  
29 mirror the card may be displayed on the dashboard of any vehicle used  
30 to transport the disabled person. Instead of regular motor vehicle  
31 license plates, disabled persons are entitled to receive special  
32 license plates bearing the international symbol of access for one  
33 vehicle registered in the disabled person's name. Disabled persons who  
34 are not issued the special license plates are entitled to receive a  
35 second special placard upon submitting a written request to the  
36 department. Persons who have been issued the parking privileges and  
37 who are using a vehicle or are riding in a vehicle displaying the  
38 special license plates or placard may park in places reserved for  
39 mobility disabled persons. The director shall adopt rules providing

1 for the issuance of special placards and license plates to public  
2 transportation authorities, nursing homes licensed under chapter 18.51  
3 RCW, boarding homes licensed under chapter 18.20 RCW, senior citizen  
4 centers, private nonprofit agencies as defined in chapter 24.03 RCW,  
5 and vehicles registered with the department as cabulances that  
6 regularly transport disabled persons who have been determined eligible  
7 for special parking privileges provided under this section. The  
8 director may issue special license plates for a vehicle registered in  
9 the name of the public transportation authority, nursing home, boarding  
10 homes, senior citizen center, private nonprofit agency, or cabulance  
11 service if the vehicle is primarily used to transport persons with  
12 disabilities described in this section. Public transportation  
13 authorities, nursing homes, boarding homes, senior citizen centers,  
14 private nonprofit agencies, and cabulance services are responsible for  
15 insuring that the special placards and license plates are not used  
16 improperly and are responsible for all fines and penalties for improper  
17 use.

18 ~~((+3))~~ (4) Whenever the disabled person transfers or assigns his  
19 or her interest in the vehicle, the special license plates shall be  
20 removed from the motor vehicle. If another vehicle is acquired by the  
21 disabled person and the vehicle owner qualifies for a special plate,  
22 the plate shall be attached to the vehicle, and the director shall be  
23 immediately notified of the transfer of the plate. If another vehicle  
24 is not acquired by the disabled person, the removed plate shall be  
25 immediately surrendered to the director.

26 ~~((+4))~~ (5) The special license plate shall be renewed in the same  
27 manner and at the time required for the renewal of regular motor  
28 vehicle license plates under this chapter. No special license plate  
29 may be issued to a person who is temporarily disabled. A person who  
30 has a condition expected to improve within six months may be issued a  
31 temporary placard for a period not to exceed six months. ~~((The  
32 director may issue a second temporary placard during that period if  
33 requested by the person who is temporarily disabled.))~~ If the  
34 condition exists after six months a new temporary placard shall be  
35 issued upon receipt of a new certification from the disabled person's  
36 physician. The permanent parking placard and photo identification card  
37 of a disabled person shall be renewed~~((, when))~~ at least every five  
38 years, as required by the director, by satisfactory proof of the right  
39 to continued use of the privileges. In the event of the permit

1 holder's death, the parking placard and photo identification card must  
2 be immediately surrendered to the department. The department shall  
3 match and purge its disabled permit data base with available death  
4 record information at least every twelve months.

5 ~~((+5))~~ (6) Each person who has been issued a permanent disabled  
6 parking permit on or before July 1, 1998, must renew the permit no  
7 later than July 1, 2003, subject to a schedule to be set by the  
8 department, or the permit will expire.

9 (7) Additional fees shall not be charged for the issuance of the  
10 special placards or the photo identification cards. No additional fee  
11 may be charged for the issuance of the special license plates except  
12 the regular motor vehicle registration fee and any other fees and taxes  
13 required to be paid upon registration of a motor vehicle.

14 ~~((+6))~~ (8) Any unauthorized use of the special placard (~~or the~~),  
15 special license plate, or photo identification card is a  
16 (~~misdemeanor~~) traffic infraction with a monetary penalty of two  
17 hundred fifty dollars.

18 ~~((+7))~~ (9) It is a parking infraction, with a monetary penalty of  
19 one hundred seventy-five dollars for any person to park a vehicle in a  
20 parking place provided on private property without charge or on public  
21 property reserved for physically disabled persons without a special  
22 license plate or placard. It is a parking infraction, with a monetary  
23 penalty of one hundred seventy-five dollars for a person to make  
24 inaccessible the access aisle located next to a space reserved for  
25 physically disabled persons. The clerk of the court shall report all  
26 violations related to this subsection to the department. If a person  
27 is charged with a violation, the person shall not be determined to have  
28 committed an infraction if the person produces in court or before the  
29 court appearance the special license plate or placard required under  
30 this section. A local jurisdiction providing nonmetered, on-street  
31 parking places reserved for physically disabled persons may impose by  
32 ordinance time restrictions of no less than four hours on the use of  
33 these parking places. A local jurisdiction may impose by ordinance  
34 time restrictions of no less than four hours on the use of nonreserved,  
35 on-street parking spaces by vehicles displaying the special parking  
36 placards. All time restrictions must be clearly posted.

37 ~~((+8))~~ (10) The penalty imposed under subsection (~~((+7))~~) (9) of  
38 this section shall be used by that local jurisdiction exclusively for  
39 law enforcement. The court may also impose an additional penalty

1 sufficient to reimburse the local jurisdiction for any costs it may  
2 have incurred in removal and storage of the improperly parked vehicle.

3 ~~((+9))~~ (11) Except as provided by subsection (2) of this section,  
4 it is a ~~((misdemeanor))~~ traffic infraction with a monetary penalty of  
5 two hundred fifty dollars for any person ~~((to))~~ willfully to obtain a  
6 special license plate ~~((or))~~, placard, or photo identification card in  
7 a manner other than that established under this section.

8 (12)(a) A law enforcement agency authorized to enforce parking laws  
9 may appoint volunteers to issue notices of infractions for violations  
10 of this section or RCW 46.61.581. Volunteers must be at least twenty-  
11 one years of age. The law enforcement agency appointing volunteers may  
12 establish any other qualifications the agency deems desirable.

13 (b) An agency appointing volunteers under this section must provide  
14 training to the volunteers before authorizing them to issue notices of  
15 infractions.

16 (c) A notice of infraction issued by a volunteer appointed under  
17 this subsection has the same force and effect as a notice of infraction  
18 issued by a police officer for the same offense.

19 (d) A police officer or a volunteer may request a person to show  
20 the person's photo identification card or special parking placard when  
21 investigating the possibility of a violation of this section. If the  
22 request is refused, the person in charge of the vehicle may be issued  
23 a notice of infraction for a violation of this section.

24 (e) A police officer or a volunteer may confiscate the special  
25 parking placard and photo identification card from a person who  
26 fraudulently obtains or uses the placard or photo identification card.

27 (13) For second or subsequent violations of this section, in  
28 addition to a monetary fine, the violator must complete a minimum of  
29 forty hours of:

30 (a) Community service for a nonprofit organization that serves the  
31 disabled community or persons having disabling diseases; or

32 (b) Any other community service that may sensitize the violator to  
33 the needs and obstacles faced by persons who have disabilities.

34 **Sec. 2.** RCW 46.61.581 and 1988 c 74 s 1 are each amended to read  
35 as follows:

36 A parking space or stall for a disabled person shall be indicated  
37 by a vertical sign, between thirty-six and eighty-four inches off the  
38 ground, with the international symbol of access, whose colors are white

1 on a blue background, described under RCW 70.92.120 and the notice  
2 "State disabled parking permit required."

3 Failure of the person owning or controlling the property where  
4 required parking spaces are located to erect and maintain the sign is  
5 a class ((4)) 2 civil infraction under chapter 7.80 RCW for each  
6 parking space that should be so designated. The person owning or  
7 controlling the property where the required parking spaces are located  
8 shall ensure that the parking spaces are not blocked or made  
9 inaccessible, and failure to do so is a class 2 civil infraction.

10 **Sec. 3.** RCW 46.63.020 and 1997 c 229 s 13 and 1997 c 66 s 8 are  
11 each reenacted and amended to read as follows:

12 Failure to perform any act required or the performance of any act  
13 prohibited by this title or an equivalent administrative regulation or  
14 local law, ordinance, regulation, or resolution relating to traffic  
15 including parking, standing, stopping, and pedestrian offenses, is  
16 designated as a traffic infraction and may not be classified as a  
17 criminal offense, except for an offense contained in the following  
18 provisions of this title or a violation of an equivalent administrative  
19 regulation or local law, ordinance, regulation, or resolution:

20 (1) RCW 46.09.120(2) relating to the operation of a nonhighway  
21 vehicle while under the influence of intoxicating liquor or a  
22 controlled substance;

23 (2) RCW 46.09.130 relating to operation of nonhighway vehicles;

24 (3) RCW 46.10.090(2) relating to the operation of a snowmobile  
25 while under the influence of intoxicating liquor or narcotics or  
26 habit-forming drugs or in a manner endangering the person of another;

27 (4) RCW 46.10.130 relating to the operation of snowmobiles;

28 (5) Chapter 46.12 RCW relating to certificates of ownership and  
29 registration and markings indicating that a vehicle has been destroyed  
30 or declared a total loss;

31 (6) RCW 46.16.010 relating to initial registration of motor  
32 vehicles;

33 (7) RCW 46.16.011 relating to permitting unauthorized persons to  
34 drive;

35 (8) RCW 46.16.160 relating to vehicle trip permits;

36 (9) RCW 46.16.381 (~~((6) or (9))~~) (2) relating to (~~(unauthorized use~~  
37 ~~or acquisition of)~~) knowingly providing false information in

1 conjunction with an application for a special placard or license plate  
2 for disabled persons' parking;

3 (10) RCW 46.20.005 relating to driving without a valid driver's  
4 license;

5 (11) RCW 46.20.091 relating to false statements regarding a  
6 driver's license or instruction permit;

7 (12) RCW 46.20.336 relating to the unlawful possession and use of  
8 a driver's license;

9 (13) RCW 46.20.342 relating to driving with a suspended or revoked  
10 license or status;

11 (14) RCW 46.20.410 relating to the violation of restrictions of an  
12 occupational driver's license;

13 (15) RCW 46.20.420 relating to the operation of a motor vehicle  
14 with a suspended or revoked license;

15 (16) RCW 46.20.740 relating to operation of a motor vehicle without  
16 an ignition interlock device in violation of a license notation that  
17 the device is required;

18 (17) RCW 46.20.750 relating to assisting another person to start a  
19 vehicle equipped with an ignition interlock device;

20 (18) RCW 46.25.170 relating to commercial driver's licenses;

21 (19) Chapter 46.29 RCW relating to financial responsibility;

22 (20) RCW 46.30.040 relating to providing false evidence of  
23 financial responsibility;

24 (21) RCW 46.37.435 relating to wrongful installation of  
25 sunscreening material;

26 (22) RCW 46.44.180 relating to operation of mobile home pilot  
27 vehicles;

28 (23) RCW 46.48.175 relating to the transportation of dangerous  
29 articles;

30 (24) RCW 46.52.010 relating to duty on striking an unattended car  
31 or other property;

32 (25) RCW 46.52.020 relating to duty in case of injury to or death
