AN ACT Relating to security of drivers' licenses; amending RCW 46.20.091, 46.20.117, 46.20.161, and 46.20.181; reenacting and amending RCW 46.63.020; adding a new section to chapter 46.04 RCW; adding new sections to chapter 46.20 RCW; adding a new section to chapter 42.17 RCW; creating a new section; prescribing penalties; and providing an effective date.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

The legislature finds that while the 8 NEW SECTION. Sec. 1. 9 driver's license was designed to be a declaration of the privilege to operate a motor vehicle, drivers' licenses and identicards issued by 10 the department of licensing have become the most widely accepted forms 11 12 of personal identification used by Washington residents. There is an 13 increasing use of false drivers' licenses and identicards to purchase 14 liquor, to cash bad checks, and to obtain food stamps and other 15 benefits, often at the expense of law-abiding residents. In recognition of these losses that are borne by taxpayers, businesses, 16 17 and government, Congress has recently directed the states to produce counterfeit-resistant drivers' licenses. It is the purpose of this act 18 19 to require effective means of rendering drivers' licenses and

identicards as immune as possible from alteration and counterfeiting in
 order to promote the public health and safety of the people of this
 state.

4 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 46.04 RCW 5 to read as follows:

6 "Biometrics" means physical attributes that are unique to 7 individual persons. Biometrics includes but is not limited to finger 8 images, iris/retinal scans, vein patterns, facial images, and 9 hand/finger geometry.

10 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 46.20 RCW 11 to read as follows:

By July 1, 1999, the department shall enter into a contract for the procurement of a new state driver's license and identicard. The contract may incorporate the following features subject to the listed restrictions:

(1) A digital imaging system. A digital imaging system permits a 16 17 person's photograph and signature to be stored and displayed by 18 computer, which allows for improved file management, flexibility, responsiveness, and fraud protection. The digital photograph shall not 19 20 incorporate facial recognition technology that would allow a one-to-21 many search. A one-to-many search compares the photograph to all of 22 the other photographs to determine if there is a match. However, the 23 department may compare the photograph against the individual applying 24 for a license, license renewal, or identicard.

(2) Machine-readable technologies, including a one-dimensional bar
 code, two-dimensional bar code, and a magnetic stripe. Through
 encryption, both the magnetic stripe and two-dimensional bar code offer
 additional levels of security against alteration and counterfeiting.

29 (a) Information included on a driver's license in machine-readable form may be accessed by the director, the chief of the Washington state 30 patrol, commissioned law enforcement officers, district courts, 31 municipal courts, superior courts, city and county prosecuting 32 33 attorneys, and such other public officials as may be designated by law. (b) Except as authorized by this section, a person accessing 34 35 information encrypted in machine-readable form on a driver's license is 36 guilty of a gross misdemeanor.

1 sec. 4. RCW 46.20.091 and 1996 c 287 s 5 are each amended to read
2 as follows:

3 (1) Every application for an instruction permit or for an original 4 driver's license shall be made upon a form prescribed and furnished by 5 the department which shall be sworn to and signed by the applicant before a person authorized to administer oaths. An applicant making a 6 7 false statement under this subsection is guilty of false swearing, a gross misdemeanor, under RCW 9A.72.040. Every application for an 8 9 instruction permit containing a photograph shall be accompanied by a 10 fee of five dollars. The department shall forthwith transmit the fees 11 collected for instruction permits and temporary drivers' permits to the 12 state treasurer.

(2) Every such application shall state the full name, date of 13 birth, sex, and Washington residence address of the applicant, and 14 15 briefly describe the applicant, and shall state whether the applicant has theretofore been licensed as a driver or chauffeur, and, if so, 16 17 when and by what state or country, and whether any such license has ever been suspended or revoked, or whether an application has ever been 18 19 refused, and, if so, the date of and reason for such suspension, 20 revocation, or refusal, and shall state such additional information as the department shall require, including a statement that identifying 21 22 documentation presented by the applicant is valid. Except for 23 submitting a digital photograph as authorized by section 3 of this act, 24 the department shall not require an applicant to submit biometrics as 25 part of an application under this section.

(3) Whenever application is received from a person previously licensed in another jurisdiction, the department shall request a copy of such driver's record from such other jurisdiction. When received, the driving record shall become a part of the driver's record in this state.

(4) Whenever the department receives request for a driving record from another licensing jurisdiction, the record shall be forwarded without charge if the other licensing jurisdiction extends the same privilege to the state of Washington. Otherwise there shall be a reasonable charge for transmittal of the record, the amount to be fixed by the director of the department.

37 **Sec. 5.** RCW 46.20.117 and 1993 c 452 s 3 are each amended to read 38 as follows:

(1) The department shall issue "identicards," containing a picture, 1 to nondrivers for a fee of ((four)) six dollars. However, the fee 2 3 shall be the actual cost of production to recipients of continuing 4 public assistance grants under Title 74 RCW who are referred in writing to the department by the secretary of social and health services. The 5 fee shall be deposited in the highway safety fund. To be eligible, 6 7 each applicant shall produce evidence as required in RCW 46.20.035 that 8 positively proves identity. The "identicard" shall be distinctly 9 designed so that it will not be confused with the official driver's 10 license. The identicard shall expire on the fifth anniversary of the applicant's birthdate after issuance. 11

12 (2) The department may cancel an "identicard" upon a showing by its 13 records or other evidence that the holder of such "identicard" has 14 committed a violation relating to "identicards" defined in RCW 15 46.20.336.

16 **Sec. 6.** RCW 46.20.161 and 1990 c 250 s 40 are each amended to read 17 as follows:

18 (1) The department, upon receipt of a fee of ((fourteen)) twenty 19 dollars, which includes the fee for the required photograph, shall issue to every applicant qualifying therefor a driver's license, which 20 21 license shall bear thereon a distinguishing number assigned to the licensee, the full name, date of birth, Washington residence address, 22 23 and a brief description of the licensee, and either a facsimile of the 24 signature of the licensee or a space upon which the licensee shall 25 write his usual signature with pen and ink immediately upon receipt of 26 the license. No license is valid until it has been so signed by the 27 licensee.

(2) As authorized by section 3 of this act, the department may also include the information specified by subsection (1) of this section on a driver's license in machine-readable form. Any information included on a driver's license in a form that can only be read by machine must be encrypted.

33 **Sec. 7.** RCW 46.20.181 and 1990 c 250 s 41 are each amended to read 34 as follows:

Every driver's license expires on the fourth anniversary of the licensee's birthdate following the issuance of the license. Every such license is renewable on or before its expiration upon application prescribed by the department and the payment of a fee of ((fourteen))
twenty dollars. This fee includes the fee for the required photograph.

3 <u>NEW SECTION.</u> Sec. 8. A new section is added to chapter 46.20 RCW 4 to read as follows:

Beginning October 1, 2000, the federal Illegal Immigration Control 5 Act, P.L. 104-208, requires states to either place drivers' social 6 7 security numbers on the face of their licenses, or to complete a social security verification process. The legislature finds that requiring 8 9 the placement of social security numbers on drivers' licenses means that whenever someone shows his or her driver's license, the person 10 will also be exposing his or her social security number. With the 11 12 social security number accessible to so many people, it will be relatively easy for someone to fraudulently use another's social 13 14 security number to assume that person's identity and gain access to 15 bank accounts, credit services, billing information, driving history, and other sources of personal information. The new federal law will 16 compound and exacerbate the disturbing trend of social security number-17 18 related fraud. In order to prevent fraud and curtail invasions of 19 privacy, the governor, through the department of licensing, shall seek a waiver to the federal mandate. If a waiver is not granted, the 20 21 department shall rely only upon the verification process prescribed in 22 the federal law. In no event may the social security number be placed 23 on the driver's license or identicard.

5 <u>NEW SECTION.</u> Sec. 11. Sections 5 through 7 of this act take 6 effect July 1, 1999.
