SENATE BILL 6546

- 1 AN ACT Relating to school nurses; adding a new section to chapter
- 2 28A.210 RCW; creating new sections; and providing an expiration date.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that schools are being 5 asked to play an increasingly expanding role in protecting our
- 6 children's health. Schools are responsible for monitoring the
- 7 immunization of children, evaluating children's hearing and vision, and
- 8 screening for scoliosis. Chronically ill children often require
- 9 medically ordered treatment to enable them to attend school.
- 10 Prescription medication is often required to be given to children
- 11 during the school day. Schools are also responsible for identifying
- 12 and reporting child abuse, identifying drug and alcohol problems,
- 13 treating emergencies, providing counseling and assistance for teenage
- 14 parents, and providing AIDS education. The legislature finds that
- 15 expertise is needed in our schools to protect the health of students in
- 16 our schools and to help students learn.
- 17 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.210
- 18 RCW to read as follows:

p. 1 SB 6546

- (1) Beginning with the 1999-2000 school year, each school district 1 shall maintain a ratio of not less than one school nurse for every one 2 thousand five hundred full-time equivalent students. In the 2000-2001 3 4 school year, each school district shall maintain a ratio of not less 5 than one school nurse for every one thousand full-time equivalent In the 2001-2002 school year, each school district shall 6 7 maintain a ratio of not less than one school nurse for every seven 8 hundred fifty full-time equivalent students.
- 9 (2) The state board of education shall adopt rules providing for 10 the initial and continuing certification for certified school nurses. 11 Application shall be made within one year after the effective date of 12 this section.
- 13 (3) A second class school district may continue to hire persons who 14 meet the requirements of RCW 28A.210.300.
- 15 (4) As used in this section, "school nurse" means a person who 16 satisfies the following requirements:
- 17 (a)(i) The candidate holds a bachelor of science degree in nursing, 18 including training in public health nursing;
- 19 (ii) The candidate holds a valid license as a registered nurse (RN) 20 in Washington state;
- (iii) The candidate is certified as an educational staff associate pursuant to requirements established by the office of the superintendent of public instruction;
- (iv) The candidate has successfully completed additional postgraduate work including, but not limited to, school health, crisis intervention, health counseling, child development, health curriculum, and drug and alcohol abuse curriculum; and
- (v) The candidate has professional nursing experience in school settings for the equivalent of three school years within the six years immediately preceding the effective date of this section; or
- 31 (b) The candidate qualifies under subsection (3) of this section.
- NEW SECTION. Sec. 3. By December 31, 2001, the superintendent of public instruction shall submit a report to the legislature on the implementation of section 2 of this act and the impact of the services provided. The report shall include recommendations about whether funding for school nurses should be an ongoing responsibility of the state and part of basic education.
