1 AN ACT Relating to exempting the sale and use of motion picture or 2 video production equipment and supplies from sales and use tax; and 3 amending RCW 82.08.0315 and 82.12.0315.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 82.08.0315 and 1997 c 61 s 1 are each amended to read 6 as follows:

7 (1) As

(1) As used in this section:

8 (a) "Production equipment and supplies" means ((the following when 9 used in motion picture or video production or postproduction:)) all 10 items necessary and essential to the production of motion picture or video production or postproduction and used solely in such activities, 11 including but not limited to grip and lighting equipment, cameras, film 12 and other production supplies, camera mounts including tripods, jib 13 14 arms, steadicams, and other camera mounts, cranes, dollies, generators, 15 helicopter mounts, helicopters rented for motion picture or video 16 production, walkie talkies and other communication equipment, vans, 17 trucks, and other vehicles specifically equipped for motion picture or video production or used solely for production activities, wardrobe and 18 19 makeup trailers, special effects and stunt equipment, video assists,

1 videotape recorders, cables and connectors, ((telepromoters
2 [teleprompters])) teleprompters, sound recording equipment, ((and))
3 editorial equipment, and items used for wardrobe, hair, and makeup
4 design and stage and set construction and decoration.

5 (b) "Production services" means motion picture and video 6 processing, printing, editing, duplicating, animation, graphics, 7 special effects, negative cutting, conversions to other formats or 8 media, stock footage, sound mixing, rerecording, sound sweetening, 9 sound looping, sound effects, and automatic dialog replacement.

10 (c) "Motion picture or video production business" means a person 11 engaged in the production of motion pictures and video tapes for 12 exhibition, sale, or for broadcast by a person other than the person 13 producing the motion picture or video tape.

(2) The tax levied by RCW 82.08.020 does not apply to <u>the sale of</u>
 <u>or</u> the rental of production equipment <u>and supplies</u>, or the sale of
 production services, to a motion picture or video production business.

17 (3) The exemption provided for in this section shall not apply to 18 rental of production equipment <u>and supplies</u>, or the sale of production 19 services, to a motion picture or video production business that is 20 engaged, to any degree, in the production of erotic material, as 21 defined in RCW 9.68.050.

(4) In order to claim an exemption under this section, the purchaser must provide the seller with an exemption certificate in a form and manner prescribed by the department. The seller shall retain a copy of the certificate for the seller's files.

26 Sec. 2. RCW 82.12.0315 and 1995 2nd sp.s. c 5 s 2 are each amended 27 to read as follows:

(1) The provisions of this chapter shall not apply in respect tothe use of:

30 (a) Production equipment <u>and supplies purchased by or</u> rented to a
 31 motion picture or video production business;

32 (b) Production equipment <u>and supplies</u> acquired and used by a motion 33 picture or video production business in another state, if the 34 acquisition and use occurred more than ninety days before the time the 35 motion picture or video production business entered this state.

36 (2) As used in this section, "production equipment <u>and supplies</u>"
 37 and "motion picture or video production business" have the meanings
 38 given in RCW 82.08.0315.

1 (3) The exemption provided for in this section shall not apply to 2 the use of production equipment <u>and supplies purchased by or</u> rented to, 3 or production equipment <u>and supplies</u> acquired and used by, a motion 4 picture or video production business that is engaged, to any degree, in 5 the production of erotic material, as defined in RCW 9.68.050.
