- 2 STATES, AND TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE
- 3 OF REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF
- 4 THE UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, The Bonneville Power Administration was initially created
- 9 to provide low-cost power to rural areas, a tradition that it maintains
- 10 today; and
- 11 WHEREAS, The Pacific Northwest enjoys low electricity rates, thanks
- 12 largely to the Bonneville Power Administration; and
- 13 WHEREAS, Those rates would be seriously jeopardized by the sale of
- 14 the Bonneville Power Administration; and
- 15 WHEREAS, The sale of the Bonneville Power Administration would
- 16 threaten the long-standing relationship the Bonneville Power
- 17 Administration has established with the Northwest's public utility
- 18 districts and rural electric associations; and
- 19 WHEREAS, The Bonneville Power Administration currently contributes
- 20 a portion of its revenue to salmon restoration, and there is no

- 1 guarantee those funds would be available if the Bonneville Power
- 2 Administration is sold;
- NOW, THEREFORE, Your Memorialists respectfully pray that the
- 4 President and Congress agree not to sell the Bonneville Power
- 5 Administration and rather to allow it to continue fulfilling its
- 6 mission of providing low-cost power to the Pacific Northwest.
- 7 BE IT RESOLVED, That copies of this Memorial be immediately
- 8 transmitted to the Honorable William J. Clinton, President of the
- 9 United States, the President of the United States Senate, the Speaker
- 10 of the House of Representatives, and each member of Congress from the
- 11 State of Washington.
