5 Strike everything after the enacting clause and insert the
6 following:

7 "NEW SECTION. **Sec. 1.** A new section is added to chapter 28B.15
8 RCW to read as follows:

9 In addition to waivers granted under the authority of RCW
10 28B.15.910, the governing boards of the state universities, the
11 regional universities, The Evergreen State College, and the community
12 colleges, subject to state board policy, may waive all or a portion of
13 the operating fees for any student. There shall be no state general
14 fund support for waivers granted under this section.

15 By January 31st of each odd-numbered year, the institutions of
16 higher education shall prepare a report of the costs and benefits of
17 waivers granted under this act and shall transmit copies of their
18 report to the appropriate policy and fiscal committees of the
19 legislature.

20 **Sec. 2.** RCW 28B.15.066 and 1999 c 309 s 932 are each amended to
21 read as follows:

22 It is the intent of the legislature that:

23 In making appropriations from the state's general fund to
24 institutions of higher education, each appropriation shall conform to
25 the following:

26 (1) The appropriation shall not be reduced by the amount of
27 operating fees revenue estimated to be collected from students enrolled
28 at the state-funded enrollment level specified in the omnibus biennial
29 operating appropriations act;

30 (2) The appropriation shall not be reduced by the amount of
31 operating fees revenue collected from students enrolled above the
32 state-funded level, but within the over-enrollment limitations,
33 specified in the omnibus biennial operating appropriations act; and

34 (3) The general fund state appropriation shall not be reduced by
35 the amount of operating fees revenue collected as a result of waiving

1 less operating fees revenue than the amounts authorized under RCW
2 28B.15.910. State general fund appropriations shall not be provided
3 for revenue foregone as a result of or for waivers granted under
4 (~~section 601(3)(e), chapter 309, Laws of 1999~~) section 1 of this act.

5 **Sec. 3.** RCW 28B.15.910 and 1999 c 344 s 3 are each amended to read
6 as follows:

7 (1) For the purpose of providing state general fund support to
8 public institutions of higher education, except for revenue waived
9 under programs listed in subsections (3) and (4) of this section, and
10 unless otherwise expressly provided in the omnibus state appropriations
11 act, the total amount of operating fees revenue waived, exempted, or
12 reduced by a state university, a regional university, The Evergreen
13 State College, or the community colleges as a whole, shall not exceed
14 the percentage of total gross authorized operating fees revenue in this
15 subsection. As used in this section, "gross authorized operating fees
16 revenue" means the estimated gross operating fees revenue as estimated
17 under RCW 82.33.020 or as revised by the office of financial
18 management, before granting any waivers. This limitation applies to
19 all tuition waiver programs established before or after July 1, 1992.

- 23 (4) The total amount of operating fees revenue waived, exempted, or
24 reduced by institutions of higher education participating in the
25 western interstate commission for higher education western
26 undergraduate exchange program under RCW 28B.15.544 shall not exceed
27 the percentage of total gross authorized operating fees revenue in this
28 subsection.
