EFFECT: Clarifies that the crime of criminal impersonation applies to the use of a "made-up" identity with the intent to commit a felony or third degree theft. It also increases the penalties for Identity Theft and Criminal Impersonation in the First Degree by ranking both crimes as level IV offenses. This means that a person with no prior criminal history would receive a presumptive sentence range of three to nine months confinement. Criminal Impersonation in the Second Degree is raised from a misdemeanor to a gross misemeanor.
