Read first time 01/22/1999. Referred to Committee on Criminal Justice & Corrections.

AN ACT Relating to sentencing for certain criminal acts; amending RCW 81.60.070 and 9.40.120; reenacting and amending RCW 9.94A.320; creating new sections; prescribing penalties; providing an effective date; and declaring an emergency.

3 Every person who, in such manner as might, if not discovered, 4 endanger the safety of any engine, motor, car or train, or any person 5 thereon, shall in any manner interfere or tamper with or obstruct any switch, frog, rail, roadbed, sleeper, viaduct, bridge, trestle, 6 culvert, embankment, structure, or appliance pertaining to or connected 7 with any railway, or any train, engine, motor, or car on such railway, 8 and every person who shall discharge any firearm or throw any dangerous 9 missile at any train, engine, motor, or car on any railway, shall be 10 11 punished by imprisonment in a state correctional facility for not more 12 than ((twenty-five)) ten years.

13 Sec. 3. RCW 9.40.120 and 1971 ex.s. c 302 s 4 are each amended to 14 read as follows:

Every person who possesses, manufactures, or disposes of an incendiary device knowing it to be such is guilty of a felony, and upon conviction, shall be punished by imprisonment in a state prison for a term of not more than ((twenty-five)) ten years.

19 <u>NEW SECTION.</u> Sec. 4. The code reviser shall alphabetize the 20 offenses within each seriousness level in RCW 9.94A.320, including any 21 offenses added in the 1999 legislative session.

22 <u>NEW SECTION.</u> Sec. 5. The amendments made by this act shall apply 23 to offenses committed on or after July 1, 1999.

NEW SECTION. Sec. 6. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect July 1, 1999.
