- 11 for at least thirty-six months.
- 12 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 2.06 RCW
- 13 to read as follows:
- 14 Computers and software acquired by the court of appeals must be
- 15 used for at least thirty-six months.
- 16 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 2.56 RCW
- 17 to read as follows:

- 1 Computers and software acquired by the administrator for the courts
- 2 must be used for at least thirty-six months.
- 3 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 28B.10 RCW
- 4 to read as follows:
- 5 Computers and software acquired by institutions of higher education
- 6 must be used for at least thirty-six months.
- 7 <u>NEW SECTION.</u> **Sec. 5.** A new section is added to chapter 43.01 RCW
- 8 to read as follows:
- 9 Computers and software acquired by each state elected official, and
- 10 the office of those officials, must be used for at least thirty-six
- 11 months.
- 12 <u>NEW SECTION.</u> **Sec. 6.** A new section is added to chapter 43.17 RCW
- 13 to read as follows:
- 14 Computers and software acquired by each department, agency, office,
- 15 division, bureau, board, commission, or other administrative agency of
- 16 the state must be used for at least thirty-six months.
- 17 <u>NEW SECTION.</u> **Sec. 7.** A new section is added to chapter 44.04 RCW
- 18 to read as follows:
- 19 Computers and software acquired by the legislature, and each
- 20 legislative agency, must be used for at least thirty-six months.
