- 1 AN ACT Relating to the endorsement of school sealant endorsed
- 2 dental hygienists; adding new sections to chapter 18.29 RCW; and
- 3 creating a new section.

State of Washington

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that access to
- 6 preventive and restorative oral health services by low-income children
- 7 is currently restricted by complex regulatory, financial, cultural, and
- 8 geographic barriers that have resulted in a large number of children
- 9 suffering unnecessarily from dental disease. The legislature also
- 10 finds that very early exposure to oral health care can reverse this
- 11 disease in many cases, thereby significantly reducing costs of
- 12 providing dental services to low-income populations.
- 13 It is the intent of the legislature to address the problem of poor
- 14 access to oral health care by providing for school-based sealant
- 15 programs through the endorsement of dental hygienists.
- 16 <u>NEW SECTION.</u> **Sec. 2.** A dental hygienist licensed under this
- 17 chapter may apply for endorsement by the department of health as a
- 18 school sealant endorsed dental hygienist upon completion of the

- 1 Washington state sealant guidelines and training as developed or
- 2 approved by the department of health. The secretary of health may
- 3 adopt rules to implement sections 2 through 4 of this act.
- 4 <u>NEW SECTION.</u> **Sec. 3.** (1) For low-income, rural, and other at-risk
- 5 populations and in coordination with local public health jurisdictions
- 6 and local oral health coalitions, dental hygienists who are school
- 7 sealant endorsed under section 2 of this act may assess for and apply
- 8 sealants in public and private school-based, school-linked sealant
- 9 programs.
- 10 (2) A dental hygienist endorsed under section 2 of this act shall
- 11 refer in writing each sealant patient to a dentist for follow-up care.
- 12 <u>NEW SECTION.</u> **Sec. 4.** (1) The school sealant endorsement program
- 13 will accept applications upon the establishment of the endorsement
- 14 course by the secretary, or by July 1, 2001, whichever is sooner. The
- 15 secretary of health may impose a fee for implementation of this section
- 16 and sections 2 and 3 of this act.
- 17 (2) The department of health shall report to the legislature by
- 18 December 1, 2004, on the impact of granting school sealant endorsements
- 19 to dental hygienists to assess for and apply sealants in public and
- 20 private school-based, school-linked sealant programs.
- 21 <u>NEW SECTION</u>. **Sec. 5.** Sections 2 through 4 of this act are each
- 22 added to chapter 18.29 RCW.
