AN ACT Relating to anhydrous ammonia; amending RCW 69.50.440; reenacting and amending RCW 9.94A.320; adding a new chapter to Title 69 RCW; creating a new section; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> **Sec. 1.** (1) A person who, with intent to deprive the 6 owner or owner's agent, wrongfully obtains anhydrous ammonia, is guilty 7 of theft of anhydrous ammonia.

8 (2) Theft of anhydrous ammonia is a class C felony.

9 <u>NEW SECTION.</u> Sec. 2. A person is guilty of the crime of unlawful 10 storage of anhydrous ammonia if the person possesses anhydrous ammonia 11 in a container that (1) is not approved by the United States department 12 of transportation to hold anhydrous ammonia, or (2) was not constructed 13 to meet state and federal industrial health and safety standards for 14 holding anhydrous ammonia. Violation of this section is a class C 15 felony.

16 This section does not apply to public employees or private 17 contractors authorized to clean up and dispose of hazardous waste or 18 toxic substances under chapter 70.105 or 70.105D RCW.

1 <u>NEW SECTION.</u> Sec. 3. Any damages arising out of the unlawful possession of, storage of, or tampering with anhydrous ammonia or 2 anhydrous ammonia equipment shall be the sole responsibility of the 3 4 unlawful possessor, storer, or tamperer. In no case shall liability 5 for damages arising out of the unlawful possession of, storage of, or tampering with anhydrous ammonia or anhydrous ammonia equipment extend 6 7 to the lawful owner, installer, maintainer, designer, manufacturer, 8 possessor, or seller of the anhydrous ammonia or anhydrous ammonia 9 equipment, unless such damages arise out of the owner, installer, 10 maintainer, designer, manufacturer, possessor, or seller's acts or 11 omissions that constitute negligent misconduct to abide by the laws regarding anhydrous ammonia possession and storage. 12

13 **Sec. 4.** RCW 69.50.440 and 1997 c 71 s 3 are each amended to read 14 as follows:

15 It is unlawful for any person to possess ephedrine $((\sigma r))_{L}$ pseudoephedrine, or anhydrous ammonia with intent to manufacture 16 methamphetamine. Any person who violates this section is guilty of a 17 18 crime and may be imprisoned for not more than ten years, fined not more than twenty-five thousand dollars, or both. Three thousand dollars of 19 the fine may not be suspended. As collected, the first three thousand 20 dollars of the fine must be deposited with the law enforcement agency 21 22 having responsibility for cleanup of laboratories, sites, or substances 23 used in the manufacture of the methamphetamine. The fine moneys 24 deposited with that law enforcement agency must be used for such clean-25 up cost.

26 **Sec. 5.** RCW 9.94A.320 and 1999 c 352 s 3, 1999 c 322 s 5, and 1999 27 c 45 s 4 are each reenacted and amended to read as follows:

21 <u>NEW SECTION.</u> Sec. 7. If specific funding for the purposes of this 22 act, referencing this act by bill or chapter number, is not provided by 23 June 30, 2000, in the omnibus appropriations act, this act is null and 24 void.

25 <u>NEW SECTION.</u> **Sec. 8.** If any provision of this act or its 26 application to any person or circumstance is held invalid, the 27 remainder of the act or the application of the provision to other 28 persons or circumstances is not affected.
