AN ACT Relating to small works rosters; amending RCW 39.04.155, 39.04.010, 39.04.200, 28A.335.190, 28B.10.350, 35.22.620, 35.23.352, 36.32.235, 36.32.250, 36.77.075, 52.14.110, 53.08.120, 54.04.070, 57.08.050, and 70.44.140; adding new sections to chapter 39.04 RCW; adding a new section to chapter 35.82 RCW; creating new sections; and repealing RCW 28B.10.355, 35.82.075, and 39.04.150.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 <u>NEW SECTION.</u> Sec. 1. The purpose of this act is to establish a 9 common small works roster procedure that state agencies and local 10 governments may use to award contracts for construction, building, 11 renovation, remodeling, alteration, repair, or improvement of real 12 property.

# PART I - COMMON SMALL WORKS ROSTER PROCEDURE

14 **Sec. 101.** RCW 39.04.155 and 1998 c 278 s 12 are each amended to 15 read as follows:

16 (1) This section provides ((a)) uniform ((process)) small works 17 roster provisions to award contracts for ((public works projects by

those municipalities that are authorized to use a small works roster in 1 lieu of the requirements for formal sealed bidding. The state statutes 2 3 governing a specific type of municipality shall establish the maximum 4 dollar thresholds of the contracts that can be awarded under this process, and may include other matters concerning the small works 5 roster process, for the municipality)) construction, building, б renovation, remodeling, alteration, repair, or improvement of real 7 8 property that may be used by state agencies and by any local government that is expressly authorized to use these provisions. These provisions 9 may be used in lieu of other procedures to award contracts for such 10 work with an estimated cost of two hundred thousand dollars or less. 11

12 (2) ((Such municipalities)) A state agency or authorized local government may create a single general small works roster, or may 13 14 create a small works roster for different <u>specialties or</u> categories of Where applicable, small works rosters may make anticipated work. 15 distinctions between contractors based upon different geographic areas 16 The small works roster or rosters shall 17 served by the contractor. consist of all responsible contractors who have requested to be on the 18 19 list, and where required by law are properly licensed or registered to 20 perform such work in this state. A state agency or local government establishing a small works roster or rosters may require eligible 21 contractors desiring to be placed on a roster or rosters to keep 22 current records of any applicable licenses, certifications, 23 24 registrations, bonding, insurance, or other appropriate matters on file with the state agency or local government as a condition of being 25 placed on a roster or rosters. At least ((twice)) once a year, the 26 ((municipality)) state agency or local government shall publish in a 27 newspaper of general circulation within the jurisdiction a notice of 28 29 the existence of the roster or rosters and solicit the names of 30 contractors for such roster or rosters. In addition, responsible 31 contractors shall be added to an appropriate roster or rosters at any time they submit a written request and necessary records. Master 32 contracts may be required to be signed that become effective when a 33 34 specific award is made using a small works roster.

((The governing body of the municipality shall establish a)) (3) A state agency establishing a small works roster or rosters shall adopt rules implementing this section. A local government establishing a small works roster or rosters shall adopt an ordinance or resolution implementing this section. Procedures included in rules adopted by the

department of general administration in implementing this section must 1 be included in any rules providing for a small works roster or rosters 2 that is adopted by another state agency, if the authority for that 3 4 state agency to engage in these activities has been delegated to it by the department of general administration under chapter 43.19 RCW. An 5 interlocal contract or agreement between two or more state agencies or 6 7 local governments establishing a small works roster or rosters to be 8 used by the parties to the agreement or contract must clearly identify 9 the lead entity that is responsible for implementing the provisions of 10 this section.

(4) Procedures shall be established for securing telephone ((or)), 11 written, or electronic quotations from ((the)) contractors on the 12 13 ((general)) appropriate small works roster((, or a specific small works 14 roster for the appropriate category of work, )) to assure that a 15 competitive price is established and to award contracts to the lowest responsible bidder, as defined in RCW 43.19.1911. ((Such)) Invitations 16 for quotations shall include an estimate of the scope and nature of the 17 work to be performed as well as materials and equipment to be 18 19 furnished. However, detailed plans and specifications need not be included in the invitation. This section does not eliminate other 20 requirements for architectural or engineering approvals as to quality 21 22 and compliance with building codes. ((Whenever possible at least five 23 contractors shall be invited to submit bids. Once a contractor has 24 been afforded an opportunity to submit a proposal, that contractor 25 shall not be offered another opportunity until all other appropriate 26 contractors on the small works roster have been afforded an opportunity to submit a proposal on a contract. Proposals)) Quotations may be 27 28 invited from all appropriate contractors on the <u>appropriate</u> small works 29 As an alternative, quotations may be invited from at least roster. 30 five contractors on the appropriate small works roster who have indicated the capability of performing the kind of work being 31 contracted, in a manner that will equitably distribute the opportunity 32 among the contractors on the appropriate roster. However, if the 33 34 estimated cost of the work is from one hundred thousand dollars to two 35 hundred thousand dollars, a state agency or local government, other than a port district, that chooses to solicit bids from less than all 36 37 the appropriate contractors on the appropriate small works roster must also notify the remaining contractors on the appropriate small works 38 39 roster that quotations on the work are being sought. The government

has the sole option of determining whether this notice to the remaining 1 contractors is made by: (a) Publishing notice in a legal newspaper in 2 general circulation in the area where the work is to be done; (b) 3 4 mailing a notice to these contractors; or (c) sending a notice to these contractors by facsimile or other electronic means. For purposes of 5 this subsection, "equitably distribute" means that a state agency or 6 7 local government soliciting bids may not favor certain contractors on 8 the appropriate small works roster over other contractors on the 9 appropriate small works roster who perform similar services.

10 (5) A contract awarded from a small works roster under this section 11 need not be advertised.

12 <u>(6)</u> Immediately after an award is made, the bid quotations obtained 13 shall be recorded, open to public inspection, and available by 14 telephone inquiry.

15 (7) The breaking of any project into units or accomplishing any 16 projects by phases is prohibited if it is done for the purpose of 17 avoiding the maximum dollar amount of a contract that may be let using 18 the small works roster process.

19 (8) As used in this section, "state agency" means the department of general administration, the state parks and recreation commission, the 20 department of natural resources, the department of fish and wildlife, 21 the department of transportation, any institution of higher education 22 as defined under RCW 28B.10.016, and any other state agency delegated 23 24 authority by the department of general administration to engage in construction, building, renovation, remodeling, alteration, 25 26 improvement, or repair activities.

27 Sec. 102. RCW 39.04.010 and 1997 c 220 s 402 are each amended to 28 read as follows:

29 The term state shall include the state of Washington and all 30 departments, supervisors, commissioners and agencies thereof.

The term municipality shall include every city, county, town, 31 district or other public agency thereof which is authorized by law to 32 33 require the execution of public work, except drainage districts, diking 34 districts, diking and drainage improvement districts, drainage improvement districts, diking improvement districts, consolidated 35 36 diking and drainage improvement districts, consolidated drainage 37 improvement districts, consolidated diking improvement districts, 38 irrigation districts or any such other districts as shall from time to

1 time be authorized by law for the reclamation or development of waste 2 or undeveloped lands.

3 The term public work shall include all work, construction, 4 alteration, repair, or improvement other than ordinary maintenance, executed at the cost of the state or of any municipality, or which is 5 by law a lien or charge on any property therein. All public works, 6 7 including maintenance when performed by contract shall comply with the 8 provisions of RCW 39.12.020. The term does not include work, 9 construction, alteration, repair, or improvement performed under contracts entered into under RCW 36.102.060(4) or under development 10 agreements entered into under RCW 36.102.060(7) or leases entered into 11 under RCW 36.102.060(8). 12

The term contract shall mean a contract in writing for the execution of public work for a fixed or determinable amount duly awarded after advertisement and competitive bid. However, a contract which is awarded from a small works roster ((under the authority of RCW <del>39.04.150, 35.22.620, 28B.10.355, 35.82.075, and 57.08.050</del>)) need not be advertised.

19 **Sec. 103.** RCW 39.04.200 and 1993 c 198 s 3 are each amended to 20 read as follows:

21 Any ((municipality that utilizes the small works roster process established in RCW 39.04.155 to award contracts for public works 22 23 projects, or)) local government using the uniform process established in RCW 39.04.190 to award contracts for purchases((-)) must post a list 24 25 of the contracts awarded under ((RCW 39.04.155 and 39.04.190)) that 26 process at least once every two months. Any state agency or local government using the small works roster process established in RCW 27 <u>39.04.155 to award contracts for construction, building, renovation,</u> 28 29 remodeling, alteration, repair, or improvement of real property must make available a list of the contracts awarded under that process at 30 The list shall contain the name of the least once every year. 31 contractor or vendor awarded the contract, the amount of the contract, 32 a brief description of the type of work performed or items purchased 33 under the contract, and the date it was awarded. The list shall also 34 state the location where the bid quotations for these contracts are 35 36 available for public inspection.

<u>NEW SECTION.</u> Sec. 104. A new section is added to chapter 39.04
 RCW to read as follows:

3 The department of community, trade, and economic development, in 4 cooperation with the municipal research and services center, shall 5 prepare a small works roster manual and periodically notify the 6 different types of local government authorized to use a small works 7 roster process about this authority.

8 <u>NEW SECTION.</u> **Sec. 105.** A new section is added to chapter 39.04 9 RCW to read as follows:

10 The department of community development, in cooperation with the 11 municipal research and services center, shall prepare a small works 12 roster manual and periodically notify the different types of local 13 government authorized to use a small works roster process about this 14 authority.

15 <u>NEW SECTION.</u> Sec. 106. A report on the use of the small works 16 roster shall be made to the independent oversight committee established 17 under RCW 39.10.110 prior to the 2003 legislative session.

# PART II - REFERENCES TO SMALL WORKS ROSTER PROCEDURE

19 Sec. 201. RCW 28A.335.190 and 1995 1st sp.s. c 10 s 3 are each 20 amended to read as follows:

21 (1) When, in the opinion of the board of directors of any school 22 district, the cost of any furniture, supplies, equipment, building, improvements, or repairs, or other work or purchases, except books, 23 will equal or exceed the sum of fifty thousand dollars, complete plans 24 25 and specifications for such work or purchases shall be prepared and 26 notice by publication given in at least one newspaper of general circulation within the district, once each week for two consecutive 27 of the intention to receive bids therefor 28 weeks, and that specifications and other information may be examined at the office of 29 30 the board or any other officially designated location: PROVIDED, That 31 the board without giving such notice may make improvements or repairs to the property of the district through the shop and repair department 32 33 of such district when the total of such improvements or repair does not exceed the sum of (a) fifteen thousand dollars, for districts with 34 fifteen thousand five hundred or more full-time equivalent students; or 35

р. б

(b) for districts with fewer than fifteen thousand five hundred full-1 time equivalent students, fifteen thousand dollars if more than one 2 craft or trade is involved with the school district improvement or 3 4 repair, or ten thousand dollars if a single craft or trade is involved with the school district improvement or repair. The cost of any public 5 work, improvement or repair for the purposes of this section shall be 6 7 the aggregate of all amounts to be paid for labor, material, and 8 equipment on one continuous or interrelated project where work is to be 9 performed simultaneously or in close sequence. The bids shall be in writing and shall be opened and read in public on the date and in the 10 place named in the notice and after being opened shall be filed for 11 12 public inspection.

(2) Every purchase of furniture, equipment or supplies, except 13 books, the cost of which is estimated to be in excess of fifteen 14 15 thousand dollars, shall be on a competitive basis. The board of 16 directors shall establish a procedure for securing telephone and/or 17 written quotations for such purchases. Whenever the estimated cost is from fifteen thousand dollars up to fifty thousand dollars, the 18 19 procedure shall require quotations from at least three different sources to be obtained in writing or by telephone, and recorded for 20 Whenever the estimated cost is in excess of fifty public perusal. 21 thousand dollars, the public bidding process provided in subsection (1) 22 of this section shall be followed. 23

24 (3) Every building, improvement, repair or other public works 25 project, the cost of which is estimated to be in excess of (a) fifteen 26 thousand dollars, for districts with fifteen thousand five hundred or 27 more full-time equivalent students; or (b) for districts with fewer than fifteen thousand five hundred full-time equivalent students, 28 29 fifteen thousand dollars if more than one craft or trade is involved 30 with the school district improvement or repair, or ten thousand dollars if a single craft or trade is involved with the school district 31 improvement or repair, shall be on a competitive bid process. 32 ((<del>All</del> 33 such projects estimated to be less than fifty thousand dollars may be 34 awarded to a contractor on the small works roster. The small works 35 roster shall be comprised of all responsible contractors who have requested to be on the list. The board of directors shall establish a 36 procedure for securing telephone and/or written quotations from the 37 38 contractors on the small works roster to assure establishment of a 39 competitive price and for awarding contracts to the lowest responsible

bidder. Such procedure shall require that a good faith effort be made 1 2 to request quotations from all contractors on the small works roster who have indicated the capability of performing the kind of public 3 4 works being contracted. Immediately after an award is made, the bid 5 quotations obtained shall be recorded, open to public inspection, and available by telephone inquiry. The small works roster shall be 6 7 revised at least once each year by publishing notice of such 8 opportunity in at least one newspaper of general circulation in the 9 district. Responsible contractors shall be added to the list at any 10 time they submit a written request.)) Whenever the estimated cost of a public works project is fifty thousand dollars or more, the public 11 12 bidding process provided in subsection (1) of this section shall be 13 followed unless the contract is let using the small works roster process in RCW 39.04.155 or under any other procedure authorized for 14 15 school districts. One or more school districts may authorize an educational service district to establish and operate a small works 16 roster for the school district under the provisions of RCW 39.04.155. 17

18 (4) The contract for the work or purchase shall be awarded to the 19 lowest responsible bidder as defined in RCW 43.19.1911 but the board 20 may by resolution reject any and all bids and make further calls for 21 bids in the same manner as the original call. On any work or purchase 22 the board shall provide bidding information to any qualified bidder or 23 the bidder's agent, requesting it in person.

24 (5) In the event of any emergency when the public interest or 25 property of the district would suffer material injury or damage by 26 delay, upon resolution of the board declaring the existence of such an 27 emergency and reciting the facts constituting the same, the board may waive the requirements of this section with reference to any purchase 28 29 or contract: PROVIDED, That an "emergency", for the purposes of this 30 section, means a condition likely to result in immediate physical injury to persons or to property of the school district in the absence 31 of prompt remedial action. 32

(6) This section does not apply to the direct purchase of school
 buses by school districts and educational services in accordance with
 RCW 28A.160.195.

36 **Sec. 202.** RCW 28B.10.350 and 1993 c 379 s 109 are each amended to 37 read as follows:

(1) When the cost to The Evergreen State College, any regional 1 university, or state university, of any building, construction, 2 renovation, remodeling, or demolition other than maintenance or repairs 3 4 will equal or exceed the sum of twenty-five thousand dollars, complete 5 plans and specifications for such work shall be prepared and such work shall be put out for public bids and the contract shall be awarded to 6 7 lowest responsible bidder if in accordance with the bid the 8 specifications: PROVIDED, That when the estimated cost of such 9 building, construction, renovation, remodeling, or demolition equals or 10 exceeds the sum of twenty-five thousand dollars, such project shall be deemed a public works and "the prevailing rate of wage," under chapter 11 12 39.12 RCW shall be applicable thereto: PROVIDED FURTHER, That when such building, construction, renovation, remodeling, or demolition 13 involves one trade or craft area and the estimated cost exceeds ten 14 thousand dollars, complete plans and specifications for such work shall 15 16 be prepared and such work shall be put out for public bids, and the contract shall be awarded to the lowest responsible bidder if in 17 accordance with the bid specifications. This subsection shall not 18 19 apply when a contract is awarded by the small works roster procedure 20 authorized in RCW ((<del>28B.10.355</del>)) <u>39.04.155 or under any other procedure</u> authorized for an institution of higher education. 21

(2) The Evergreen State College, any regional university, or state
university may require a project to be put to public bid even when it
is not required to do so under subsection (1) of this section.

25 (3) Where the estimated cost to The Evergreen State College, any 26 regional university, or state university of any building, construction, renovation, remodeling, or demolition is less than 27 twenty-five thousand dollars or the contract is awarded by the small 28 works roster procedure authorized in RCW ((28B.10.355)) 39.04.155, the 29 30 publication requirements of RCW 39.04.020 shall be inapplicable.

31 (4) In the event of any emergency when the public interest or property of The Evergreen State College, regional university, or state 32 university would suffer material injury or damage by delay, the 33 president of such college or university may declare the existence of 34 35 such an emergency and reciting the facts constituting the same may waive the requirements of this section with reference to any contract 36 37 in order to correct the condition causing the emergency: PROVIDED, That an "emergency," for the purposes of this section, means a 38 39 condition likely to result in immediate physical injury to persons or

1 to property of such college or university in the absence of prompt 2 remedial action or a condition which immediately impairs the 3 institution's ability to perform its educational obligations.

4 **Sec. 203.** RCW 35.22.620 and 1998 c 278 s 2 are each amended to 5 read as follows:

6 (1) As used in this section, the term "public works" means as 7 defined in RCW 39.04.010.

8 (2) A first class city may have public works performed by contract 9 pursuant to public notice and call for competitive bids. As limited by subsection (3) of this section, a first class city may have public 10 works performed by city employees in any annual or biennial budget 11 12 period equal to a dollar value not exceeding ten percent of the public works construction budget, including any amount in a supplemental 13 14 public works construction budget, over the budget period. The amount 15 of public works that a first class city has a county perform for it under RCW 35.77.020 shall be included within this ten percent 16 limitation. 17

18 If a first class city has public works performed by public employees in any budget period that are in excess of this ten percent 19 limitation, the amount in excess of the permitted amount shall be 20 reduced from the otherwise permitted amount of public works that may be 21 performed by public employees for that city in its next budget period. 22 23 Twenty percent of the motor vehicle fuel tax distributions to that city 24 shall be withheld if two years after the year in which the excess amount of work occurred, the city has failed to so reduce the amount of 25 public works that it has performed by public employees. The amount so 26 withheld shall be distributed to the city when it has demonstrated in 27 its reports to the state auditor that the amount of public works it has 28 29 performed by public employees has been so reduced.

Whenever a first class city has had public works performed in any budget period up to the maximum permitted amount for that budget period, all remaining public works within that budget period shall be done by contract pursuant to public notice and call for competitive bids.

The state auditor shall report to the state treasurer any first class city that exceeds this amount and the extent to which the city has or has not reduced the amount of public works it has performed by public employees in subsequent years.

(3) In addition to the percentage limitation provided in subsection 1 2 (2) of this section, a first class city with a population in excess of one hundred fifty thousand shall not have public employees perform a 3 4 public works project in excess of fifty thousand dollars if more than 5 a single craft or trade is involved with the public works project, or a public works project in excess of twenty-five thousand dollars if 6 only a single craft or trade is involved with the public works project 7 8 or the public works project is street signalization or street lighting. 9 In addition to the percentage limitation provided in subsection (2) of 10 this section, a first class city with a population of one hundred fifty thousand or less shall not have public employees perform a public works 11 12 project in excess of thirty-five thousand dollars if more than one 13 craft or trade is involved with the public works project, or a public works project in excess of twenty thousand dollars if only a single 14 15 craft or trade is involved with the public works project or the public 16 works project is street signalization or street lighting. A public 17 works project means a complete project. The restrictions in this subsection do not permit the division of the project into units of work 18 19 or classes of work to avoid the restriction on work that may be 20 performed by day labor on a single project.

(4) In addition to the accounting and record-keeping requirements 21 contained in RCW 39.04.070, every first class city annually shall 22 23 prepare a report for the state auditor indicating the total public 24 works construction budget and supplemental public works construction 25 budget for that year, the total construction costs of public works 26 performed by public employees for that year, and the amount of public works that is performed by public employees above or below ten percent 27 of the total construction budget. However, if a city budgets on a 28 29 biennial basis, this annual report shall indicate the amount of public 30 works that is performed by public employees within the current biennial period that is above or below ten percent of the total biennial 31 construction budget. 32

33 ((After September 1, 1987,)) Each first class city with a 34 population of one hundred fifty thousand or less shall use the form 35 required by RCW 43.09.205 to account and record costs of public works 36 in excess of five thousand dollars that are not let by contract.

(5) The cost of a separate public works project shall be the costsof materials, supplies, equipment, and labor on the construction of

that project. The value of the public works budget shall be the value
 of all the separate public works projects within the budget.

3 (6) The competitive bidding requirements of this section may be 4 waived by the city legislative authority pursuant to RCW 39.04.280 if 5 an exemption contained within that section applies to the work or 6 contract.

7 (7) In lieu of the procedures of subsections (2) and (6) of this 8 section, a first class city may ((use)) <u>let contracts using</u> the small 9 works roster process in RCW 39.04.155 ((<del>to award contracts for public</del> 10 <del>works projects with an estimated value of one hundred thousand dollars</del> 11 <del>or less</del>)).

12 Whenever possible, the city shall invite at least one proposal from 13 a minority or woman contractor who shall otherwise qualify under this 14 section.

(8) The allocation of public works projects to be performed by cityemployees shall not be subject to a collective bargaining agreement.

(9) This section does not apply to performance-based contracts, as
defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A
RCW.

(10) Nothing in this section shall prohibit any first class city
 from allowing for preferential purchase of products made from recycled
 materials or products that may be recycled or reused.

23 **Sec. 204.** RCW 35.23.352 and 1998 c 278 s 3 are each amended to 24 read as follows:

25 (1) Any second class city or any town may construct any public works, as defined in RCW 39.04.010, by contract or day labor without 26 calling for bids therefor whenever the estimated cost of the work or 27 improvement, including cost of materials, supplies and equipment will 28 29 not exceed the sum of thirty thousand dollars if more than one craft or trade is involved with the public works, or twenty thousand dollars if 30 a single craft or trade is involved with the public works or the public 31 32 works project is street signalization or street lighting. A public works project means a complete project. The restrictions in this 33 34 subsection do not permit the division of the project into units of work or classes of work to avoid the restriction on work that may be 35 performed by day labor on a single project. 36

37 Whenever the cost of the public work or improvement, including 38 materials, supplies and equipment, will exceed these figures, the same

shall be done by contract. All such contracts shall be let at public 1 bidding upon publication of notice calling for sealed bids upon the 2 3 work. The notice shall be published in the official newspaper, or a 4 newspaper of general circulation most likely to bring responsive bids, at least thirteen days prior to the last date upon which bids will be 5 received. The notice shall generally state the nature of the work to б 7 be done that plans and specifications therefor shall then be on file in 8 the city or town hall for public inspections, and require that bids be 9 sealed and filed with the council or commission within the time specified therein. Each bid shall be accompanied by a bid proposal 10 deposit in the form of a cashier's check, postal money order, or surety 11 bond to the council or commission for a sum of not less than five 12 percent of the amount of the bid, and no bid shall be considered unless 13 accompanied by such bid proposal deposit. The council or commission of 14 15 the city or town shall let the contract to the lowest responsible 16 bidder or shall have power by resolution to reject any or all bids and 17 to make further calls for bids in the same manner as the original call. When the contract is let then all bid proposal deposits shall be 18 19 returned to the bidders except that of the successful bidder which shall be retained until a contract is entered into and a bond to 20 perform the work furnished, with surety satisfactory to the council or 21 commission, in accordance with RCW 39.08.030. If the bidder fails to 22 enter into the contract in accordance with his or her bid and furnish 23 24 a bond within ten days from the date at which he or she is notified 25 that he or she is the successful bidder, the check or postal money 26 order and the amount thereof shall be forfeited to the council or commission or the council or commission shall recover the amount of the 27 surety bond. A low bidder who claims error and fails to enter into a 28 29 contract is prohibited from bidding on the same project if a second or 30 subsequent call for bids is made for the project.

If no bid is received on the first call the council or commission may readvertise and make a second call, or may enter into a contract without any further call or may purchase the supplies, material or equipment and perform the work or improvement by day labor.

(2) The allocation of public works projects to be performed by city
 or town employees shall not be subject to a collective bargaining
 agreement.

(3) In lieu of the procedures of subsection (1) of this section, a
second class city or a town may ((use)) <u>let contracts using</u> the small

A housing authority may establish and use a small works roster for awarding contracts under RCW 39.04.155.

3 (1) In each county with a population of one million or more which 4 resolution establishes a county purchasing department, the by purchasing department shall enter into leases of personal property on 5 a competitive basis and purchase all supplies, materials, and equipment 6 7 on a competitive basis, for all departments of the county, as provided 8 in this chapter and chapter 39.04 RCW, except that the county 9 purchasing department is not required to make purchases that are paid 10 from the county road fund or equipment rental and revolving fund.

11 (2) As used in this section, "public works" has the same definition 12 as in RCW 39.04.010.

(3) Except as otherwise specified in this chapter or in chapter 36.77 RCW, all counties subject to these provisions shall contract on a competitive basis for all public works after bids have been submitted to the county upon specifications therefor.
