- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** This act shall be known and cited as the
- 6 Fred Mills act.
- 7 Sec. 2. RCW 74.41.020 and 1987 c 409 s 1 are each amended to read
- 8 as follows:
- 9 It is the intent of the legislature to provide ((for both)) a
- 10 comprehensive program of long-term care information and support,
- 11 <u>including</u> in-home and out-of-home respite care services ((which are
- 12 provided by a range of service providers)), for family and other unpaid
- 13 caregivers who provide the daily services required when caring for
- 14 <u>adults with functional disabilities</u>. The ((respite care)) <u>family</u>
- 15 <u>caregiver long-term care information and support services shall:</u>
- 16 (1) Provide <u>information</u>, relief, and support to family or other
- 17 unpaid caregivers of ((disabled)) adults with functional disabilities;

- 1 (2) Encourage <u>family and other nonpaid</u> individuals to provide care 2 for ((disabled)) adults <u>with functional disabilities</u> at home, and thus 3 offer a viable alternative to ((institutionalization)) <u>placement in a</u> 4 <u>long-term care facility</u>;
- 5 (3) Ensure that respite care is made generally available on a 6 sliding-fee basis to eligible participants in the program according to 7 priorities established by the department;
 - (4) Be provided in the least restrictive setting available consistent with the individually assessed needs of the ((functionally disabled)) adults with functional disabilities; ((and))
- 11 (5) Include services appropriate to the needs of persons caring for 12 individuals with dementing illnesses; and
- 13 (6) Provide unpaid family and other unpaid caregivers with services
 14 that enable them to make informed decisions about current and future
 15 care plans, solve day-to-day caregiving problems, learn essential
 16 caregiving skills, and locate services that may strengthen their
 17 capacity to provide care.
- 18 **Sec. 3.** RCW 74.41.030 and 1987 c 409 s 2 are each amended to read 19 as follows:
- 20 Unless the context clearly indicates otherwise, the definitions in 21 this section apply throughout this chapter.
- (1) <u>"Family caregiver long-term care information and support</u> 22 23 services" means providing long-term care information and support services to unpaid family and other unpaid caregivers of adults with 24 functional disabilities, including but not limited to providing: (a) 25 Information about available public and private long-term care support 26 services; (b) assistance in gaining access to an array of appropriate 27 long-term care family caregiver services; (c) promotion and 28 29 implementation of support groups; (d) caregiver training to assist the nonpaid caregivers in making decisions and solving challenges relating 30 to their caregiving roles; (e) respite care services; and (f) 31 additional supportive long-term care services that may include but not 32 33 be limited to translating/interpreter services, specialized 34 transportation, coordination of health care services, help purchasing needed supplies, durable goods, or equipment, and other forms of 35

activity.

(2) "Respite care services" means relief care for families or other caregivers of ((disabled)) adults with functional disabilities, eligibility for which shall be determined by the department by rule.

The services provide temporary care or supervision of ((disabled)) adults with functional disabilities in substitution for the caregiver.

The term includes ((social)) adult day ((care)) services.

- ((\(\frac{(2)}{2}\))) (3) "Eligible participant for family caregiver long-term care information and support services" means an adult ((\(\frac{(a)}{2}\))) who needs substantially continuous care or supervision by reason of his or her functional disability((\(\frac{1}{2}\)), and (b) who is assessed as requiring institutionalization in the absence of a caregiver assisted by home and community support services, including respite care)) and may be at risk of placement into a long-term care facility.
- 14 (4) "Eligible participant for respite care services" means an adult
 15 who needs substantially continuous care or supervision by reason of his
 16 or her functional disability and is also assessed as requiring
 17 placement into a long-term care facility in the absence of an unpaid
 18 family or other unpaid caregiver.
 - ((\(\frac{(3)}{)}\)) (5) "Unpaid caregiver" means a spouse, relative, or friend who has primary responsibility for the care of ((a functionally disabled adult,)) an adult with a functional disability and who does not receive financial compensation for the care((, and who is assessed as being at risk of placing the eligible participant in a long-term care facility if respite care is not available)). To be eligible for respite care and for family caregiver support services, the caregiver is considered the client.
- 27 ((4) "Institutionalization" means placement in a long-term care 28 facility.
- 29 (5)) (6) "((Social)) Adult day ((care)) services" means nonmedical 30 services to persons who live with their families, cannot be left unsupervised, and are at risk of being placed in a twenty-four-hour 32 care facility if their families do not receive some relief from 33 constant care.
- (((+6))) (7) "Department" means the department of social and health services.
- **Sec. 4.** RCW 74.41.050 and 1989 c 427 s 8 are each amended to read 37 as follows:

1 The department shall contract with area agencies on aging or other appropriate agencies to conduct ((respite care projects)) family 2 3 caregiver long-term care information and support services to the extent 4 of available funding. The responsibilities of the agencies shall include but not be limited to: (1) Administering a program of family 5 caregiver long-term care information and support services; and (2) 6 7 negotiating rates of payment, administering sliding-fee scales to 8 enable eligible participants to participate in paying for respite care, and arranging for respite care <u>information</u>, training, and other support 9 10 ((Rates of payment to respite care service providers shall not exceed, and may be less than, rates paid by the department to 11 providers for the same level of service.)) In evaluating the need for 12 respite services, consideration shall be given to the mental and 13 physical ability of the caregiver to perform necessary caregiver 14 15 functions.

16 **Sec. 5.** RCW 74.41.070 and 1998 c 245 s 151 are each amended to 17 read as follows:
