7 "NEW SECTION. **Sec. I.** It is the intent of this act to clarify
8 that the legislature, when it enacted Senate Bill No. 6865 during the
9 2000 legislative session, intended to repeal all motor vehicle excise
10 taxes, including the local motor vehicle excise tax and replace them
11 with a thirty dollar license fee.

12 NEW SECTION. **Sec. II.** The following acts or parts of acts are
13 each repealed:

15 excise tax authorized--Credits--Public hearing on route and design--

34 combustion equipment to comply with pollution control standards) and

2 facilities to be in conjunction with system stations or transfer
3 facilities) and 1969 ex.s. c 255 s 20.

4 NEW SECTION. **Sec. III.** This act is necessary for the immediate
5 preservation of the public peace, health, or safety, or support of the
6 state government and its existing public institutions, and takes effect
7 immediately.

8 NEW SECTION. **Sec. IV.** This act applies retroactively to January
9 1, 2000."
