- 1 AN ACT Relating to removal of competitive grant requirements for
- 2 community mobilization; amending RCW 43.270.010, 43.270.020,
- 3 43.270.070, and 43.270.080; and repealing RCW 43.270.030, 43.270.050,
- 4 and 43.270.060.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 43.270.010 and 1989 c 271 s 315 are each amended to 7 read as follows:
- 8 The legislature recognizes that state-wide efforts aimed at
- 9 reducing the incidence of substance abuse, including alcohol, tobacco,
- 10 or other drug abuse, or violence must be increased. The legislature
- 11 further recognizes that the most effective strategy for reducing the
- 12 impact of alcohol ((and)), tobacco, other drug abuse, and violence is
- 13 through the collaborative efforts of educators, law enforcement, local
- 14 government officials, local treatment providers, and concerned
- 15 community and citizens' groups.
- 16 The legislature intends to support the development and activities
- 17 of community mobilization strategies against ((substance)) alcohol,
- 18 tobacco, or other drug abuse, and violence, through the following
- 19 efforts:

- 1 (1) ((Provide)) Providing funding support for prevention, 2 treatment, and enforcement activities identified by communities that 3 have brought together education, treatment, local government, law 4 enforcement, and other key elements of the community;
- 5 (2) ((Provide)) Providing technical assistance and support to help 6 communities develop and carry out effective activities; and
- 7 (3) ((Provide)) Providing communities with opportunities to share 8 suggestions for state program operations and budget priorities.
- 9 **Sec. 2.** RCW 43.270.020 and 1989 c 271 s 316 are each amended to 10 read as follows:
- 11 (1) There is established in the ((office of the governor))
- 12 <u>department of community, trade, and economic development</u> a grant
- 13 program to provide incentive for and support for communities to develop
- 14 targeted and coordinated strategies to reduce the incidence and impact
- 15 of ((substance)) alcohol, tobacco, or other drug abuse, or violence.
- 16 (2) The department of community, trade, and economic development
- 17 shall make awards, subject to funds appropriated by the legislature,
- 18 <u>under the following terms:</u>
- 19 <u>(a) Starting July 1, 2001, funds will be available to county-wide</u>
- 20 programs through a formula developed by the department of community,
- 21 trade, and economic development in consultation with program
- 22 contractors, which will take into consideration county population size.
- 23 (b) In order to be eligible for consideration, applicants must
- 24 <u>demonstrate</u>, at a minimum:
- 25 <u>(i) That the community has developed and is committed to carrying</u>
- 26 out a coordinated strategy of prevention, treatment, and law
- 27 enforcement activities;
- 28 (ii) That the community has considered research-based theory when
- 29 <u>developing its strategy;</u>
- 30 (iii) That proposals submitted for funding are based on a local
- 31 assessment of need and address specific objectives contained in a
- 32 coordinated strategy of prevention, treatment, and law enforcement
- 33 <u>against alcohol, tobacco, or other drug abuse, or violence;</u>
- 34 (iv) Evidence of active participation in preparation of the
- 35 proposal and specific commitments to implementing the community-wide
- 36 agenda by leadership from education, law enforcement, local government,
- 37 tribal government, and treatment entities in the community, and the
- 38 opportunity for meaningful involvement from others such as neighborhood

- 1 and citizen groups, businesses, human service, health and job training
- 2 organizations, and other key elements of the community, particularly
- 3 those whose responsibilities in law enforcement, treatment, prevention,
- 4 <u>education</u>, or other community efforts provide direct, ongoing contact
- 5 with substance abusers or those who exhibit violent behavior, or those
- 6 <u>at risk for alcohol, tobacco, or other drug abuse, or violent behavior;</u>
- 7 (v) Evidence of additional local resources committed to the
- 8 applicant's strategy totaling at least twenty-five percent of funds
- 9 awarded under this section. These resources may consist of public or
- 10 private funds, donated goods or services, and other measurable
- 11 commitments, including in-kind contributions such as volunteer
- 12 <u>services</u>, <u>materials</u>, <u>supplies</u>, <u>physical facilities</u>, <u>or a combination</u>
- 13 thereof; and
- (vi) That the funds applied for, if received, will not be used to
- 15 replace funding for existing activities.
- 16 (c) At a minimum, grant applications must include the following:
- 17 <u>(i) A definition of geographic area;</u>
- 18 <u>(ii) A needs assessment describing the extent and impact of</u>
- 19 alcohol, tobacco, or other drug abuse, and violence in the community,
- 20 including an explanation of those who are most severely impacted and
- 21 those most at risk of substance abuse or violent behavior;
- 22 (iii) An explanation of the community-wide strategy for prevention,
- 23 treatment, and law enforcement activities related to alcohol, tobacco,
- 24 or other drug abuse, or violence, with particular attention to those
- 25 who are most severely impacted and/or those most at risk of alcohol,
- 26 <u>tobacco</u>, or other drug abuse, or violent behavior;
- 27 <u>(iv) An explanation of who was involved in development of the</u>
- 28 strategy and what specific commitments have been made to carry it out;
- 29 (v) Identification of existing prevention, education, treatment,
- 30 and law enforcement resources committed by the applicant, including
- 31 financial and other support, and an explanation of how the applicant's
- 32 strategy involves and builds on the efforts of existing organizations
- 33 or coalitions that have been carrying out community efforts against
- 34 <u>alcohol</u>, tobacco, or other drug abuse, or violence;
- 35 (vi) Identification of activities that address specific objectives
- 36 <u>in the strategy for which additional resources are needed;</u>
- 37 (vii) Identification of additional local resources, including
- 38 public or private funds, donated goods or services, and other

- 1 measurable commitments, that have been committed to the activities
- 2 <u>identified in (c)(vi) of this subsection;</u>
- 3 (viii) Identification of activities that address specific
- 4 <u>objectives in the strategy for which funding is requested;</u>
- 5 (ix) For each activity for which funding is requested, an
- 6 <u>explanation in sufficient detail to demonstrate:</u>
- 7 (A) Feasibility through deliberative design, specific objectives,
- 8 and a realistic plan for implementation;
- 9 (B) A rationale for how this activity will achieve measurable
- 10 results and how it will be evaluated;
- 11 (C) That funds requested are necessary and appropriate to
- 12 effectively carry out the activity; and
- 13 (x) Identification of a contracting agent meeting state
- 14 requirements for each activity proposed for funding.
- 15 <u>Each contracting agent must execute a written agreement with its</u>
- 16 local community mobilization advisory board that reflects the duties
- 17 <u>and powers of each party.</u>
- 18 (3) Activities ((which)) that may be funded through this grant
- 19 program include those ((which)) that:
- 20 (((1))) <u>(a)</u> Prevent ((substance)) <u>alcohol</u>, <u>tobacco</u>, <u>or other drug</u>
- 21 abuse, or violence through educational ((and self-esteem)) efforts,
- 22 development of positive alternatives, intervention with high-risk
- 23 groups, and other prevention strategies;
- (((+2))) (b) Support effective treatment by increasing access to and
- 25 availability of treatment opportunities, particularly for underserved
- 26 or highly impacted populations, developing aftercare and support
- 27 mechanisms, and other strategies to increase the availability and
- 28 effectiveness of treatment;
- 29 $((\frac{3}{1}))$ (c) Provide meaningful consequences for participation in
- 30 illegal activity and promote safe and healthy communities through
- 31 support of law enforcement strategies;
- (((4))) (d) Create or build on efforts by existing community
- 33 programs, coordinate their efforts, and develop cooperative efforts or
- 34 other initiatives to make most effective use of resources to carry out
- 35 the community's strategy against ((substance)) alcohol, tobacco, or
- 36 other drug abuse, or violence; and
- (((5))) (e) Other activities ((which)) that demonstrate both
- 38 feasibility and a rationale for how the activity will achieve

- 1 measurable results in the strategy against ((substance)) alcohol,
- 2 tobacco, or other drug abuse, or violence.
- 3 **Sec. 3.** RCW 43.270.070 and 1989 c 271 s 321 are each amended to 4 read as follows:
- 5 The ((governor)) <u>department of community, trade, and economic</u>
- 6 <u>development</u> shall ask communities for suggestions on state practices,
- 7 policies, and priorities that would help communities implement their
- 8 strategies against ((substance)) alcohol, tobacco, or other drug abuse,
- 9 <u>or violence</u>. The ((governor or appropriate agency officials))
- 10 <u>department of community, trade, and economic development</u> shall review
- 11 and respond to those suggestions making necessary changes where
- 12 feasible, making recommendations to the legislature where appropriate,
- 13 and providing an explanation as to why suggested changes cannot be
- 14 accomplished, if the suggestions cannot be acted upon.
- 15 **Sec. 4.** RCW 43.270.080 and 1989 c 271 s 322 are each amended to 16 read as follows:
- 17 The ((governor)) department of community, trade, and economic
- 18 <u>development</u> may receive such gifts, grants, and endowments from public
- 19 or private sources as may be made from time to time, in trust or
- 20 otherwise, for the use and benefit of the purposes of RCW 43.270.010
- 21 through 43.270.080 and expend the same or any income therefrom
- 22 according to the terms of the gifts, grants, or endowments.

- 25 (1) RCW 43.270.030 (Content of application) and 1989 c 271 s 317;
