HOUSE BILL 1511

State of Washington 57th Legislature 2001 Regular Session

Read first time 01/29/2001. Referred to Committee on Transportation.

- 1 AN ACT Relating to determining long-term air transportation needs
- 2 including airport siting; amending RCW 36.70A.200; adding a new section
- 3 to chapter 47.06 RCW; adding a new section to chapter 47.80 RCW; adding
- 4 a new chapter to Title 47 RCW; and making an appropriation.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that airports are
- 7 critical to the statewide transportation infrastructure. The 2000
- 8 Washington Blue Ribbon Commission on Transportation reported that the
- 9 state has no plans in place today that, if implemented, would yield
- 10 results that would meet the long-term transportation needs of the
- 11 state. The long-standing lack of consensus on how to solve
- 12 Washington's transportation problems should be resolved through a
- 13 reasonable process. The legislature intends the airport siting council
- 14 to site airports that will ensure the long-term air transportation
- 15 needs of Washington state are met and are in compliance with applicable
- 16 public health, environmental and land use laws.
- 17 <u>NEW SECTION.</u> **Sec. 2.** (1) If the transportation commission
- 18 declares an impasse under section 3 or 4 of this act, the governor

shall appoint an airport siting council. The council will consist of 1 the following members: (a) The director of the department of 2 3 community, trade, and economic development, or a designee; (b) a member 4 of the transportation commission appointed by the governor, who shall 5 be the chair of the council; (c) two members of the general public with special knowledge or background in airport issues, appointed by the 6 7 governor; and (d) a member of a growth management hearings board, 8 selected by the governor.

The member of a growth management hearings board must be a member of the growth management hearings board that hears appeals from actions taken under the Growth Management Act by counties not located in the region in which the proposed airport project under consideration is located or that is subject to the proposed transportation plan under consideration.

- (2) The chair of the council may designate another councilmember to serve as the acting chair in the absence of the chair. The department of transportation shall provide all administrative and staff support for the council.
- 19 (3) The airport siting council appointed in response to a specific finding of an impasse under section 3 or 4 of this act must be 20 disbanded once the governor has informed the council of his decision 21 under section 6 of this act regarding the council's airport siting 22 23 recommendations concerning the impasse. If, at a later date, the 24 transportation commission declares another impasse the governor shall 25 appoint another airport siting council consistent with subsection (1) of this section. 26

27 NEW SECTION. Sec. 3. If the transportation commission finds that all of the following have occurred, it shall declare an impasse and 28 29 refer the issue to the airport siting council: (1) A regional 30 transportation plan does not satisfactorily address the state's interest as defined in RCW 47.06.040 with respect to planning for 31 transportation needs through siting of an airport; (2) there has been 32 33 ample time to address siting of an airport in the regional transportation plan and local comprehensive plans, but either no 34 decision has been reached or the process has resulted in a decision 35 that will not address the state's transportation needs as set forth in 36 37 RCW 47.06.040; (3) the department of transportation has sought by all 38 reasonable means to encourage local governments and regional bodies to

- cooperate in a planning and decision-making process that addresses in 1 2 a timely manner statewide airport siting needs; (4) the transportation commission has notified the local governments and regional bodies 3 4 responsible for the regional transportation plan of its intent to 5 declare an impasse; and (5) the local governments and regional bodies responsible for the regional transportation plan have failed to show 6 7 cause within thirty days of such notification that an impasse should 8 not be declared.
- 9 <u>NEW SECTION.</u> **Sec. 4.** The transportation commission must declare 10 an impasse by August 1, 2001, regarding the search for a supplemental 11 airport in the Puget Sound region or replacement for Seattle-Tacoma 12 International Airport.
- 13 <u>NEW SECTION.</u> **Sec. 5.** (1) The airport siting council shall convene to make recommendations to the governor whenever the transportation 14 commission passes a resolution declaring that an impasse exists in the 15 siting of an airport of statewide significance, as provided in section 16 17 3 of this act. The council has eighteen months after the date on which 18 the transportation commission resolution is passed to make a recommendation regarding the siting of the airport of statewide 19 20 significance and to communicate its recommendation in writing to the 21 governor.
- 22 (2) The responsibility of the council is to make airport siting 23 recommendations that reflect the interest of the entire state. 24 Accordingly, the council is not limited to the options examined by the regional or local authority, and may also consider alternative sites 25 outside the region. In forming its recommendation the council shall 26 27 review existing information and analyses regarding the siting issue, 28 including both technical data and the decision-making process that 29 failed to produce a resolution. The council may also hire staff for technical evaluation, analysis, and research associated with the 30 31 preparation of its siting recommendation. The council may also 32 consider relationships between the proposed facility and other existing 33 or planned transportation facilities of statewide interest such as airports, rail services, ferry systems, or highways. 34
- NEW SECTION. Sec. 6. (1) The governor must accept or reject the siting council's recommendation within sixty days. If the governor

- 1 rejects the siting council's recommendation, he or she may request the
- 2 siting council to provide an alternative recommendation within thirty
- 3 days. The governor has another sixty days to accept or reject the
- 4 siting council's alternative recommendation. Once the governor has
- 5 made a decision, the governor must inform in writing the members of the
- 6 airport siting council, the transportation commission, the chair(s) of
- 7 the legislative transportation committee, the county or city affected,
- 8 and the regional transportation planning organization located in the
- 9 region in which the transportation project will be sited.
- 10 (2) Subject to the conditions set forth in section 8(2) of this
- 11 act, a decision by the governor binds the state and each of its
- 12 political subdivisions, such as departments, agencies, divisions,
- 13 bureaus, commissions, boards, counties, cities, towns, ports, and
- 14 special districts, whether a political subdivision is a member of the
- 15 council or not, regarding approval of a site and the construction and
- 16 operation of a proposed airport.
- 17 <u>NEW SECTION.</u> **Sec. 7.** The legislature may invalidate the
- 18 governor's decision if two-thirds of each house votes to object to his
- 19 or her choice of sites. The legislature must vote by the end of the
- 20 legislative session convened after the governor's decision. This will
- 21 ensure that the legislature has at least one full legislative session
- 22 for deliberation.
- 23 <u>NEW SECTION.</u> **Sec. 8.** (1) This chapter supersedes other laws for
- 24 establishing the location of airports of statewide significance or
- 25 rules adopted under state law for establishing the location of airports
- 26 of statewide significance.
- 27 (2) However, the requirements of this chapter and rules adopted
- 28 under it do not supersede the State Environmental Policy Act, the State
- 29 Clean Air Act, the State Clean Water Act, the Shoreline Management Act,
- 30 the laws relating to solid and hazardous waste management, and all the
- 31 related portions of the Washington Administrative Code that implement
- 32 these environmental laws.
- 33 <u>NEW SECTION.</u> **Sec. 9.** A new section is added to chapter 47.06 RCW
- 34 to read as follows:
- 35 The legislature declares to be of statewide significance any
- 36 airports designated by the department as included in its plan as

- 1 determined by its own functional classification system and criteria.
- 2 The department shall assert leadership and cooperate with regional
- 3 transportation planning organizations, counties, cities, transit
- 4 agencies, public ports, and the private sector, by including in the
- 5 state's multimodal transportation plan improvements to transportation
- 6 facilities and services of statewide significance. Improvements to
- 7 facilities and services of statewide significance identified in the
- 8 statewide multimodal transportation plan developed under RCW
- 9 47.01.071(3) are considered essential public facilities under RCW
- 10 36.70A.200.
- 11 <u>NEW SECTION.</u> **Sec. 10.** A new section is added to chapter 47.80 RCW
- 12 to read as follows:
- 13 The regional transportation planning organization must adopt a
- 14 regional transportation plan that adequately implements the decision of
- 15 the governor to site an airport of statewide significance, as provided
- 16 in section 6 of this act.
- 17 **Sec. 11.** RCW 36.70A.200 and 1998 c 171 s 3 are each amended to
- 18 read as follows:
- 19 (1) The comprehensive plan of each county and city that is planning
- 20 under this chapter shall include a process for identifying and siting
- 21 essential public facilities. Essential public facilities include those
- 22 facilities that are typically difficult to site, such as airports,
- 23 state education facilities and state or regional transportation
- 24 facilities as defined in RCW 47.06.140, state and local correctional
- 25 facilities, solid waste handling facilities, and in-patient facilities
- 26 including substance abuse facilities, mental health facilities, and
- 27 group homes. <u>If the process of siting an airport fails, the airport</u>
- 28 shall be sited by the process set forth in chapter 47.-- RCW (sections
- 29 1 through 8 of this act).
- 30 (2) The office of financial management shall maintain a list of
- 31 those essential state public facilities that are required or likely to
- 32 be built within the next six years. The office of financial management
- 33 may at any time add facilities to the list. No local comprehensive
- 34 plan or development regulation may preclude the siting of essential
- 35 public facilities.

- 1 <u>NEW SECTION.</u> **Sec. 12.** The sum of five hundred thousand dollars,
- 2 or as much thereof as may be necessary, is appropriated for the
- 3 biennium ending June 30, 2003, from the multimodal fund to the
- 4 department of transportation for the purposes of section 5 of this act.
- 5 <u>NEW SECTION.</u> **Sec. 13.** Sections 1 through 8 of this act constitute

6 a new chapter in Title 47 RCW.
