HOUSE BILL 1938

State of Washington 57th Legislature 2001 Regular Session

Read first time 02/09/2001. Referred to Committee on Criminal Justice & Corrections.

1 AN ACT Relating to sabotage resulting in damage to land, 2 facilities, and property; amending RCW 4.24.630 and 9.05.060; 3 reenacting and amending RCW 9.94A.320; creating a new section; and 4 prescribing penalties.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. Sec. 1. The legislature finds that state, federal, 7 and private facilities increasingly are becoming the target of terrorist activities. Timber and mining companies, fur 8 farms, recreational, residential, commercial, and industrial development, 9 university research facilities, and animal and biotechnology research 10 laboratories have become targets in a campaign of intimidation, 11 12 obstruction, and terrorism aimed at the closing of these facilities or 13 industries. These actions are not only illegal but impose extreme 14 individuals, families, businesses, and suffering and loss on 15 communities and pose a serious threat to human life.

16 **Sec. 2.** RCW 4.24.630 and 1999 c 248 s 2 are each amended to read 17 as follows:

p. 1

(1) Every person who goes onto the land of another and who removes, 1 damages, or destroys livestock, timber, crops, minerals, or other 2 3 similar valuable property from the land, or wrongfully causes waste or 4 injury to the land, or wrongfully injures personal property or 5 improvements to real estate on the land, is liable to the injured party for treble the amount of the damages caused by the removal, waste, or 6 7 injury. For purposes of this section, a person acts "wrongfully" if 8 the person intentionally and unreasonably commits the act or acts while 9 knowing, or having reason to know, that he or she lacks authorization 10 to so act. Damages recoverable under this section include, but are not limited to, damages for the market value of the property removed or 11 injured, and for injury to the land, including the costs of 12 13 restoration. In addition, the person is liable for reimbursing the injured party for the party's reasonable costs, including but not 14 15 limited to investigative costs and reasonable attorneys' fees and other 16 litigation-related costs.

(2) This section does not apply in any case where liability for damages is provided under RCW 64.12.030, 79.01.756, 79.01.760, 79.40.070, or where there is immunity from liability under RCW 64.12.035.

21 **Sec. 3.** RCW 9.05.060 and 1999 c 191 s 2 are each amended to read 22 as follows:

23 (1) Whoever, with intent that his or her act shall, or with reason 24 to believe that it may, injure, interfere with, interrupt, supplant, nullify, impair, or obstruct the owner's or operator's management, 25 operation, or control of any agricultural, stockraising, lumbering, 26 mining, quarrying, fishing, manufacturing, transportation, mercantile, 27 or building enterprise, fur farm, university or private research 28 29 facility, biotechnology laboratory, or any other public or private 30 business or commercial enterprise, wherein any person is employed for wage, shall willfully damage or destroy, or attempt or threaten to 31 damage or destroy, any property whatsoever, or shall unlawfully take or 32 retain, or attempt or threaten unlawfully to take or retain, possession 33 34 or control of any property, instrumentality, machine, mechanism, or appliance used in such business or enterprise, shall be guilty of 35 36 criminal sabotage.

37 (2) Criminal sabotage is a felony.
