1 AN ACT Relating to transportation funding and appropriations;
2 creating new sections; making appropriations; authorizing expenditures
3 for capital improvements; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** (1) The legislature recognizes that a good
6 transportation system is critical in keeping Washington state's economy
7 strong and its businesses competitive. The legislature further
8 recognizes that badly needed investments in our state's transportation
9 infrastructure will create jobs and help to ensure Washington's long-
10 term economic success.

11 (2) The transportation investment act of 2002 is hereby adopted
12 and, subject to the provisions hereinafter set forth, the several
13 amounts hereinafter specified, or as much thereof as may be necessary
14 to accomplish the purposes designated, are hereby appropriated from the
15 several accounts and funds hereinafter named to the designated state
16 agencies and offices for employee compensation and other expenses, for
17 capital projects, and for other specified purposes, including the
18 payment of any final judgments arising out of such activities, for the
19 period ending June 30, 2003.

1 (3) Unless the context clearly requires otherwise, the definitions
2 in this subsection apply throughout the act.

3 (a) "Fiscal year 2002" or "FY 2002" means the fiscal year ending
4 June 30, 2002.

5 (b) "Fiscal year 2003" or "FY 2003" means the fiscal year ending
6 June 30, 2003.

7 (c) "FTE" means full-time equivalent.

8 (d) "Lapse" or "revert" means the amount shall return to an
9 unappropriated status.

10 (e) "Provided solely" means the specified amount may be spent only
11 for the specified purpose.

5 NEW SECTION. **Sec. 1003.** (1) Unless otherwise stated, for all
6 appropriations under this act that require a match of nonstate money or

8 43.88.150, shall apply: Expenditures of state money shall be timed so
