AN ACT Relating to motor vehicle theft; amending RCW 9A.56.070, 9.94A.525, and 13.40.0357; reenacting and amending RCW 9.94A.515; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 9A.56.070 and 1975 1st ex.s. c 260 s 9A.56.070 are 6 each amended to read as follows:

(1) ((Every person who shall)) (a) A person is guilty of taking a
motor vehicle without permission in the first degree if he or she,
without the permission of the owner or person entitled to possession,
intentionally takes or drives away an automobile or motor vehicle,
whether propelled by steam, electricity, or internal combustion engine,
that is the property of another, and he or she:
(i) Alters the motor vehicle for the purpose of changing its

14 appearance or primary identification, including obscuring, removing, or
15 changing the manufacturer's serial number or the vehicle identification
16 number plates;

<u>(ii) Removes, or participates in the removal of, parts from the</u>

(iii) Exports, or attempts to export, the motor vehicle across
 state lines or out of the United States for profit;

3 <u>(iv) Intends to sell the motor vehicle; or</u>

4 (v) Is engaged in a conspiracy and the central object of the
5 conspiratorial agreement is the theft of motor vehicles for sale to
6 others for profit.

7 (b) Taking a motor vehicle without permission in the first degree
8 is a class B felony.

9 (2)(a) A person is guilty of taking a motor vehicle without permission in the second degree if he or she, without the permission 10 of the owner or person entitled to ((the)) possession ((thereof)), 11 12 intentionally takes or drives away any automobile or motor vehicle, 13 whether propelled by steam, electricity, or internal combustion engine, that is the property of another, ((shall be deemed quilty of a felony, 14 15 and every person)) or he or she voluntarily ((riding)) rides in or upon 16 ((said)) the automobile or motor vehicle with knowledge of the fact 17 that ((the same)) it was unlawfully taken ((shall be equally quilty with the person taking or driving said automobile or motor vehicle and 18 19 shall be deemed guilty of taking a motor vehicle without permission)). 20 (((2))) (b) Taking a motor vehicle without permission in the second

21 <u>degree</u> is a class C felony.

13 The offender score is measured on the horizontal axis of the 14 sentencing grid. The offender score rules are as follows:

15 The offender score is the sum of points accrued under this section 16 rounded down to the nearest whole number.

(1) A prior conviction is a conviction which exists before the date of sentencing for the offense for which the offender score is being computed. Convictions entered or sentenced on the same date as the conviction for which the offender score is being computed shall be deemed "other current offenses" within the meaning of RCW 9.94A.589.

22 (2) Class A and sex prior felony convictions shall always be 23 included in the offender score. Class B prior felony convictions other 24 than sex offenses shall not be included in the offender score, if since 25 the last date of release from confinement (including full-time 26 residential treatment) pursuant to a felony conviction, if any, or entry of judgment and sentence, the offender had spent ten consecutive 27 years in the community without committing any crime that subsequently 28 29 results in a conviction. Class C prior felony convictions other than 30 sex offenses shall not be included in the offender score if, since the last date of release from confinement (including full-time residential 31 treatment) pursuant to a felony conviction, if any, or entry of 32 33 judgment and sentence, the offender had spent five consecutive years in 34 the community without committing any crime that subsequently results in a conviction. Serious traffic convictions shall not be included in the 35 36 offender score if, since the last date of release from confinement 37 (including full-time residential treatment) pursuant to a felony conviction, if any, or entry of judgment and sentence, the offender 38

spent five years in the community without committing any crime that
 subsequently results in a conviction. This subsection applies to both
 adult and juvenile prior convictions.

4 (3) Out-of-state convictions for offenses shall be classified according to the comparable offense definitions and sentences provided 5 by Washington law. Federal convictions for offenses shall be 6 7 classified according to the comparable offense definitions and 8 sentences provided by Washington law. If there is no clearly 9 comparable offense under Washington law or the offense is one that is 10 usually considered subject to exclusive federal jurisdiction, the offense shall be scored as a class C felony equivalent if it was a 11 felony under the relevant federal statute. 12

(4) Score prior convictions for felony anticipatory offenses
(attempts, criminal solicitations, and criminal conspiracies) the same
as if they were convictions for completed offenses.

16 (5)(a) In the case of multiple prior convictions, for the purpose 17 of computing the offender score, count all convictions separately, 18 except:

19 (i) Prior offenses which were found, under RCW 9.94A.589(1)(a), to encompass the same criminal conduct, shall be counted as one offense, 20 the offense that yields the highest offender score. The current 21 sentencing court shall determine with respect to other prior adult 22 offenses for which sentences were served concurrently or prior juvenile 23 24 offenses for which sentences were served consecutively, whether those offenses shall be counted as one offense or as separate offenses using 25 26 the "same criminal conduct" analysis found in RCW 9.94A.589(1)(a), and 27 if the court finds that they shall be counted as one offense, then the offense that yields the highest offender score shall be used. 28 The 29 current sentencing court may presume that such other prior offenses 30 were not the same criminal conduct from sentences imposed on separate 31 dates, or in separate counties or jurisdictions, or in separate complaints, indictments, or informations; 32

(ii) In the case of multiple prior convictions for offenses committed before July 1, 1986, for the purpose of computing the offender score, count all adult convictions served concurrently as one offense, and count all juvenile convictions entered on the same date as one offense. Use the conviction for the offense that yields the highest offender score.

1 (b) As used in this subsection (5), "served concurrently" means 2 that: (i) The latter sentence was imposed with specific reference to 3 the former; (ii) the concurrent relationship of the sentences was 4 judicially imposed; and (iii) the concurrent timing of the sentences 5 was not the result of a probation or parole revocation on the former 6 offense.

7 (6) If the present conviction is one of the anticipatory offenses 8 of criminal attempt, solicitation, or conspiracy, count each prior 9 conviction as if the present conviction were for a completed offense. 10 When these convictions are used as criminal history, score them the 11 same as a completed crime.

(7) If the present conviction is for a nonviolent offense and not covered by subsection (11) or (12) of this section, count one point for each adult prior felony conviction and one point for each juvenile prior violent felony conviction and 1/2 point for each juvenile prior nonviolent felony conviction.

(8) If the present conviction is for a violent offense and not covered in subsection (9), (10), (11), or (12) of this section, count two points for each prior adult and juvenile violent felony conviction, one point for each prior adult nonviolent felony conviction, and 1/2 point for each prior juvenile nonviolent felony conviction.

(9) If the present conviction is for a serious violent offense, count three points for prior adult and juvenile convictions for crimes in this category, two points for each prior adult and juvenile violent conviction (not already counted), one point for each prior adult nonviolent felony conviction, and 1/2 point for each prior juvenile nonviolent felony conviction.

(10) If the present conviction is for Burglary 1, count prior convictions as in subsection (8) of this section; however count two points for each prior adult Burglary 2 or residential burglary conviction, and one point for each prior juvenile Burglary 2 or residential burglary conviction.

(11) If the present conviction is for a felony traffic offense count two points for each adult or juvenile prior conviction for Vehicular Homicide or Vehicular Assault; for each felony offense count one point for each adult and 1/2 point for each juvenile prior conviction; for each serious traffic offense, other than those used for an enhancement pursuant to RCW 46.61.520(2), count one point for each adult and 1/2 point for each juvenile prior conviction.

1 (12) If the present conviction is for a drug offense count three 2 points for each adult prior felony drug offense conviction and two 3 points for each juvenile drug offense. All other adult and juvenile 4 felonies are scored as in subsection (8) of this section if the current 5 drug offense is violent, or as in subsection (7) of this section if the 6 current drug offense is nonviolent.

7 (13) If the present conviction is for Escape from Community 8 Custody, RCW 72.09.310, count only prior escape convictions in the 9 offender score. Count adult prior escape convictions as one point and 10 juvenile prior escape convictions as 1/2 point.

(14) If the present conviction is for Escape 1, RCW 9A.76.110, or
Escape 2, RCW 9A.76.120, count adult prior convictions as one point and
juvenile prior convictions as 1/2 point.

(15) If the present conviction is for Burglary 2 or residential burglary, count priors as in subsection (7) of this section; however, count two points for each adult and juvenile prior Burglary 1 conviction, two points for each adult prior Burglary 2 or residential burglary conviction, and one point for each juvenile prior Burglary 2 or residential burglary conviction.

(16) If the present conviction is for a sex offense, count priors
as in subsections (7) through (15) of this section; however count three
points for each adult and juvenile prior sex offense conviction.

(17) If the present conviction is for taking a motor vehicle
 without permission, first or second degree, count two points for each
 prior adult and juvenile conviction for this offense.

26 (18) If the present conviction is for an offense committed while 27 the offender was under community placement, add one point.
