- 1 AN ACT Relating to the wrongful practice of law; reenacting and
- 2 amending RCW 9.94A.320; reenacting RCW 2.48.180 and 9.12.010; creating
- 3 a new section; and declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The purpose of this act is to respond to
- 6 State v. Thomas, 103 Wn. App. 800, by reenacting and ranking, without
- 7 changes, legislation relating to the crime of unlawful practice of law,
- 8 enacted as sections 26 and 27, chapter 285, Laws of 1995.
- 9 **Sec. 2.** RCW 2.48.180 and 1995 c 285 s 26 are each reenacted to
- 10 read as follows:
- 11 (1) As used in this section:
- 12 (a) "Legal provider" means an active member in good standing of the
- 13 state bar, and any other person authorized by the Washington state
- 14 supreme court to engage in full or limited practice of law;
- 15 (b) "Nonlawyer" means a person to whom the Washington supreme court
- 16 has granted a limited authorization to practice law but who practices
- 17 law outside that authorization, and a person who is not an active

- 1 member in good standing of the state bar, including persons who are 2 disbarred or suspended from membership;
- 3 (c) "Ownership interest" means the right to control the affairs of 4 a business, or the right to share in the profits of a business, and 5 includes a loan to the business when the interest on the loan is based 6 upon the income of the business or the loan carries more than a 7 commercially reasonable rate of interest.
 - (2) The following constitutes unlawful practice of law:
- 9 (a) A nonlawyer practices law, or holds himself or herself out as 10 entitled to practice law;
- 11 (b) A legal provider holds an investment or ownership interest in 12 a business primarily engaged in the practice of law, knowing that a 13 nonlawyer holds an investment or ownership interest in the business;
- 14 (c) A nonlawyer knowingly holds an investment or ownership interest 15 in a business primarily engaged in the practice of law;
- 16 (d) A legal provider works for a business that is primarily engaged 17 in the practice of law, knowing that a nonlawyer holds an investment or 18 ownership interest in the business; or
- 19 (e) A nonlawyer shares legal fees with a legal provider.
- 20 (3) Unlawful practice of law is a crime. A single violation of 21 this section is a gross misdemeanor. Each subsequent violation, 22 whether alleged in the same or in subsequent prosecutions, is a class 23 C felony.
- 24 (4) Nothing contained in this section affects the power of the 25 courts to grant injunctive or other equitable relief or to punish as 26 for contempt.
- (5) Whenever a legal provider or a person licensed by the state in a business or profession is convicted, enjoined, or found liable for damages or a civil penalty or other equitable relief under this section, the plaintiff's attorney shall provide written notification of the judgment to the appropriate regulatory or disciplinary body or agency.
- 33 (6) A violation of this section is cause for discipline and 34 constitutes unprofessional conduct that could result in any regulatory 35 penalty provided by law, including refusal, revocation, or suspension 36 of a business or professional license, or right or admission to 37 practice. Conduct that constitutes a violation of this section is 38 unprofessional conduct in violation of RCW 18.130.180.

- 1 (7) In a proceeding under this section it is a defense if proven by 2 the defendant by a preponderance of the evidence that, at the time of 3 the offense, the conduct alleged was authorized by the rules of 4 professional conduct or the admission to practice rules, or Washington 5 business and professions licensing statutes or rules.
- 6 (8) Independent of authority granted to the attorney general, the 7 prosecuting attorney may petition the superior court for an injunction 8 against a person who has violated this chapter. Remedies in an 9 injunctive action brought by a prosecuting attorney are limited to an 10 order enjoining, restraining, or preventing the doing of any act or practice that constitutes a violation of this chapter and imposing a 11 civil penalty of up to five thousand dollars for each violation. 12 prevailing party in the action may, in the discretion of the court, 13 recover its reasonable investigative costs and the costs of the action 14 15 including a reasonable attorney's fee. The degree of proof required in an action brought under this subsection is a preponderance of the 16 17 evidence. An action under this subsection must be brought within three years after the violation of this chapter occurred. 18
- 19 **Sec. 3.** RCW 9.12.010 and 1995 c 285 s 27 are each reenacted to 20 read as follows:
- 21 Every person who brings on his or her own behalf, or instigates, incites, or encourages another to bring, any false suit at law or in 22 23 equity in any court of this state, with intent thereby to distress or 24 harass a defendant in the suit, or who serves or sends any paper or 25 document purporting to be or resembling a judicial process, that is not 26 in fact a judicial process, is guilty of a misdemeanor; and in case the person offending is an attorney, he or she may, in addition thereto be 27 28 disbarred from practicing law within this state.
