- 1 AN ACT Relating to eliminating the exclusivity of gill net gear in
- 2 certain waters; amending RCW 77.50.010; creating a new section; and
- 3 providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that the economic
- 6 well-being and stability of the fishing industry and the conservation
- 7 of the food fish resources of the state of Washington are best served
- 8 by providing managers with all available tools to stabilize and
- 9 distribute the commercial harvest of targeted Puget Sound salmon
- 10 stocks. In recent years, segments of the industry in cooperation with
- 11 the department of fish and wildlife have funded studies examining
- 12 modification of harvest practices and fishing gear, particularly purse
- 13 seine gear, to minimize or avoid impacts on nontargeted Puget Sound
- 14 salmon stocks.
- The legislature finds that the new Pacific salmon treaty agreement
- 16 of 1999 will drastically reduce the commercial harvest of Fraser river
- 17 sockeye salmon while likely providing increased harvest opportunities
- 18 in areas of Puget Sound where only gill net gear is now authorized.
- 19 This exclusive limitation is contrary to the long-term needs of the

- 1 fishing industry and inconsistent with the legislature's intent to
- 2 stabilize harvest levels while selectively targeting healthy salmon
- 3 stocks.

- 4 **Sec. 2.** RCW 77.50.010 and 1998 c 190 s 75 are each amended to read 5 as follows:
- 6 (1) The commission may authorize commercial fishing for sockeye 7 salmon within the waters described in subsection (2) of this section 8 only during the period June 10th to July 25th and for other salmon only 9 from the second Monday of September through November 30th, except 10 during the hours between 4:00 p.m. of Friday and 4:00 p.m. of the 11 following Sunday.
- 12 (2) All waters east and south of a line commencing at a concrete monument on Angeles Point in Clallam county near the mouth of the Elwha 13 14 River on which is inscribed "Angeles Point Monument" (latitude 481 9' 3" north, longitude 1231 33' 01" west of Greenwich Meridian); thence 15 running east on a line 811 30' true across the flashlight and bell buoy 16 off Partridge Point and thence continued to longitude 1221 40' west; 17 18 thence north to the southerly shore of Sinclair Island; thence along 19 the southerly shore of the island to the most easterly point of the island; thence 46½ true to Carter Point, the most southerly point of 20 Lummi Island; thence northwesterly along the westerly shore line of 21 22 Lummi Island to where the shore line intersects line of longitude 1221 23 40' west; thence north to the mainland, including: The southerly 24 portion of Hale Passage, Bellingham Bay, Padilla Bay, Fidalgo Bay, 25 Guemes Channel, Skagit Bay, Similk Bay, Saratoga Passage, Holmes Harbor, Possession Sound, Admiralty Inlet, Hood Canal, Puget Sound, and 26 their inlets, passages, waters, waterways, and tributaries. 27
  - (3) The commission may authorize commercial fishing for salmon with gill net, purse seine, and other lawful gear prior to the second Monday in September within the waters of Hale Passage, Bellingham Bay, Samish Bay, Padilla Bay, Fidalgo Bay, Guemes Channel, Skagit Bay, and Similk Bay, to wit: Those waters northerly and easterly of a line commencing at Stanwood, thence along the south shore of Skagit Bay to Rocky Point on Camano Island; thence northerly to Polnell Point on Whidbey Island.
- 35 (4) Whenever the commission determines that a stock or run of 36 salmon cannot be harvested in the usual manner, and that the stock or 37 run of salmon may be in danger of being wasted and surplus to natural 38 or artificial spawning requirements, the commission may authorize units

- of gill net and purse seine gear in any number or equivalents, by time and area, to fully utilize the harvestable portions of these salmon runs for the economic well being of the citizens of this state. Gill net and purse seine gear other than emergency and test gear authorized by the director shall not be used in Lake Washington.
- 6 (5) The commission may authorize commercial fishing for pink salmon in each odd-numbered year from August 1st through September 1st in the 8 waters lying inside of a line commencing at the most easterly point of 9 Dungeness Spit and thence projected to Point Partridge on Whidbey 10 Island and a line commencing at Olele Point and thence projected easterly to Bush Point on Whidbey Island.
- NEW SECTION. Sec. 3. Section 2 of this act takes effect July 1, 2002.
