- 1 AN ACT Relating to the authority of the statewide enhanced 911
- 2 program to support the statewide enhanced 911 system; amending RCW
- 3 38.52.540; adding a new section to chapter 38.52 RCW; creating a
- 4 new section; providing an effective date; and declaring an
- 5 emergency.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 NEW SECTION. Sec. 1. The legislature finds that the statewide
- 8 emergency communications network of enhanced 911 telephone
- 9 service, which allows an immediate display of a caller's
- 10 identification and location, has served to further the safety,
- 11 health, and welfare of the state's citizens, and has saved lives.
- 12 The legislature further finds that statewide operation and
- 13 management of the enhanced 911 system will create efficiencies of
- 14 operation and permit greater local control of county 911
- 15 operations, and further that some counties will continue to need
- 16 assistance from the state to maintain minimum enhanced 911 service
- 17 levels.

- 1 **Sec. 2.** RCW 38.52.540 and 1998 c 304 s 14 are each amended to read 2 as follows:
- 3 The enhanced 911 account is created in the state treasury. All
- 4 receipts from the state enhanced 911 excise tax imposed by RCW
- 5 82.14B.030 shall be deposited into the account. Moneys in the
- 6 account shall be used only to help ((implement and)) operate
- 7 enhanced 911 statewide. ((Moneys in the account may be used to
- 8 provide salary assistance on a temporary basis not to exceed three
- 9 years to counties with a population of less than seventy-five
- 10 thousand that need additional resources to cover unfunded costs
- 11 that can be shown to result from handling 911 calls. Moneys in the
- 12 account may be used to assist multicounty regions, including
- 13 ongoing salary assistance for multicounty regions consisting of
- 14 counties with populations of less than seventy-five
- 15 thousand. However,)) Funds shall not be distributed to any county
- 16 that has not imposed the maximum county enhanced 911 taxes allowed
- 17 under RCW 82.14B.030 (1) and (2). The state enhanced 911
- 18 coordinator, with the advice and assistance of the enhanced 911
- 19 advisory committee, shall specify by rule the purposes for which
- 20 moneys may be expended from this account.
- 21 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 38.52
- 22 RCW to read as follows:
- In specifying rules defining the purposes for which moneys may
- 24 be expended, the state enhanced 911 coordinator, with the advice
- 25 and assistance of the enhanced 911 advisory committee, is
- 26 authorized to enter into statewide agreements to improve the
- 27 efficiency of 911 services for all counties and shall consider
- 28 base needs of individual counties for specific
- 29 assistance. Priorities for enhanced 911 funding are: First, to
- 30 assure that 911 dialing is operational statewide; second, to
- 31 assist as necessary to assure that counties can achieve a basic
- 32 service level for 911 operations; and third, to assist counties as
- 33 practicable to acquire items of a capital nature appropriate to
- 34 increasing 911 effectiveness.
- 35 <u>NEW SECTION.</u> **Sec. 4.** This act is necessary for the immediate

- 1 preservation of the public peace, health, or safety, or support of
- 2 the state government and its existing public institutions, and
- 3 takes effect July 1, 2001.
