- 1 AN ACT Relating to authorizing optometrists to use and prescribe
- 2 approved drugs for diagnostic or therapeutic purposes without
- 3 limitation upon the methods of delivery in the practice of optometry;
- 4 and amending RCW 18.53.010, 18.53.140, 69.41.030, and 69.50.101.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 18.53.010 and 1989 c 36 s 1 are each amended to read 7 as follows:
- 8 (1) The practice of optometry is defined as the examination of the
- 9 human eye, the examination and ascertaining any defects of the human
- 10 vision system ((and)), the analysis of the process of vision, and the
- 11 <u>treatment of the human eye and adnexa</u>. The practice of optometry
- 12 ((may)) includes, but is not ((necessarily be)) limited to, the
- 13 following:
- 14 (a) The employment of any objective or subjective means or method,
- 15 including the use of drugs ((topically applied to the eye)), for
- 16 diagnostic and therapeutic purposes by those licensed under this
- 17 chapter and who meet the requirements of subsections (2) and (3) of
- 18 this section, and the use of any diagnostic instruments or devices for
- 19 the examination or analysis of the human vision system, the measurement

of the powers or range of human vision, or the determination of the refractive powers of the human eye or its functions in general; and

- (b) The prescription and fitting of lenses, prisms, therapeutic or refractive contact lenses and the adaption or adjustment of frames and lenses used in connection therewith; and
- (c) The prescription and provision of visual therapy, therapeutic aids, and other optical devices((, and the treatment with topically applied drugs by those licensed under this chapter and who meet the requirements of subsections (2) and (3) of this section)); and
- 10 (d) The ascertainment of the perceptive, neural, muscular, or 11 pathological condition of the visual system; and
  - (e) The adaptation of prosthetic eyes.

- (2)(a) Those persons using drugs for diagnostic purposes in the practice of optometry shall have a minimum of sixty hours of didactic and clinical instruction in general and ocular pharmacology as applied to optometry((, and for therapeutic purposes, an additional minimum of seventy-five hours of didactic and clinical instruction)) established by the board, and certification from an institution of higher learning, accredited by those agencies recognized by the United States office of education or the council on postsecondary accreditation to qualify for certification by the optometry board of Washington to use drugs for diagnostic and therapeutic purposes.
- (b) Those persons using or prescribing topical drugs for therapeutic purposes in the practice of optometry shall be certified under (a) of this subsection, and shall have an additional minimum of seventy-five hours of didactic and clinical instruction as established by the board, and certification from an institution of higher learning, accredited by those agencies recognized by the United States office of education or the council on postsecondary accreditation to qualify for certification by the optometry board of Washington to use drugs for therapeutic purposes.
- (c) Those persons using or prescribing drugs administered orally, by injection, or by any other method of delivery for therapeutic purposes in the practice of optometry shall be certified under (b) of this subsection, and shall have an additional minimum of sixteen hours of didactic and eight hours of clinical instruction as established by the board, and certification from an institution of higher learning, accredited by those agencies recognized by the United States office of education or the council on postsecondary accreditation to qualify for

certification by the optometry board of Washington to use drugs administered orally, by injection, or by any other recognized method of delivery for therapeutic purposes.

- (d) Those persons using drugs administered by injection shall have an additional minimum of ten hours of didactic and clinical instruction as established by the board or have completed an approved course at an institution of higher learning, accredited by those agencies recognized by the United States office of education or the council on postsecondary accreditation.
- 10 <u>(e)</u> Such course or courses shall be the fiscal responsibility of 11 the participating and attending optometrist.
  - (3) The board shall establish a schedule of drugs for diagnostic and treatment purposes limited to the practice of optometry, and no person licensed pursuant to this chapter shall prescribe, dispense, purchase, possess, or administer drugs except as authorized and to the extent permitted by the board.
  - (4) The board shall establish a list of Schedules II through V controlled substances, after consultation with the board of pharmacy, and no person licensed pursuant to this chapter shall use, prescribe, dispense, purchase, possess, or administer these drugs except as authorized and to the extent permitted by the board.
- 22 (a) The board, in consultation with the board of pharmacy, shall
  23 establish, by rule, specific guidelines for the prescription and
  24 administration of drugs by optometrists, so that licensed optometrists
  25 and persons filling their prescriptions have a clear understanding of
  26 which drugs and which dosages or forms are included in the authority
  27 granted by this section.
  - (b) No optometrist shall prescribe, dispense, or administer a controlled substance for more than seven days in treating a particular patient for a single trauma, episode, or condition or for pain associated with or related to such trauma, episode, or condition.
  - (c) The prescription or administration of drugs as authorized in this section is specifically limited to those drugs appropriate to treatment of diseases or conditions of the human eye and the adnexa that are within the scope of practice of optometry. The prescription or administration of drugs for any other purpose is not authorized by this section.

- 1 (5) The board shall develop a means of identification and 2 verification of optometrists certified to use therapeutic drugs for the 3 purpose of issuing prescriptions as authorized by this section.
- 4 (6) No optometrist may administer any diagnostic or therapeutic 5 drug by intravitreal injection.
- (7) Nothing in this chapter shall be construed to authorize retinal repair surgery or laser in situ keratomileusis surgery; nor the use, prescription, dispensing, purchase, possession, or administration of any Schedule I controlled substance. The provisions of this subsection
- 10 <u>shall be strictly construed.</u>
- 11 **Sec. 2.** RCW 18.53.140 and 1991 c 3 s 138 are each amended to read 12 as follows:
- 13 It shall be unlawful for any person:
- 14 (1) To sell or barter, or offer to sell or barter any license 15 issued by the secretary; or
- 16 (2) To purchase or procure by barter any license with the intent to 17 use the same as evidence of the holder's qualification to practice 18 optometry; or
- 19 (3) To alter with fraudulent intent in any material regard such 20 license; or
- 21 (4) To use or attempt to use any such license which has been 22 purchased, fraudulently issued, counterfeited or materially altered as 23 a valid license; or

- (8) To use drugs in the practice of optometry, except ((those topically applied for diagnostic or therapeutic purposes)) as authorized under RCW 18.53.010; or
- (9) To use advertising whether printed, radio, display, or of any other nature, which is misleading or inaccurate in any material particular, nor shall any such person in any way misrepresent any goods or services (including but without limitation, its use, trademark, grade, quality, size, origin, substance, character, nature, finish, material, content, or preparation) or credit terms, values, policies, services, or the nature or form of the business conducted; or
- (10) To advertise the "free examination of eyes," "free consultation," "consultation without obligation," "free advice," or any words or phrases of similar import which convey the impression to the public that eyes are examined free or of a character tending to deceive or mislead the public, or in the nature of "bait advertising;" or
  - (11) To use an advertisement of a frame or mounting which is not truthful in describing the frame or mounting and all its component parts. Or advertise a frame or mounting at a price, unless it shall be depicted in the advertisement without lenses inserted, and in addition the advertisement must contain a statement immediately following, or adjacent to the advertised price, that the price is for frame or mounting only, and does not include lenses, eye examination and professional services, which statement shall appear in type as large as that used for the price, or advertise lenses or complete glasses, viz.: frame or mounting with lenses included, at a price either alone or in conjunction with professional services; or
- 30 (12) To use advertising, whether printed, radio, display, or of any 31 other nature, which inaccurately lays claim to a policy or continuing 32 practice of generally underselling competitors; or
- 33 (13) To use advertising, whether printed, radio, display or of any 34 other nature which refers inaccurately in any material particular to 35 any competitors or their goods, prices, values, credit terms, policies 36 or services; or
- 37 (14) To use advertising whether printed, radio, display, or of any 38 other nature, which states any definite amount of money as "down

- 8 (1) a practitioner authorized to prescribe (or, by the 9 practitioner's authorized agent); or
- 10 (2) the patient or research subject at the direction and in the 11 presence of the practitioner.
- (b) "Agent" means an authorized person who acts on behalf of or at the direction of a manufacturer, distributor, or dispenser. It does not include a common or contract carrier, public warehouseperson, or employee of the carrier or warehouseperson.
- 16 (c) "Board" means the state board of pharmacy.
- 17 (d) "Controlled substance" means a drug, substance, or immediate 18 precursor included in Schedules I through V as set forth in federal or 19 state laws, or federal or board rules.
- (e)(1) "Controlled substance analog" means a substance the chemical structure of which is substantially similar to the chemical structure of a controlled substance in Schedule I or II and:

The term does not include the preparation, compounding, packaging, repackaging, labeling, or relabeling of a controlled 14 15 substance:

The term does not include, 21 22 unless specifically designated as controlled under RCW 69.50.201, the 23 dextrorotatory isomer of 3-methoxy-n-methylmorphinan and its salts 24 (dextromethorphan). The term includes the racemic and levorotatory 25 forms of dextromethorphan.
- 26 (t) "Opium poppy" means the plant of the species Papaver somniferum 27 L., except its seeds.
- (u) "Person" means individual, corporation, business trust, estate, trust, partnership, association, joint venture, government, governmental subdivision or agency, or any other legal or commercial entity.
- (v) "Poppy straw" means all parts, except the seeds, of the opium poppy, after mowing.
  - (w) "Practitioner" means:
- 35 (1) A physician under chapter 18.71 RCW, a physician assistant 36 under chapter 18.71A RCW, an osteopathic physician and surgeon under 37 chapter 18.57 RCW, an optometrist licensed under chapter 18.53 RCW who 38 is certified by the optometry board under RCW 18.53.010 subject to any 39 limitations in RCW 18.53.010, a dentist under chapter 18.32 RCW, a

- 19 (x) "Prescription" means an order for controlled substances issued 20 by a practitioner duly authorized by law or rule in the state of 21 Washington to prescribe controlled substances within the scope of his 22 or her professional practice for a legitimate medical purpose.
- (y) "Production" includes the manufacturing, planting, cultivating, growing, or harvesting of a controlled substance.
- 25 (z) "Secretary" means the secretary of health or the secretary's designee.
- 27 (aa) "State," unless the context otherwise requires, means a state 28 of the United States, the District of Columbia, the Commonwealth of 29 Puerto Rico, or a territory or insular possession subject to the 30 jurisdiction of the United States.

- (bb) "Ultimate user" means an individual who lawfully possesses a controlled substance for the individual's own use or for the use of a member of the individual's household or for administering to an animal owned by the individual or by a member of the individual's household.
- (cc) "Electronic communication of prescription information" means the communication of prescription information by computer, or the transmission of an exact visual image of a prescription by facsimile, or other electronic means for original prescription information or prescription refill information for a Schedule III-V controlled

- 1 substance between an authorized practitioner and a pharmacy or the
- 2 transfer of prescription information for a controlled substance from
