AN ACT Relating to possession of ammonia; amending RCW 69.55.010, 69.55.020, and 69.55.030; reenacting and amending RCW 9.94A.515; prescribing penalties; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 69.55.010 and 2000 c 225 s 1 are each amended to read 6 as follows:

7 (1) A person who, with intent to deprive the owner or owner's
8 agent, wrongfully obtains ((anhydrous)) pressurized ammonia gas, is
9 guilty of theft of ((anhydrous)) ammonia.

10 (2) Theft of ((anhydrous)) ammonia is a class C felony.

11 **Sec. 2.** RCW 69.55.020 and 2000 c 225 s 2 are each amended to read 12 as follows:

13 is guilty of the crime of unlawful storage of A person 14 ((anhydrous)) ammonia if the person possesses ((anhydrous)), 15 transports, or delivers pressurized ammonia gas in a container that (1) 16 is not approved by the United States department of transportation to 17 hold ((anhydrous)) ammonia, or (2) was not constructed to meet state

and federal industrial health and safety standards for holding
 ((anhydrous)) ammonia. Violation of this section is a class C felony.
 This section does not apply to public employees or private
 contractors authorized to clean up and dispose of hazardous waste or
 toxic substances under chapter 70.105 or 70.105D RCW.

6 **Sec. 3.** RCW 69.55.030 and 2000 c 225 s 3 are each amended to read 7 as follows:

8 Any damages arising out of the unlawful possession of, storage of, 9 tampering with ((anhydrous)) pressurized ammonia or qas or ((anhydrous)) pressurized ammonia gas equipment shall be the sole 10 responsibility of the unlawful possessor, storer, or tamperer. In no 11 12 case shall liability for damages arising out of the unlawful possession of, storage of, or tampering with ((anhydrous)) pressurized ammonia gas 13 14 or ((anhydrous)) pressurized ammonia gas equipment extend to the lawful 15 owner, installer, maintainer, designer, manufacturer, possessor, or 16 seller of the ((anhydrous)) pressurized ammonia gas or ((anhydrous)) pressurized ammonia gas equipment, unless such damages arise out of the 17 18 owner, installer, maintainer, designer, manufacturer, possessor, or 19 seller's acts or omissions that constitute negligent misconduct to abide by the laws regarding ((anhydrous)) pressurized ammonia gas 20 21 possession and storage.
