- AN ACT Relating to possession of ephedrine, pseudoephedrine, and ammonia; amending RCW 69.50.440, 9.94A.605, and 26.44.200; reenacting and amending RCW 9.94A.515; prescribing penalties; and declaring an
- 4 emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 69.50.440 and 2000 c 225 s 4 are each amended to read 7 as follows:
- 8 It is unlawful for any person to possess ephedrine or any of its
- 9 <u>salts or isomers</u>, pseudoephedrine <u>or any of its salts or isomers</u>, or
- 10 ((anhydrous)) pressurized ammonia gas with intent to manufacture
- 11 methamphetamine. Any person who violates this section is guilty of a
- 12 crime and may be imprisoned for not more than ten years, fined not more
- 13 than twenty-five thousand dollars, or both. Three thousand dollars of
- 14 the fine may not be suspended. As collected, the first three thousand
- 15 dollars of the fine must be deposited with the law enforcement agency
- 16 having responsibility for cleanup of laboratories, sites, or substances
- 17 used in the manufacture of the methamphetamine. The fine moneys
- 18 deposited with that law enforcement agency must be used for such clean-
- 19 up cost.

- 18 immediately.
