# PROVISIONS NECESSARY TO IMPLEMENT APPROPRIATIONS

2 **Sec. 601.** RCW 47.60.010 and 1984 c 18 s 1 are each amended to read as follows:

4 The department is authorized to acquire by lease, charter, 5 contract, purchase, condemnation, or construction, and partly by any or all of such means, and to thereafter operate, improve, and extend, a 6 7 system of ferries on and crossing Puget Sound and any of its tributary 8 waters and connections thereof, and connecting with the public streets 9 and highways in the state. The system of ferries shall include such boats, vessels, wharves, docks, approaches, landings, franchises, 10 licenses, and appurtenances as shall be determined by the department to 11 12 be necessary or desirable for efficient operation of the ferry system and best serve the public. The department may in like manner acquire 13 by purchase, condemnation, or construction and include in the ferry 14 15 system such toll bridges, approaches, and connecting roadways as may be 16 deemed by the department advantageous in channeling traffic to points 17 served by the ferry system. In addition to the powers of acquisition 18 granted by this section, the department is empowered to enter into any 19 contracts, agreements, or leases with any person, firm, or corporation 20 and to thereby provide, on such terms and conditions as it shall determine, for the operation of any ferry or ferries or system thereof, 21 22 whether acquired by the department or not.

23 The authority of the department to <u>lease or</u> sell and <u>to</u> lease back 24 any state ferry, for federal tax purposes only, as authorized by 26 25 U.S.C., Sec. 168(f)(8), or by any other sections of the <u>United States</u> 26 <u>Internal Revenue Code</u>, is confirmed. Legal title and all incidents of 27 legal title to any ferry <u>leased</u>, sold, and leased back (except for the 28 federal tax benefits attributable to the ownership thereof) shall 29 remain in the state of Washington.
