- 2 tax for employment of persons in the WorkFirst program; and adding a
- 3 new section to chapter 82.04 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.04 RCW 6 to read as follows:
- 7 (1) In computing tax under this chapter, a credit is authorized for
- 8 each person equal to ten percent of amounts paid for employment during
- 9 the first six months of employment to employees who were participating
- 10 in the WorkFirst program on the date of hire. To be eligible to take
- 11 the credit, the person claiming the credit shall obtain documentation
- 12 of the employee's participation in the WorkFirst program from the
- 13 appropriate state agency.
- 14 (2) The credit shall be taken against taxes due for the same
- 15 calendar year in which the amounts for which credit is claimed were
- 16 paid. A credit must be claimed by the due date of the last tax return

- 1 for the calendar year in which the payment is made. No credit may be
- 2 carried back or forward to a different calendar year.
