- AN ACT Relating to death certificates; and amending RCW 70.58.107.
- 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 3 **Sec. 1.** RCW 70.58.107 and 1997 c 223 s 1 are each amended to read 4 as follows:
- 5 (1) The department of health shall charge a fee of thirteen dollars 6 for certified copies of records and for copies or information provided
- 7 for research, statistical, or administrative purposes, and eight
- 8 dollars for a search of the files or records when no copy is made. The
- 9 department shall ((prescribe by regulation)) adopt by rule fees to be
- 10 paid for preparing sealed files and for opening sealed files.
- 11 (2) No fee may be demanded or required for furnishing certified
- 12 copies of a birth, death, fetal death, marriage, divorce, annulment, or
- 13 legal separation record for use in connection with a claim for
- 14 compensation or pension pending before the veterans administration.
- 15 (3) The department shall keep a true and correct account of all
- 16 fees received and turn the fees over to the state treasurer on a weekly
- 17 basis.
- 18 (4) Local registrars shall charge the same fees as the state as
- 19 ((hereinabove)) provided in subsection (1) of this section and as

- prescribed by <u>the</u> department ((<u>regulation</u>)) <u>by rule</u>, except that local registrars shall charge thirteen dollars for the first copy of a death certificate and eight dollars for each additional copy of the same death certificate when the additional copies are ordered at the same time as the first copy. All such fees collected, except for five dollars of each fee for the issuance of a certified copy, shall be paid to the jurisdictional health department.
  - (5) All local registrars in cities and counties shall keep a true and correct account of all fees received under this section for the issuance of certified copies and shall turn five dollars of the fee over to the state treasurer on or before the first day of January, April, July, and October.
- 13 <u>(6)</u> Five dollars of each fee imposed for the issuance of certified 14 copies, except for copies suitable for display issued under RCW 15 70.58.085, at both the state and local levels shall be held by the 16 state treasurer in the death investigations' account established by RCW 17 43.79.445.
- (7) The department and all local registrars in cities and counties 18 19 must charge a surcharge of one dollar for each fee imposed for certified copies of records and for copies or information provided for 20 research, statistical, or administrative purposes, or for a search of 21 the files or records when no copy is made. All the revenue generated 22 through this surcharge must be transmitted to the state treasurer on or 23 24 before the first day of January, April, July, and October. The state treasurer must distribute these funds to the department of health's 25 center for health statistics, for the sole purpose of implementing a 26 web-based electronic death certificate registration system. The web-27 28 based electronic death certificate registration system must include a function that automatically provides county auditors and the secretary 29 30 of state with the death certificate information in order to allow those entities to update their voter registration records. The surcharge 31 imposed under this subsection expires July 1, 2006. 32
