18 ~~following general election if the voter so indicates in his or her~~
19 ~~request. For any out of state voter, overseas voter, or service voter,~~
20 ~~a request for an absentee ballot for a primary election shall also be~~
21 ~~honored as a request for an absentee ballot for the following general~~
22 ~~election.~~

23 ~~(3) A voter admitted to a hospital no earlier than five days before~~
24 ~~a primary or election and confined to the hospital on election day may~~
25 ~~apply by messenger for an absentee ballot on the day of the primary or~~
26 ~~election if a signed statement from the hospital administrator, or~~
27 ~~designee, verifying the voter's date of admission and status as a~~
28 ~~patient in the hospital on the day of the primary or election is~~
29 ~~attached to the voter's written application for an absentee ballot.~~

30 ~~(4) In a voter's request for an absentee ballot, the voter shall~~
31 ~~state the address to which the absentee ballot should be sent. A~~
32 ~~request for an absentee ballot from an out of state voter, overseas~~
33 ~~voter, or service voter shall state the address of that elector's last~~
34 ~~residence for voting purposes in the state of Washington and either a~~
35 ~~written application or the oath on the return envelope shall include a~~
36 ~~declaration of the other qualifications of the applicant as an elector~~
37 ~~of this state. A request for an absentee ballot from any other voter~~
38 ~~shall state the address at which that voter is currently registered to~~

1 vote in the state of Washington or the county auditor shall verify such
2 information from the voter registration records of the county.

3 (5) A request for an absentee ballot from a registered voter who is
4 within this state shall be made directly to the auditor of the county
5 in which the voter is registered. An absentee ballot request from a
6 registered voter who is temporarily outside this state or from an out-
7 of-state voter, overseas voter, or service voter may be made either to
8 the appropriate county auditor or to the secretary of state, who shall
9 promptly forward the request to the appropriate county auditor. No
10 person, organization, or association may distribute absentee ballot
11 applications within this state that contain any return address other
12 than that of the appropriate county auditor.

13 (6) A person may request an absentee ballot for use by the person
14 as a registered voter and may request an absentee ballot on behalf of
15 any member of that person's immediate family who is a registered voter
16 for use by the family member. As a means of ensuring that a person who
17 requests an absentee ballot is requesting the ballot for only that
18 person or a member of the person's immediate family, the secretary of
19 state shall adopt rules prescribing the circumstances under which an
20 auditor: May require a person who requests an absentee ballot to
21 identify the date of birth of the voter for whom the ballot is
22 requested; and may deny a request which is not accompanied by this
23 information.))

24 NEW SECTION. **Sec. 2.** A new section is added to chapter 29.36 RCW
25 to read as follows:

26 REQUEST FOR SINGLE ABSENTEE BALLOT. (1) Except as otherwise
27 provided by law, a registered voter or out-of-state voter, overseas
28 voter, or service voter desiring to cast an absentee ballot at a single
29 election or primary must request the absentee ballot from his or her
30 county auditor no earlier than ninety days nor later than the day
31 before the election or primary at which the person seeks to vote.
32 Except as otherwise provided by law, the request may be made orally in
33 person, by telephone, electronically, or in writing. An application or
34 request for an absentee ballot made under the authority of a federal
35 statute or regulation will be considered and given the same effect as
36 a request for an absentee ballot under this chapter.

37 (2) A voter requesting an absentee ballot for a primary may also
38 request an absentee ballot for the following general election. A

1 request by an out-of-state voter, overseas voter, or service voter for
2 an absentee ballot for a primary election will be considered as a
3 request for an absentee ballot for the following general election.

4 (3) In requesting an absentee ballot, the voter shall state the
5 address to which the absentee ballot should be sent. A request for an
6 absentee ballot from an out-of-state voter, overseas voter, or service
7 voter must include the address of the last residence in the state of
8 Washington and either a written application or the oath on the return
9 envelope must include a declaration of the other qualifications of the
10 applicant as an elector of this state. A request for an absentee
11 ballot from any other voter must state the address at which that voter
12 is currently registered to vote in the state of Washington or the
13 county auditor shall verify that information from the voter
14 registration records of the county.

15 (4) A request for an absentee ballot from a registered voter who is
16 within this state must be made directly to the auditor of the county in
17 which the voter is registered. An absentee ballot request from a
18 registered voter who is temporarily outside this state or from an out-
19 of-state voter, overseas voter, or service voter may be made either to
20 the appropriate county auditor or to the secretary of state, who shall
21 promptly forward the request to the appropriate county auditor. No
22 person, organization, or association may distribute absentee ballot
23 applications within this state that contain a return address other than
24 that of the appropriate county auditor.

25 NEW SECTION. **Sec. 3.** A new section is added to chapter 29.36 RCW
26 to read as follows:

27 **REQUESTING ABSENTEE BALLOT FOR FAMILY MEMBER.** A member of a
28 registered voter's family may request an absentee ballot on behalf of
29 and for use by the voter. As a means of ensuring that a person who
30 requests an absentee ballot is requesting the ballot for only that
31 person or a member of the person's immediate family, an auditor may
32 require a person who requests an absentee ballot to identify the date
33 of birth of the voter for whom the ballot is requested and deny a
34 request that is not accompanied by this information.

35 **Sec. 4.** RCW 29.36.013 and 1999 c 298 s 12 are each amended to read
36 as follows:

1 REQUEST FOR ONGOING ABSENTEE VOTER STATUS. Any registered voter
2 may apply, in writing, for status as an ongoing absentee voter. Each
3 qualified applicant shall automatically receive an absentee ballot for
4 each ensuing election or primary for which ~~((he or she))~~ the voter is
5 entitled to vote and need not submit a separate request for each
6 election. Ballots received from ongoing absentee voters shall be
7 validated, processed, and tabulated in the same manner as other
8 absentee ballots.

9 Status as an ongoing absentee voter shall be terminated upon any of
10 the following events:

- 11 (1) The written request of the voter;
- 12 (2) The death or disqualification of the voter;
- 13 (3) The cancellation of the voter's registration record;
- 14 (4) The return of an ongoing absentee ballot as undeliverable; or
- 15 (5) Upon placing a voter on inactive status under RCW 29.10.071.

16 **Sec. 5.** RCW 29.36.170 and 1991 c 81 s 35 are each amended to read
17 as follows:

18 SPECIAL ABSENTEE BALLOT. (1) As provided in this section, county
19 auditors shall provide special absentee ballots to be used for state
20 primary or state general elections. An auditor shall provide a special
21 absentee ballot ~~((shall))~~ only ~~((be provided))~~ to a registered voter
22 who completes an application stating that(~~+~~

23 ~~(a) The voter believes that she or he will be residing or stationed~~
24 ~~or working outside the continental United States; and~~

25 ~~(b) The voter believes that))~~ she or he will be unable to vote and
26 return a regular absentee ballot by normal mail delivery within the
27 period provided for regular absentee ballots.

28 The application for a special absentee ballot may not be filed
29 earlier than ninety days before the applicable state primary or general
30 election. The special absentee ballot ~~((shall))~~ will list the offices
31 and measures, if known, scheduled to appear on the state primary or
32 general election ballot. The voter may use the special absentee ballot
33 to write in the name of any eligible candidate for each office and vote
34 on any measure.

35 (2) With any special absentee ballot issued under this section, the
36 county auditor shall include a listing of any candidates who have filed
37 before the time of the application for offices that will appear on the

1 ballot at that primary or election and a list of any issues that have
2 been referred to the ballot before the time of the application.

3 (3) Write-in votes on special absentee ballots (~~shall~~) must be
4 counted in the same manner provided by law for the counting of other
5 write-in votes. The county auditor shall process and canvass the
6 special absentee ballots provided under this section in the same manner
7 as other absentee ballots under chapters 29.36 and 29.62 RCW.

8 (4) A voter who requests a special absentee ballot under this
9 section may also request an absentee ballot under (~~RCW 29.36.010~~)
10 section 2(4) of this act. If the regular absentee ballot is properly
11 voted and returned, the special absentee ballot (~~shall be deemed~~) is
12 void, and the county auditor shall reject it in whole when special
13 absentee ballots are canvassed.

14 **Sec. 6.** RCW 29.36.030 and 1991 c 81 s 31 are each amended to read
15 as follows:

16 ISSUANCE OF ABSENTEE BALLOT. (1) The county auditor shall issue an
17 absentee ballot for the primary or election for which it was requested,
18 or for the next occurring primary or election when ongoing absentee
19 status has been requested if the information contained in a request for
20 an absentee ballot or ongoing absentee status received by the county
21 auditor is complete and correct and the applicant is qualified to vote
22 under federal or state law(~~, the county auditor shall issue an~~
23 absentee ballot for the primary or election for which the absentee
24 ballot was requested)). Otherwise, the county auditor shall notify the
25 applicant of the reason or reasons why the request cannot be accepted.
26 Whenever two or more candidates have filed for the position of precinct
27 committee officer for the same party in the same precinct at a general
28 election held in an even-numbered year, the contest for that position
29 must be presented to absentee voters from that precinct by either
30 including the contest on the regular absentee ballot or a separate
31 absentee ballot. The ballot must provide space designated for writing
32 in the name of additional candidates.

33 (~~At each general election in an even-numbered year, each absentee~~
34 ~~voter shall also be given a separate ballot containing the names of the~~
35 ~~candidates that have filed for the office of precinct committee officer~~
36 ~~unless fewer than two candidates have filed for the same political~~
37 ~~party in the absentee voter's precinct. The ballot shall provide space~~
38 ~~for writing in the name of additional candidates.~~

1 ~~When mailing an absentee ballot to a registered voter temporarily~~
2 ~~outside the state or to an out-of-state voter, overseas voter, or~~
3 ~~service voter, the county auditor shall send a)) (2) A registered voter~~
4 may obtain a replacement ballot if the ballot is destroyed, spoiled,
5 lost, or not received by the voter. The voter may obtain the ballot by
6 telephone request, by mail, electronically, or in person. The county
7 auditor shall keep a record of each replacement ballot provided under
8 this subsection.

9 (3) A copy of the state voters' and candidates' pamphlet must be
10 sent to registered voters temporarily outside the state, out-of-state
11 voters, overseas voters, and service voters along with the absentee
12 ballot if such a pamphlet has been prepared for the primary or election
13 and is available to the county auditor at the time of mailing. The
14 county auditor shall mail all absentee ballots and related material to
15 voters outside the territorial limits of the United States and the
16 District of Columbia under 39 U.S.C. 3406.

17 **Sec. 7.** RCW 29.36.035 and 1984 c 27 s 2 are each amended to read
18 as follows:

19 DELIVERY OF ABSENTEE BALLOT. The delivery of an absentee ballot
20 for any primary or election shall be subject to the following
21 qualifications:

22 (1) Only the registered voter~~((, himself))~~ personally, or a member
23 of ~~((his))~~ the registered voter's immediate family may pick up an
24 absentee ballot for the voter at the office of the issuing officer
25 unless the voter is ~~((hospitalized))~~ a resident of a health care
26 facility, as defined by RCW 70.37.020(3), on election day and applies
27 by messenger ~~((in accordance with RCW 29.36.010))~~ for an absentee
28 ballot ~~((on the day of the primary or election))~~. In this latter case,
29 the messenger may pick up the ~~((hospitalized))~~ voter's absentee ballot.

30 (2) Except as noted in subsection (1) ~~((above))~~ of this section,
31 the issuing officer shall mail or deliver the absentee ballot directly
32 to each applicant.

33 ~~((3) No absentee ballot shall be issued on the day of the primary~~
34 ~~or election concerned, except as provided by RCW 29.36.010, for a voter~~
35 ~~confined to a hospital on the day of a primary or election.))~~

36 **Sec. 8.** RCW 29.36.045 and 1987 c 346 s 12 are each amended to read
37 as follows:

1 ENVELOPES AND INSTRUCTIONS. The county auditor shall send each
2 absentee voter a ballot, a security envelope in which to seal the
3 ballot after voting, a larger envelope in which to return the security
4 envelope, and instructions on how to mark the ballot and how to return
5 it to the county auditor. The larger return envelope (~~shall~~) must
6 contain a declaration by the absentee voter reciting his or her
7 qualifications and stating that he or she has not voted in any other
8 jurisdiction at this election, together with a summary of the penalties
9 for any violation of any of the provisions of this chapter. The return
10 envelope (~~shall~~) must provide space for the voter to indicate the
11 date on which the ballot was voted and for the voter to sign the oath.
12 A summary of the applicable penalty provisions of this chapter
13 (~~shall~~) must be printed on the return envelope immediately adjacent
14 to the space for the voter's signature. The signature of the voter on
15 the return envelope (~~shall~~) must affirm and attest to the statements
16 regarding the qualifications of that voter and to the validity of the
17 ballot. For out-of-state voters, overseas voters, and service voters,
18 the signed declaration on the return envelope constitutes the
19 equivalent of a voter registration for the election or primary for
20 which the ballot has been issued. The voter (~~shall~~) must be
21 instructed to either return the ballot to the county auditor by whom it
22 was issued or attach sufficient first class postage, if applicable, and
23 mail the ballot to the appropriate county auditor no later than the day
24 of the election or primary for which the ballot was issued.

25 If the county auditor chooses to forward absentee ballots, he or
26 she must include with the ballot a clear explanation of the
27 qualifications necessary to vote in that election and must also advise
28 a voter with questions about his or her eligibility to contact the
29 county auditor. This explanation may be provided on the ballot
30 envelope, on an enclosed insert, or printed directly on the ballot
31 itself. If the information is not included, the envelope must clearly
32 indicate that the ballot is not to be forwarded and that return postage
33 is guaranteed.

34 NEW SECTION. Sec. 9. A new section is added to chapter 29.36 RCW
35 to read as follows:

36 OBSERVERS. County auditors must request that observers be
37 appointed by the major political parties to be present during the
38 processing of absentee ballots. The absence of the observers will not

1 prevent the processing of absentee ballots if the county auditor has
2 requested their presence.

3 **Sec. 10.** RCW 29.36.060 and 1991 c 81 s 32 are each amended to read
4 as follows:

5 PROCESSING ABSENTEE BALLOTS. (1) The opening and subsequent
6 processing of return envelopes for any primary or election may begin on
7 or after the tenth day (~~(prior to such)~~) before the primary or
8 election. The (~~(opening of the security envelopes and)~~) tabulation of
9 absentee ballots (~~(shall)~~) must not commence until after 8:00
10 (~~(o'clock)~~) p.m. on the day of the primary or election.

11 (2) After opening the return envelopes, the county canvassing board
12 shall place all of the ballots (~~(envelopes in containers that can be~~
13 ~~secured with numbered seals. These sealed containers shall be stored)~~)
14 in ((a)) secure (~~(location)~~) storage until after 8:00 (~~(o'clock)~~) p.m.
15 of the day of the primary or election. Absentee ballots that are to be
16 tabulated on an electronic vote tallying system may be taken from the
17 inner envelopes and all the normal procedural steps may be performed to
18 prepare these ballots for tabulation (~~(before sealing the containers)~~).

19 (3) Before opening a returned absentee ballot, the canvassing
20 board, or its designated representatives, shall examine the postmark,
21 statement, and signature on ((each)) the return envelope ((containing))
22 that contains the security envelope and absentee ballot. They shall
23 verify that the voter's signature on the return envelope is the same as
24 the signature of that voter in the registration files ((for that
25 ~~voter)) of the county. For ((absentee)) registered voters ((other than
26 ~~out-of-state voters, overseas voters, and service voters, if the~~
27 postmark is illegible)) casting absentee ballots, the date on the
28 return envelope to which the voter ((attests shall)) has attested
29 determines the validity, as to the time of voting((, of)) for that
30 absentee ballot ((under this chapter)) if the postmark is missing or is
31 illegible. For out-of-state voters, overseas voters, and service
32 voters, the date on the return envelope to which the voter has attested
33 determines the validity as to the time of voting for that absentee
34 ballot. For any absentee ((voter)) ballot, a variation between the
35 signature of the voter on the return envelope and the signature of that
36 voter in the registration files due to the substitution of initials or
37 the use of common nicknames is permitted so long as the surname and
38 handwriting are clearly the same.~~

1 **Sec. 11.** RCW 29.36.070 and 1990 c 262 s 2 are each amended to read
2 as follows:

3 COUNTING ABSENTEE BALLOTS. The absentee ballots (~~((shall be grouped~~
4 ~~and counted by))~~) must be reported at a minimum on a congressional and
5 legislative district ((without regard to)) basis. Absentee ballots may
6 be counted by congressional or legislative district or by individual
7 precinct, except as required under RCW 29.62.090(2).

8 These returns (~~((shall))~~) must be added to the total of the votes
9 cast at the polling places.

10 **Sec. 12.** RCW 29.36.075 and 1988 c 181 s 3 are each amended to read
11 as follows:

12 CREDIT FOR VOTING. (~~((In counties that do not tabulate absentee~~
13 ~~ballots on electronic vote tallying systems, canvassing boards may not~~
14 ~~tabulate or record votes cast by absentee ballots on any uncontested~~
15 ~~office except write in votes for candidates for the office of precinct~~
16 ~~committeeperson who have filed valid declarations of candidacy under~~
17 ~~RCW 29.04.180. "Uncontested office" means an office where only one~~
18 ~~candidate has filed a valid declaration of candidacy either during the~~
19 ~~regular filing period or as a write in candidate under RCW 29.04.180.))~~)

20 Each registered voter casting an absentee ballot (~~((shall))~~) will be
21 credited with voting on his or her voter registration record.
22 Absentee ballots (~~((shall))~~) must be retained for the same length of time
23 and in the same manner as ballots cast at the precinct polling places.

24 **Sec. 13.** RCW 29.36.100 and 1987 c 346 s 18 are each amended to
25 read as follows:

26 CHALLENGED ABSENTEE BALLOTS. The qualifications of any absentee
27 voter may be challenged at the time the signature on the return
28 envelope is verified and the ballot is processed by the canvassing
29 board. The board has the authority to determine the legality of any
30 absentee ballot challenged under this section. Challenged ballots must
31 be handled in accordance with chapter 29.10 RCW.

32 **Sec. 14.** RCW 29.36.160 and 1994 c 269 s 2 are each amended to read
33 as follows:

34 PENALTY. A person who willfully violates any provision of this
35 chapter regarding the assertion or declaration of qualifications to
36 receive or cast an absentee ballot(~~((7))~~) or unlawfully casts a vote by

1 absentee ballot(~~(, or willfully violates any provision regarding the~~
2 ~~conduct of mail ballot primaries or elections under RCW 29.36.120~~
3 ~~through 29.36.139))~~ is guilty of a class C felony punishable under RCW
4 9A.20.021. Except as provided in chapter 29.85 RCW a person who
5 willfully violates any other provision of this chapter is guilty of a
6 misdemeanor.

12 ~~or special,))~~ The county auditor may(~~(, in))~~ designate any precinct
13 having fewer than two hundred active registered voters at the time of
14 closing of voter registration as provided in RCW 29.07.160(~~(, conduct~~
15 ~~the voting in that precinct by))~~ as a mail ballot precinct. (~~(For any~~
16 ~~precinct having fewer than two hundred active registered voters where~~
17 ~~voting at a primary or a general election is conducted by mail ballot,~~
18 ~~the county auditor shall, not less than fifteen days prior to the date~~
19 ~~of that primary or general election, mail or deliver to each active and~~
20 ~~inactive registered voter within that precinct a notice that the voting~~
21 ~~in that precinct will be by mail ballot, an application form for a mail~~
22 ~~ballot, and a postage prepaid envelope, preaddressed to the issuing~~
23 ~~officer. A mail ballot shall be issued to each voter who returns a~~
24 ~~properly executed application to the county auditor no later than the~~

33 not be counted. Nothing in this section may be construed as altering
