- 1 AN ACT Relating to restoring sex offender registration for
- 2 nonfelony communication with a minor convictions; reenacting and
- 3 amending RCW 9A.44.130; creating a new section; and declaring an
- 4 emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 Sec. 1. RCW 9A.44.130 and 2001 c 169 s 1 and 2001 c 95 s 2 are 7 each reenacted and amended to read as follows:
- 8 (1) Any adult or juvenile residing whether or not the person has a
- 9 fixed residence, or who is a student, is employed, or carries on a
- 10 vocation in this state who has been found to have committed or has been
- 11 convicted of any sex offense or kidnapping offense, or who has been
- 12 found not guilty by reason of insanity under chapter 10.77 RCW of
- 13 committing any sex offense or kidnapping offense, shall register with
- 14 the county sheriff for the county of the person's residence, or if the
- 15 person is not a resident of Washington, the county of the person's
- 16 school, or place of employment or vocation, or as otherwise specified
- 17 in this section. Where a person required to register under this
- 18 section is in custody of the state department of corrections, the state
- 19 department of social and health services, a local division of youth

services, or a local jail or juvenile detention facility as a result of 2 a sex offense or kidnapping offense, the person shall also register at the time of release from custody with an official designated by the 3 4 agency that has jurisdiction over the person. In addition, any such 5 adult or juvenile who is admitted to a public or private institution of higher education shall, within ten days of enrolling or by the first 6 7 business day after arriving at the institution, whichever is earlier, 8 notify the sheriff for the county of the person's residence of the 9 person's intent to attend the institution. Persons required to 10 register under this section who are enrolled in a public or private institution of higher education on June 11, 1998, must notify the 11 county sheriff immediately. The sheriff shall notify the institution's 12 13 department of public safety and shall provide that department with the same information provided to a county sheriff under subsection (3) of 14 15 this section.

- (2) This section may not be construed to confer any powers pursuant to RCW 4.24.500 upon the public safety department of any public or private institution of higher education.
- 19 (3)(a) The person shall provide the following information when 20 registering: (i) Name; (ii) address; (iii) date and place of birth; 21 (iv) place of employment; (v) crime for which convicted; (vi) date and 22 place of conviction; (vii) aliases used; (viii) social security number; 23 (ix) photograph; and (x) fingerprints.
 - (b) Any person who lacks a fixed residence shall provide the following information when registering: (i) Name; (ii) date and place of birth; (iii) place of employment; (iv) crime for which convicted; (v) date and place of conviction; (vi) aliases used; (vii) social security number; (viii) photograph; (ix) fingerprints; and (x) where he or she plans to stay.
- (4)(a) Offenders shall register with the county sheriff within the following deadlines. For purposes of this section the term "conviction" refers to adult convictions and juvenile adjudications for sex offenses or kidnapping offenses:
- (i) OFFENDERS IN CUSTODY. (A) Sex offenders who committed a sex offense on, before, or after February 28, 1990, and who, on or after July 28, 1991, are in custody, as a result of that offense, of the state department of corrections, the state department of social and health services, a local division of youth services, or a local jail or juvenile detention facility, and (B) kidnapping offenders who on or

after July 27, 1997, are in custody of the state department of corrections, the state department of social and health services, a 2 local division of youth services, or a local jail or juvenile detention 3 4 facility, must register at the time of release from custody with an official designated by the agency that has jurisdiction over the 5 offender. The agency shall within three days forward the registration 6 7 information to the county sheriff for the county of the offender's 8 anticipated residence. The offender must also register within twenty-9 four hours from the time of release with the county sheriff for the 10 county of the person's residence, or if the person is not a resident of Washington, the county of the person's school, or place of employment 11 or vocation. The agency that has jurisdiction over the offender shall 12 13 provide notice to the offender of the duty to register. Failure to register at the time of release and within twenty-four hours of release 14 15 constitutes a violation of this section and is punishable as provided 16 in subsection (10) of this section.

When the agency with jurisdiction intends to release an offender with a duty to register under this section, and the agency has knowledge that the offender is eligible for developmental disability services from the department of social and health services, the agency shall notify the division of developmental disabilities of the release. Notice shall occur not more than thirty days before the offender is to be released. The agency and the division shall assist the offender in meeting the initial registration requirement under this section. Failure to provide such assistance shall not constitute a defense for any violation of this section.

27 OFFENDERS NOT IN CUSTODY UNDER STATE (ii) BUT OR LOCAL JURISDICTION. Sex offenders who, on July 28, 1991, are not in custody but are under the jurisdiction of the indeterminate sentence review board or under the department of correction's active supervision, as defined by the department of corrections, the state department of social and health services, or a local division of youth services, for 32 sex offenses committed before, on, or after February 28, 1990, must 33 register within ten days of July 28, 1991. Kidnapping offenders who, on July 27, 1997, are not in custody but are under the jurisdiction of the indeterminate sentence review board or under the department of 36 37 correction's active supervision, as defined by the department of corrections, the state department of social and health services, or a 38 39 local division of youth services, for kidnapping offenses committed

before, on, or after July 27, 1997, must register within ten days of July 27, 1997. A change in supervision status of a sex offender who was required to register under this subsection (4)(a)(ii) as of July 28, 1991, or a kidnapping offender required to register as of July 27, 1997, shall not relieve the offender of the duty to register or to

reregister following a change in residence. The obligation to register

shall only cease pursuant to RCW 9A.44.140. (iii) OFFENDERS UNDER FEDERAL JURISDICTION. Sex offenders who, on or after July 23, 1995, and kidnapping offenders who, on or after July 27, 1997, as a result of that offense are in the custody of the United States bureau of prisons or other federal or military correctional agency for sex offenses committed before, on, or after February 28, 1990, or kidnapping offenses committed on, before, or after July 27, 1997, must register within twenty-four hours from the time of release with the county sheriff for the county of the person's residence, or if the person is not a resident of Washington, the county of the person's school, or place of employment or vocation. Sex offenders who, on July 23, 1995, are not in custody but are under the jurisdiction of the United States bureau of prisons, United States courts, United States parole commission, or military parole board for sex offenses committed before, on, or after February 28, 1990, must register within ten days of July 23, 1995. Kidnapping offenders who, on July 27, 1997, are not in custody but are under the jurisdiction of the United States bureau of prisons, United States courts, United States parole commission, or military parole board for kidnapping offenses committed before, on, or after July 27, 1997, must register within ten days of July 27, 1997. A change in supervision status of a sex offender who was required to register under this subsection (4)(a)(iii) as of July 23, 1995, or a kidnapping offender required to register as of July 27, 1997 shall not relieve the offender of the duty to register or to reregister following a change in residence, or if the person is not a resident of Washington, the county of the person's school, or place of employment or vocation. The obligation to register shall only cease pursuant to

(iv) OFFENDERS WHO ARE CONVICTED BUT NOT CONFINED. Sex offenders who are convicted of a sex offense on or after July 28, 1991, for a sex offense that was committed on or after February 28, 1990, and kidnapping offenders who are convicted on or after July 27, 1997, for a kidnapping offense that was committed on or after July 27, 1997, but

4 (v) OFFENDERS WHO ARE NEW RESIDENTS OR RETURNING WASHINGTON Sex offenders and kidnapping offenders who move to 5 RESIDENTS. Washington state from another state or a foreign country that are not 6 7 under the jurisdiction of the state department of corrections, the 8 indeterminate sentence review board, or the state department of social 9 and health services at the time of moving to Washington, must register 10 within thirty days of establishing residence or reestablishing residence if the person is a former Washington resident. 11 register under this subsection applies to sex offenders convicted under 12 13 the laws of another state or a foreign country, federal or military statutes, or Washington state for offenses committed on or after 14 15 February 28, 1990, and to kidnapping offenders convicted under the laws 16 of another state or a foreign country, federal or military statutes, or 17 Washington state for offenses committed on or after July 27, 1997. Sex offenders and kidnapping offenders from other states or a foreign 18 19 country who, when they move to Washington, are under the jurisdiction of the department of corrections, the indeterminate sentence review 20 board, or the department of social and health services must register 21 within twenty-four hours of moving to Washington. The agency that has 22 jurisdiction over the offender shall notify the offender of the 23 24 registration requirements before the offender moves to Washington.

25 (vi) OFFENDERS FOUND NOT GUILTY BY REASON OF INSANITY. Any adult 26 or juvenile who has been found not guilty by reason of insanity under 27 chapter 10.77 RCW of (A) committing a sex offense on, before, or after February 28, 1990, and who, on or after July 23, 1995, is in custody, 28 29 as a result of that finding, of the state department of social and 30 health services, or (B) committing a kidnapping offense on, before, or 31 after July 27, 1997, and who on or after July 27, 1997, is in custody, as a result of that finding, of the state department of social and 32 33 health services, must register within twenty-four hours from the time 34 of release with the county sheriff for the county of the person's 35 residence. The state department of social and health services shall provide notice to the adult or juvenile in its custody of the duty to 36 37 Any adult or juvenile who has been found not guilty by register. reason of insanity of committing a sex offense on, before, or after 38 39 February 28, 1990, but who was released before July 23, 1995, or any

- 20 the supervision of the department shall register in the county of their

- 22 (ix) OFFENDERS WHO MOVE TO, WORK, CARRY ON A VOCATION, OR ATTEND
- 23 SCHOOL IN ANOTHER STATE. Offenders required to register in Washington,
- 24 who move to another state, or who work, carry on a vocation, or attend
- 25 school in another state shall register a new address, fingerprints, and
- 26 photograph with the new state within ten days after establishing
- 27 residence, or after beginning to work, carry on a vocation, or attend
- 28 school in the new state. The person must also send written notice
- 29 within ten days of moving to the new state or to a foreign country to
- 30 the county sheriff with whom the person last registered in Washington
- 31 state. The county sheriff shall promptly forward this information to
- 32 the Washington state patrol.
- 33 (b) Failure to register within the time required under this section
- 34 constitutes a per se violation of this section and is punishable as
- 35 provided in subsection (10) of this section. The county sheriff shall
- 36 not be required to determine whether the person is living within the
- 37 county.
- 38 (c) An arrest on charges of failure to register, service of an
- 39 information, or a complaint for a violation of this section, or

arraignment on charges for a violation of this section, constitutes actual notice of the duty to register. Any person charged with the 2 crime of failure to register under this section who asserts as a 3 4 defense the lack of notice of the duty to register shall register immediately following actual notice of the duty through arrest, 5 service, or arraignment. Failure to register as required under this 6 7 subsection (4)(c) constitutes grounds for filing another charge of 8 failing to register. Registering following arrest, service, or 9 arraignment on charges shall not relieve the offender from criminal 10 liability for failure to register prior to the filing of the original 11 charge.

- 12 (d) The deadlines for the duty to register under this section do 13 not relieve any sex offender of the duty to register under this section 14 as it existed prior to July 28, 1991.
- 15 (5)(a) If any person required to register pursuant to this section 16 changes his or her residence address within the same county, the person 17 must send written notice of the change of address to the county sheriff within seventy-two hours of moving. If any person required to register 18 19 pursuant to this section moves to a new county, the person must send 20 written notice of the change of address at least fourteen days before moving to the county sheriff in the new county of residence and must 21 register with that county sheriff within twenty-four hours of moving. 22 The person must also send written notice within ten days of the change 23 24 of address in the new county to the county sheriff with whom the person 25 last registered. The county sheriff with whom the person last 26 registered shall promptly forward the information concerning the change of address to the county sheriff for the county of the person's new 27 residence. Upon receipt of notice of change of address to a new state, 28 29 the county sheriff shall promptly forward the information regarding the 30 change of address to the agency designated by the new state as the 31 state's offender registration agency.
 - (b) It is an affirmative defense to a charge that the person failed to send a notice at least fourteen days in advance of moving as required under (a) of this subsection that the person did not know the location of his or her new residence at least fourteen days before moving. The defendant must establish the defense by a preponderance of the evidence and, to prevail on the defense, must also prove by a preponderance that the defendant sent the required notice within twenty-four hours of determining the new address.

- (6)(a) Any person required to register under this section who lacks 1 2 a fixed residence shall provide written notice to the sheriff of the county where he or she last registered within forty-eight hours 3 4 excluding weekends and holidays after ceasing to have a fixed The notice shall include the information required by 5 subsection (3)(b) of this section, except the photograph and 6 7 fingerprints. The county sheriff may, for reasonable cause, require 8 the offender to provide a photograph and fingerprints. The sheriff 9 shall forward this information to the sheriff of the county in which the person intends to reside, if the person intends to reside in 10 11 another county.
 - (b) A person who lacks a fixed residence must report weekly, in person, to the sheriff of the county where he or she is registered. The weekly report shall be on a day specified by the county sheriff's office, and shall occur during normal business hours. The county sheriff's office may require the person to list the locations where the person has stayed during the last seven days. The lack of a fixed residence is a factor that may be considered in determining an offender's risk level and shall make the offender subject to disclosure of information to the public at large pursuant to RCW 4.24.550.
 - (c) If any person required to register pursuant to this section does not have a fixed residence, it is an affirmative defense to the charge of failure to register, that he or she provided written notice to the sheriff of the county where he or she last registered within forty-eight hours excluding weekends and holidays after ceasing to have a fixed residence and has subsequently complied with the requirements of subsections (4)(a)(vii) or (viii) and (6) of this section. To prevail, the person must prove the defense by a preponderance of the evidence.
- 30 (7) A sex offender subject to registration requirements under this 31 section who applies to change his or her name under RCW 4.24.130 or any other law shall submit a copy of the application to the county sheriff 32 of the county of the person's residence and to the state patrol not 33 34 fewer than five days before the entry of an order granting the name 35 change. No sex offender under the requirement to register under this section at the time of application shall be granted an order changing 36 37 his or her name if the court finds that doing so will interfere with legitimate law enforcement interests, except that no order shall be 38 39 denied when the name change is requested for religious or legitimate

- 1 (d) "Student" means a person who is enrolled, on a full-time or 2 part-time basis, in any public or private educational institution. An 3 educational institution includes any secondary school, trade or 4 professional institution, or institution of higher education.
- 5 (10) A person who knowingly fails to register with the county sheriff or notify the county sheriff, or who changes his or her name 6 7 without notifying the county sheriff and the state patrol, as required 8 by this section is guilty of a class C felony if the crime for which 9 the individual was convicted was a felony sex offense as defined in subsection (9)(a) of this section or a federal or out-of-state 10 conviction for an offense that under the laws of this state would be a 11 felony sex offense as defined in subsection (9)(a) of this section. If 12 the crime was other than a felony or a federal or out-of-state 13 conviction for an offense that under the laws of this state would be 14 15 other than a felony, violation of this section is a gross misdemeanor.
 - (11) A person who knowingly fails to register or who moves within the state without notifying the county sheriff as required by this section is guilty of a class C felony if the crime for which the individual was convicted was a felony kidnapping offense as defined in subsection (9)(b) of this section or a federal or out-of-state conviction for an offense that under the laws of this state would be a felony kidnapping offense as defined in subsection (9)(b) of this section. If the crime was other than a felony or a federal or out-of-state conviction for an offense that under the laws of this state would be other than a felony, violation of this section is a gross misdemeanor.
- NEW SECTION. Sec. 2. This act applies to all persons convicted of communication with a minor either on, before, or after July 1, 2001, unless otherwise relieved of the duty to register under RCW 9A.44.140.
- NEW SECTION. **Sec. 3.** If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.
- NEW SECTION. Sec. 4. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the
