- 6 <u>NEW SECTION.</u> **Sec. 1.** The department of social and health services
- 7 serves parents and children with multiple needs, which cannot be
- 8 resolved in isolation. Further, the complexity of service delivery
- 9 systems is a barrier for families in crisis when a child is removed or
- 10 a parent is removed from the home. The department must undertake
- 11 efforts to streamline the delivery of services.
- 12 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 13.34 RCW
- 13 to read as follows:
- 14 The department of social and health services shall develop methods
- 15 for coordination of services to parents and children in child
- 16 dependency cases. To the maximum extent possible under current funding
- 17 levels, the department must:

- 1 (1) Coordinate and integrate services to children and families, 2 using service plans and activities that address the children's and 3 families' multiple needs. Assessment criteria should screen for 4 multiple needs;
- 5 (2) Develop treatment plans for the individual needs of the client 6 in a manner that minimizes the number of contacts the client is 7 required to make; and
- 8 (3) Access training for department staff to increase skills across 9 disciplines to assess needs for mental health, substance abuse, 10 developmental disabilities, and other areas.
