- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 41.26.110 and 2003 c 30 s 3 are each amended to read 5 as follows:
  - (1) All claims for disability shall be acted upon and either approved or disapproved by either type of disability board authorized to be created in this section.
  - (a) Each city having a population of twenty thousand or more shall establish a disability board having jurisdiction over all members employed by those cities and composed of the following five members: Two members of the city legislative body to be appointed by the mayor; one active or retired fire fighter employed by or retired from the city to be elected by the fire fighters employed by or retired from the city who are subject to the jurisdiction of the board; one active or retired law enforcement officer employed by or retired from the city to be elected by the law enforcement officers employed by or retired from the city who are subject to the jurisdiction of the board; and one member from the public at large who resides within the city to be appointed by

the other four members designated in this subsection. Only those 1 2 active or retired fire fighters and law enforcement officers who are subject to the jurisdiction of the board have the right to elect under 3 this section. All fire fighters and law enforcement officers employed 4 by or retired from the city are eligible for election. Each of the 5 elected members shall serve a two year term. The members appointed 6 pursuant to this subsection shall serve for two year terms: 7 That cities of the first class only, shall retain existing firemen's 8 pension boards established pursuant to RCW 41.16.020 and existing 9 10 boards of trustees of the relief and pension fund of the police department as established pursuant to RCW 41.20.010 which such boards 11 12 shall have authority to act upon and approve or disapprove claims for 13 disability by fire fighters or law enforcement officers as provided 14 under the Washington law enforcement officers' and fire fighters' retirement system act. 15

(b) Each county shall establish a disability board having jurisdiction over all members ((residing in the county)) employed by or retired from an employer within the county and not employed by a city in which a disability board is established. The county disability board so created shall be composed of five members to be chosen as One member of the legislative body of the county to be appointed by the county legislative body; one member of a city or town legislative body located within the county which does not contain a city disability board established pursuant to subsection (1)(a) of this section to be chosen by a majority of the mayors of such cities and towns within the county which does not contain a city disability board; one active fire fighter or retired fire fighter employed by or retired from an employer within the county to be elected by the fire fighters employed or retired ((in)) from an employer within the county who are not employed by or retired from a city in which a disability board is established and who are subject to the jurisdiction of ((the)) that board; one law enforcement officer or retired law enforcement officer employed by or retired from an employer within the county to be elected by the law enforcement officers employed in or retired from an employer within the county who are not employed by or retired from a city in which a disability board is established and who are subject to the jurisdiction of ((the)) that board; and one member from the public at large who resides within the county but does not reside within a city

in which a city disability board is established, to be appointed by the 1 other four members designated in this subsection. However, in counties 2 with a population less than sixty thousand, the member of the 3 disability board appointed by a majority of the mayors of the cities 4 and towns within the county that do not contain a city disability board 5 must be a resident of one of the cities and towns but need not be a 6 7 member of a city or town legislative body. Only those active or retired fire fighters and law enforcement officers who are subject to 8 the jurisdiction of the board have the right to elect under this 9 section. All fire fighters and law enforcement officers employed by or 10 retired from an employer within the county who are not employed by or 11 12 retired from a city in which a disability board is established are 13 eligible for election. All members appointed or elected pursuant to 14 this subsection shall serve for two year terms. If there are no fire fighters under the jurisdiction of the board eligible to vote, a second 15 eligible employee representative shall be elected by the law 16 enforcement officers eligible to vote. If there are no law enforcement 17 officers under the jurisdiction of the board eligible to vote, a second 18 eligible representative shall be elected by the fire fighters eligible 19 20 to vote.

(2) The members of both the county and city disability boards shall not receive compensation for their service upon the boards but the members shall be reimbursed by their respective county or city for all expenses incidental to such service as to the amount authorized by law.

- (3) The disability boards authorized for establishment by this section shall perform all functions, exercise all powers, and make all such determinations as specified in this chapter.
- NEW SECTION. Sec. 2. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
