- 5 **Sec. 1.** RCW 82.04.214 and 1994 c 22 s 1 are each amended to read 6 as follows:
- 7 <u>(1)(a) Until June 30, 2011, "newspaper" means:</u>
- 8 <u>(i) A</u> publication issued regularly at stated intervals at least
- 9 twice a month and printed on newsprint in tabloid or broadsheet format
- 10 folded loosely together without stapling, glue, or any other binding of
- 11 any kind, including any supplement of a printed newspaper; and
- 12 (ii) An electronic version of a printed newspaper that:
- 13 (A) Shares content with the printed newspaper; and
- 14 (B) Is prominently identified by the same name as the printed
- 15 newspaper or otherwise conspicuously indicates that it is a complement
- 16 to the printed newspaper.
- (b) For purposes of this section, "supplement" means a printed
- 18 publication, including a magazine or advertising section, that is:
- (i) Labeled and identified as part of the printed newspaper; and

- (A) As an insert or attachment to the printed newspaper; or
- 3 (B) Separate and apart from the printed newspaper so long as the distribution is within the general circulation area of the newspaper.
- 5 (2) Beginning July 1, 2011, "newspaper" means a publication issued 6 regularly at stated intervals at least twice a month and printed on 7 newsprint in tabloid or broadsheet format folded loosely together 8 without stapling, glue, or any other binding of any kind, including any 9 supplement of a printed newspaper as defined in subsection (1)(b) of 10 this section.
