AN ACT Relating to the deposit of public funds with credit unions; adding a new section to chapter 39.58 RCW; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 39.58 RCW 6 to read as follows:

7 Solely for the purpose of receiving public deposits that may total 8 no more than one hundred thousand dollars or the maximum deposit insured by the national credit union share insurance fund, whichever is 9 10 the lesser amount, a credit union is a public depositary and subject to 11 reporting under RCW 39.58.100. The maximum deposit applies to all funds attributable to any one depositor of public funds in any one 12 credit union. A credit union means a state-chartered credit union 13 under chapter 31.12 RCW. A credit union is not a public depositary for 14 15 any other purpose under this chapter, including but not limited to inclusion in the single public depositary pool under RCW 39.58.200. 16
