Helps provide local health jurisdictions with a more stable dedicated funding system by providing a dedicated state revenue stream.

Creates a single account through which all state funding for public health will be distributed.

Eliminates the sales and use tax exemption on candy.

Imposes a tax on the legal sale of marijuana, the proceeds of which will support drug education and awareness.

Imposes a set of rules and laws concerning marijuana comparable to those imposed on alcohol.

Creates the marijuana revolving fund.
