1 AN ACT Relating to creating a funding mechanism to promote
2 innovation at community and technical colleges; amending RCW 28B.15.031
3 and 28B.15.100; adding a new section to chapter 28B.50 RCW; and
4 creating a new section.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** (1) The legislature finds that the community
7 and technical college system mission to ensure affordable access to
8 higher education geographically distributed throughout the state is
9 aligned with innovative approaches to learning and substantial
10 efficiencies that have been implemented since the legislature
11 established the system in 1967. Systemic approaches include a common
12 accounting system, a common administrative computing system, a single
13 system budget request for operating and capital expenses, and common
14 course numbering. Innovative approaches include the system's e-
15 learning platform, the adoption of open educational resources, and the
16 adoption of lecture-capture tools that allow students to replay
17 lectures, review classroom materials, and distribute outstanding
18 instruction via the web anytime, anywhere.

1 (2) It is the intent of the legislature to further enhance the
2 community and technical college system by making the maximum use of
3 technologies to:

4 (a) Help dismantle the barriers of geographic isolation, cost,
5 competing demands of work and family life, and past educational
6 failure;

7 (b) Create a system for learning that is welcoming to all, easy to
8 enter and use, and tailored to the needs of each learner; and

9 (c) Fosters personal relationships and support all students and
10 their families to learn and thrive.

11 **Sec. 2.** RCW 28B.15.031 and 2003 c 232 s 2 are each amended to read
12 as follows:

13 (1) The term "operating fees" as used in this chapter shall include
14 the fees, other than building fees, charged all students registering at
15 the state's colleges and universities but shall not include fees for
16 short courses, self-supporting degree credit programs and courses,
17 marine station work, experimental station work, correspondence or
18 extension courses, and individual instruction and student deposits or
19 rentals, disciplinary and library fines, which colleges and
20 universities shall have the right to impose, laboratory, gymnasium,
21 health, technology and student activity fees, or fees, charges,
22 rentals, and other income derived from any or all revenue producing
23 lands, buildings and facilities of the colleges or universities
24 heretofore or hereafter acquired, constructed or installed, including
25 but not limited to income from rooms, dormitories, dining rooms,
26 hospitals, infirmaries, housing or student activity buildings,
27 vehicular parking facilities, land, or the appurtenances thereon, or
28 such other special fees as may be established by any college or
29 university board of trustees or regents from time to time. All moneys
30 received as operating fees at any institution of higher education shall
31 be deposited in a local account containing only operating fees revenue
32 and related interest: PROVIDED, That a minimum of three and one-half
33 percent of operating fees shall be retained by the institutions for the
34 purposes of RCW 28B.15.820.

35 (2) In addition to the three and one-half percent of operating fees
36 retained by the institutions under subsection (1) of this section,
37 three percent of operating fees charged to students at community and

1 technical colleges shall be transferred to the community and technical
2 college innovation account for the implementation of the college
3 board's strategic technology plan in section 3 of this act.

4 (3) Local operating fee accounts shall not be subject to
5 appropriation by the legislature or allotment procedures under chapter
6 43.88 RCW.

7 NEW SECTION. **Sec. 3.** A new section is added to chapter 28B.50 RCW
8 to read as follows:

9 (1) The community and technical college innovation account is
10 created in the custody of the state treasurer. All receipts from
11 operating fees in RCW 28B.15.031(2) must be deposited into the account.
12 Expenditures from the account may be used only as provided in
13 subsection (2) of this section. Only the director of the college board
14 or the director's designee may authorize expenditures from the account.
15 The account is subject to allotment procedures under chapter 43.88 RCW,
16 but an appropriation is not required for expenditures.

17 (2) Funds in the community and technical college innovation account
18 may be used solely to:

19 (a) Pay and secure the payment of the principal of and interest on
20 financing contracts, such as certificates of participation issued for
21 the innovation account under chapter 39.94 RCW and authorized by the
22 legislature; and

23 (b) Implement the college board's strategic technology plan to
24 improve student achievement, student services, and increase systemwide
25 administrative efficiencies. The college board must approve projects
26 under the strategic technology plan to improve student achievement,
27 student services, and increase systemwide administrative efficiencies
28 before the director authorizes expenditures to be made.

29 **Sec. 4.** RCW 28B.15.100 and 2003 c 232 s 6 are each amended to read
30 as follows:

31 (1) The governing boards of the state universities, the regional
32 universities, The Evergreen State College, and the community colleges
33 shall charge to and collect from each of the students registering at
34 the particular institution for any quarter or semester such tuition
35 fees and services and activities fees, and other fees as such board
36 shall in its discretion determine. For the governing boards of the

1 state universities, the regional universities, and The Evergreen State
2 College, the total of all fees shall be rounded to the nearest whole
3 dollar amount: PROVIDED, That such tuition fees shall be established
4 in accordance with RCW 28B.15.067.

5 (2) Part-time students shall be charged tuition and services and
6 activities fees proportionate to full-time student rates established
7 for residents and nonresidents: PROVIDED, That except for students
8 registered at community colleges, students registered for fewer than
9 two credit hours shall be charged tuition and services and activities
10 fees at the rate established for two credit hours: PROVIDED FURTHER,
11 That, subject to the limitations of RCW 28B.15.910, residents of Idaho
12 or Oregon who are enrolled in community college district number twenty
13 for six or fewer credits during any quarter or semester may be exempted
14 from payment of all or a portion of the nonresident tuition fees
15 differential upon a declaration by the higher education coordinating
16 board that it finds Washington residents from the community college
17 district are afforded substantially equivalent treatment by such other
18 states.

19 (3) Full-time students registered for more than eighteen credit
20 hours shall be charged an additional operating fee for each credit hour
21 in excess of eighteen hours at the applicable established per credit
22 hour tuition fee rate for part-time students: PROVIDED, That, subject
23 to the limitations of RCW 28B.15.910, the governing boards of the state
24 universities and the community colleges may exempt all or a portion of
25 the additional charge, for students who are registered exclusively in
26 first professional programs in medicine, dental medicine, veterinary
27 medicine, doctor of pharmacy, or law, or who are registered exclusively
28 in required courses in vocational preparatory programs.
