(c) The total budget necessary to implement the proposal statewide for fiscal year 2013, including administrative support; and

(d) Possible savings to the state and counties that might result from implementing the proposal.

Subsequent allotment modifications shall not include transfers of moneys between sections of this act except as expressly provided in this act, nor shall allotment modifications permit moneys that are provided solely for a specified purpose to be used for other than that purpose.

(2) The department of social and health services shall not initiate any services that require expenditure of state general fund moneys unless expressly authorized in this act or other law. The department may seek, receive, and spend, under RCW 43.79.260 through 43.79.282, federal moneys not anticipated in this act as long as the federal funding does not require expenditure of state moneys for the program in excess of amounts anticipated in this act. If the department receives unanticipated unrestricted federal moneys, those moneys shall be spent for services authorized in this act or in any other legislation providing appropriation authority, and an equal amount of appropriated state general fund moneys shall lapse. Upon the lapsing of any moneys under this subsection, the office of financial management shall notify the legislative fiscal committees. As used in this subsection, "unrestricted federal moneys" includes block grants and other funds that federal law does not require to be spent on specifically defined projects or matched on a formula basis by state funds.

(3)(a) The health care authority and the department are authorized to develop an integrated health care program designed to slow the progression of illness and disability and better manage medicaid expenditures for the aged and disabled population. Under this Washington medicaid integration partnership (WMIP), the health care authority and the department may combine and transfer such medicaid

1 funds appropriated under sections 204, 206, 208, and 213 of this act as
2 may be necessary to finance a unified health care plan for the WMIP
3 program enrollment. Until January 1, 2013, the WMIP pilot projects

22 integrated care project (ICP), and, if the health care authority and
23 the department determine that it will be feasible to meet federal
24 project design requirements, the project may be expanded to better
25 manage medicaid and medicare expenditures for the aged and disabled
26 population, including dually eligible individuals. The project shall
27 not exceed a combined daily enrollment of 25,000 persons and shall not
28 expand beyond four counties during the 2011-2013 fiscal biennium. The

26 Allocations for certificated instructional staff salaries for the

35 (5) CENTRAL OFFICE ALLOCATIONS

37 In addition to classified and administrative staff units allocated
38 in subsections (3) and (4) of this section, classified and

1 administrative staff units are provided for the 2011-12 and 2012-13
2 school year for the central office administrative costs of operating a
3 school district, at the following rates:

4 (a) The total central office staff units provided in this
5 subsection (5) are calculated by first multiplying the total number of
6 eligible certificated instructional, certificated administrative, and
7 classified staff units providing school-based or district-wide support

9 (b) Of the central office staff units calculated in (a) of this
10 subsection, 74.53 percent are allocated as classified staff units, as
11 generated in subsection (4) of this section, and 25.47 percent shall be

14 (c) Staff units generated as enhancements outside the program of

11 (9) SUBSTITUTE TEACHER ALLOCATIONS

13 costs for classroom teachers is based on four (4) funded substitute

16 (10) ALTERNATIVE LEARNING EXPERIENCE PROGRAM FUNDING

29 than fifty annual average full-time equivalent students and less than
30 one hundred eighty students, operating a grades K-6 program or a grades
31 1-6 program, an additional one-half of a certificated instructional
32 staff unit;

33 (f)(i) For enrollments generating certificated staff unit
34 allocations under (a) through (e) of this subsection, one classified
35 staff unit for each 2.94 certificated staff units allocated under such
36 subsections;

37 (ii) For each nonhigh school district with an enrollment of more

1 than fifty annual average full-time equivalent students and less than
2 one hundred eighty students, an additional one-half of a classified
3 staff unit; and

4 (g) School districts receiving additional staff units to support
5 small student enrollments and remote and necessary plants under
6 subsection (12) of this section shall generate additional MSOC
7 allocations consistent with the nonemployee related costs (NERC)
8 allocation formula in place for the 2010-11 school year as provided
9 section 502, chapter 37, Laws of 2010 1st sp. sess. (2010 supplemental
10 budget), adjusted annually for inflation.

11 (13) Any school district board of directors may petition the
12 superintendent of public instruction by submission of a resolution
13 adopted in a public meeting to reduce or delay any portion of its basic
14 education allocation for any school year. The superintendent of public
15 instruction shall approve such reduction or delay if it does not impair
16 the district's financial condition. Any delay shall not be for more
17 than two school years. Any reduction or delay shall have no impact on
18 levy authority pursuant to RCW 84.52.0531 and local effort assistance

15 allocation. Repayments or advances will be accomplished by a reduction
16 in the school district's apportionment payments on or before June 30th

23 director shall pay by April 30th of each year on game lands in each
24 county, if requested by an election under RCW 77.12.201, an amount in
25 lieu of real property taxes equal to that amount paid on similar
26 parcels of open space land taxable under chapter 84.34 RCW or the
27 greater of seventy cents per acre per year or the amount paid in 1984
28 plus an additional amount for control of noxious weeds equal to that
29 which would be paid if such lands were privately owned. This amount
30 shall not be assessed or paid on department buildings, structures,
31 facilities, game farms, fish hatcheries, tidelands, or public fishing
32 areas of less than one hundred acres.

33 (2) "Game lands," as used in this section and RCW 77.12.201, means
34 those tracts one hundred acres or larger owned in fee by the department
35 and used for wildlife habitat and public recreational purposes. All

1 lands purchased for wildlife habitat, public access or recreation
2 purposes with federal funds in the Snake River drainage basin shall be
3 considered game lands regardless of acreage.

4 (3) This section shall not apply to lands transferred after April
5 23, 1990, to the department from other state agencies.

6 (4) The county shall distribute the amount received under this
7 section in lieu of real property taxes to all property taxing districts
8 except the state in appropriate tax code areas the same way it would
9 distribute local property taxes from private property. The county
10 shall distribute the amount received under this section for weed
11 control to the appropriate weed district.

12 **Sec. 918.** RCW 79.64.020 and 2011 c 216 s 15 are each amended to
13 read as follows:

14 A resource management cost account in the state treasury is created
15 to be used solely for the purpose of defraying the costs and expenses
16 necessarily incurred by the department in managing and administering
17 state lands, community forest trust lands, and aquatic lands and the
18 making and administering of leases, sales, contracts, licenses,
19 permits, easements, and rights-of-way as authorized under the
20 provisions of this title. Appropriations from the resource management
21 cost account to the department shall be expended for no other purposes.
22 Funds in the resource management cost account may be appropriated or
23 transferred by the legislature for the benefit of all of the trusts
24 from which the funds were derived. During the 2011-2013 fiscal
25 biennium, the legislature may transfer from the aquatics revenues in
26 the resources management cost account to the aquatics land enhancement
27 account, such amounts as reflect the excess fund balance in the
28 account.

29 **Sec. 919.** RCW 79.64.040 and 2011 1st sp.s. c 50 s 966 and 2011 c
30 216 s 16 are each reenacted and amended to read as follows:

31 (1) The board shall determine the amount deemed necessary in order
32 to achieve the purposes of this chapter and shall provide by rule for
33 the deduction of this amount from the moneys received from all leases,
34 sales, contracts, licenses, permits, easements, and rights-of-way
35 issued by the department and affecting state lands, community forest

1 trust lands, and aquatic lands, provided that no deduction shall be
2 made from the proceeds from agricultural college lands.

3 (2) Moneys received as deposits from successful bidders, advance
4 payments, and security under RCW 79.15.100, 79.15.080, and 79.11.150
5 prior to December 1, 1981, which have not been subjected to deduction
6 under this section are not subject to deduction under this section.

7 (3) Except as otherwise provided in subsections (4) and (6) of this
8 section, the deductions authorized under this section shall not exceed
9 twenty-five percent of the moneys received by the department in
10 connection with any one transaction pertaining to state lands and
11 aquatic lands other than second-class tide and shore lands and the beds
12 of navigable waters, and fifty percent of the moneys received by the
13 department pertaining to second-class tide and shore lands and the beds
14 of navigable waters.

15 (4) Deductions authorized under this section for transactions
16 pertaining to community forest trust lands must be established at a
17 level sufficient to defray over time the management costs for
18 activities prescribed in a parcel's management plan adopted pursuant to
19 RCW 79.155.080, and, if deemed appropriate by the board consistent with
20 RCW 79.155.090, to reimburse the state and any local entities' eligible
21 financial contributions for acquisition of the parcel.

22 (5) In the event that the department sells logs using the contract
23 harvesting process described in RCW 79.15.500 through 79.15.530, the
24 moneys received subject to this section are the net proceeds from the
25 contract harvesting sale.

26 (6) During the (~~2009-2011~~) 2011-2013 fiscal biennium (~~and fiscal~~
27 ~~year 2012~~), the twenty-five percent limitation on deductions set in
28 subsection (3) of this section may be increased up to thirty percent by
29 the board.

30 **Sec. 920.** RCW 79.64.100 and 2003 c 334 s 219 are each amended to
31 read as follows:

32 There is created a forest development account in the state
33 treasury. The state treasurer shall keep an account of all sums
34 deposited therein and expended or withdrawn therefrom. Any sums placed
35 in the forest development account shall be pledged for the purpose of
36 paying interest and principal on the bonds issued by the department
37 under RCW 79.22.080 and 79.22.090 and the provisions of this chapter,

1 and for the purchase of land for growing timber. Any bonds issued
2 shall constitute a first and prior claim and lien against the account
3 for the payment of principal and interest. No sums for the above
4 purposes shall be withdrawn or paid out of the account except upon
5 approval of the department.

6 Appropriations may be made by the legislature from the forest
7 development account to the department for the purpose of carrying on
8 the activities of the department on state forest lands, lands managed
9 on a sustained yield basis as provided for in RCW 79.10.320, and for
10 reimbursement of expenditures that have been made or may be made from
11 the resource management cost account in the management of state forest
12 lands. For the 2011-2013 fiscal biennium, moneys from the forest
13 development account shall be distributed as directed in section 709 of
14 this act to the beneficiaries of the revenues derived from state forest
15 lands. During the 2011-2013 fiscal biennium, the legislature may
16 appropriate moneys in the forest development account to support
17 emergency fire suppression activities in a manner that, at a maximum,
18 represents the proportion of land that the department manages in
19 comparison to the total land the department conducts emergency fire
20 suppression activities on.

21 **Sec. 921.** RCW 79.70.130 and 2005 c 303 s 11 are each amended to
22 read as follows:

23 The state treasurer, on behalf of the department and with the
24 exception of fiscal year 2013, must distribute to counties for all
25 lands acquired for the purposes of this chapter an amount in lieu of
26 real property taxes equal to the amount of tax that would be due if the
27 land were taxable as open space land under chapter 84.34 RCW except
28 taxes levied for any state purpose, plus an additional amount equal to

6 real property taxes equal to the amount of tax that would be due if the
7 land were taxable as open space land under chapter 84.34 RCW except

9 the amount of weed control assessment that would be due if such lands
10 were privately owned. The county assessor and county legislative
11 authority shall assist in determining the appropriate calculation of

21 79.64.040 and payments to towns under RCW 79.115.150(2), all moneys
22 received by the state from the sale or lease of state-owned aquatic
23 lands and from the sale of valuable material from state-owned aquatic
24 lands shall be deposited in the aquatic lands enhancement account which
25 is hereby created in the state treasury. After appropriation, these
26 funds shall be used solely for aquatic lands enhancement projects; for
27 the purchase, improvement, or protection of aquatic lands for public
28 purposes; for providing and improving access to the lands; and for
29 volunteer cooperative fish and game projects. During the ((2009-2011
30 and)) 2011-2013 fiscal ((~~biennia~~)) biennium, the aquatic lands
31 enhancement account may also be used for scientific research as part of
32 the adaptive management process and for developing a planning report
33 for McNeil Island. During the ((2009-2011-and)) 2011-2013 fiscal
34 ((~~biennia~~)) biennium, the legislature may transfer from the aquatic
35 lands enhancement account to the state general fund such amounts as
36 reflect excess fund balance of the account. During the 2011-2013
37 fiscal biennium, the aquatic lands enhancement account may be used to

1 support the shellfish program, (~~the ballast water program,~~) native
2 fish recovery program, fish production, aquatic invasive species
3 monitoring and control program, and the Puget Sound toxic sampling
4 program at the department of fish and wildlife, and the knotweed
5 program at the department of agriculture.

6 (2) In providing grants for aquatic lands enhancement projects, the
7 recreation and conservation funding board shall:

8 (a) Require grant recipients to incorporate the environmental
9 benefits of the project into their grant applications;

10 (b) Utilize the statement of environmental benefits, consideration,
11 except as provided in RCW 79.105.610, of whether the applicant is a
12 Puget Sound partner, as defined in RCW 90.71.010, whether a project is
13 referenced in the action agenda developed by the Puget Sound
14 partnership under RCW 90.71.310, and except as otherwise provided in
15 RCW 79.105.630, and effective one calendar year following the
16 development and statewide availability of model evergreen community
17 management plans and ordinances under RCW 35.105.050, whether the
18 applicant is an entity that has been recognized, and what gradation of
19 recognition was received, in the evergreen community recognition
20 program created in RCW 35.105.030 in its prioritization and selection
21 process; and

22 (c) Develop appropriate outcome-focused performance measures to be
23 used both for management and performance assessment of the grants.

24 (3) To the extent possible, the department should coordinate its
25 performance measure system with other natural resource-related agencies
26 as defined in RCW 43.41.270.

27 (4) The department shall consult with affected interest groups in
28 implementing this section.

29 (5) After January 1, 2010, any project designed to address the
30 restoration of Puget Sound may be funded under this chapter only if the
31 project is not in conflict with the action agenda developed by the
32 Puget Sound partnership under RCW 90.71.310.

33 **Sec. 924.** RCW 80.01.080 and 2010 1st sp.s. c 37 s 950 are each
34 amended to read as follows:

35 There is created in the state treasury a public service revolving
36 fund. Regulatory fees payable by all types of public service companies
37 shall be deposited to the credit of the public service revolving fund.

1 Except for expenses payable out of the pipeline safety account, all
2 expense of operation of the Washington utilities and transportation
3 commission shall be payable out of the public service revolving fund.

4 During the (~~2009-2011~~) 2011-2013 fiscal biennium, the legislature
5 may transfer from the public service revolving fund to the state
6 general fund such amounts as reflect the excess fund balance of the
7 fund.

8 **Sec. 925.** 2010 c 23 s 205 (uncodified) is amended to read as
9 follows:

10 (1) The legislature finds that this state's tax policy with respect
11 to the taxation of transactions between affiliated entities and the
12 income derived from such transactions (intercompany transactions) has
13 motivated some taxpayers to engage in transactions designed solely or
14 primarily to minimize the tax effects of intercompany transactions.
15 The legislature further finds that some intercompany transactions
16 result from taxpayers that are required to establish affiliated
17 entities to comply with regulatory mandates and that transactions
18 between such affiliates effectively increases the tax burden in this
19 state on the affiliated group of entities.

20 (2) Therefore, as existing resources allow, the department of
21 revenue is directed to conduct a review of the state's tax policy with
22 respect to the taxation of intercompany transactions. The review must
23 include the impacts of such transactions under the state's business and
24 occupation tax and state and local sales and use taxes. The department
25 may include other taxes in the review as it deems appropriate.

26 (3) In conducting the review, the department must examine how this
27 state's tax policy compares to the tax policy of other states with
28 respect to the taxation of intercompany transactions. The department's
29 review must include an analysis of potential alternatives to the
30 current policy of taxing intercompany transactions, including their
31 estimated revenue impacts if practicable.

32 (4) In conducting this review, the department may seek input from
33 members of the business community and others as it deems appropriate.

34 (5) The department must report its findings to the fiscal
35 committees of the house of representatives and senate by December 1,
36 2010. However, if the department has not completed its review by

1 December 1, 2010, the department must provide the fiscal committees of
2 the legislature with a brief status report by December 1, 2010, and the
3 final report by December 1, (~~2011~~) 2012.

4 NEW SECTION. **Sec. 926.** It is the intent of the legislature that
5 regulatory agencies receiving appropriations in this act work with the
6 office of regulatory assistance to:

7 (1) Establish a small business liaison team to assist small

10 actions that could have been discovered and noted in the original

22 NEW SECTION. **Sec. 927.** A new section is added to 2011 1st sp.s.
23 c 50 (uncodified) to read as follows:

24 Chapter 50, Laws of 2011 1st sp. sess. (the biennial operating
25 budget) included funding for the pension system cost of legislation
26 adopted during the 2011 session of the legislature. No supplemental
27 rates are authorized for funding that legislation during the remainder
28 of the 2011-2013 fiscal biennium. Pension contribution rates for the
29 public employees' retirement system, the public safety employees'
30 retirement system, the school employees' retirement systems, and the
31 teachers' retirement system are established.

32 (1) For the public employees' retirement system:

33 (a) Beginning April 1, 2012, an employer contribution rate of 7.08
34 percent shall be charged;

35 (b) Beginning July 1, 2012, an employer contribution rate of 7.21
36 percent shall be charged.

1 (2) For the public safety employees' retirement system:
2 (a) Beginning April 1, 2012, an employer contribution rate of 8.74
3 percent shall be charged;

4 (b) Beginning July 1, 2012, an employer contribution rate of 8.87
5 percent shall be charged.

6 (3) For the school employees' retirement system:
7 (a) Beginning April 1, 2012, an employer contribution rate of 7.58
8 percent shall be charged;

9 (b) Beginning September 1, 2012, an employer contribution rate of
10 7.59 percent shall be charged.

11 (4) For the teachers' retirement system:
12 (a) Beginning April 1, 2012, an employer contribution rate of 8.04
13 percent shall be charged; and

14 (b) Beginning September 21, 2012, an employer contribution rate of
15 8.05 percent shall be charged.

16 These rates are inclusive of a department of retirement systems
17 expense charge of 0.16 percent. The department of retirement systems
18 shall collect employee contributions as provided in chapter 41.45 RCW.

19 NEW SECTION. **Sec. 928.** If any provision of this act or its
20 application to any person or circumstance is held invalid, the
21 remainder of the act or the application of the provision to other
22 persons or circumstances is not affected.

23 NEW SECTION. **Sec. 929.** This act is necessary for the immediate
24 preservation of the public peace, health, or safety, or support of the
25 state government and its existing public institutions, and takes effect
26 immediately.
