1 AN ACT Relating to special parking privileges for persons with  
2 disabilities; amending RCW 46.19.010, 46.19.020, 46.19.030, 46.19.050,  
3 46.61.582, 46.61.583, and 46.63.020; creating a new section;  
4 prescribing penalties; and providing an effective date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** (1) The legislature finds that there is a  
7 history of abuse of special parking privileges for persons with  
8 disabilities that requires changes to maintain public safety and good  
9 order.

10 (2) It is the intent of the legislature to: (a) Decrease the  
11 amount of unlawful use of special parking privileges for persons with  
12 disabilities; (b) not create additional burdens for those in need of  
13 special parking privileges for persons with disabilities; (c) provide  
14 local jurisdictions with the authority to improve their administration  
15 of on-street parking; (d) encourage the department of licensing to  
16 implement the recommendations of the disabled parking work group in  
17 regards to placard and application changes; and (e) encourage the  
18 department of licensing to consider parking information system upgrades

1 related to special parking privileges for persons with disabilities in  
2 its pursuit of technology modernization.

3 **Sec. 2.** RCW 46.19.010 and 2011 c 96 s 32 are each amended to read  
4 as follows:

5 (1) A natural person who has a disability that meets one of the  
6 following criteria may apply for special parking privileges:

7 (a) Cannot walk two hundred feet without stopping to rest;

8 (b) Is severely limited in ability to walk due to arthritic,  
9 neurological, or orthopedic condition;

10 (c) Has such a severe disability that the person cannot walk  
11 without the use of or assistance from a brace, cane, another person,  
12 prosthetic device, wheelchair, or other assistive device;

13 (d) Uses portable oxygen;

14 (e) Is restricted by lung disease to an extent that forced  
15 expiratory respiratory volume, when measured by spirometry, is less  
16 than one liter per second or the arterial oxygen tension is less than  
17 sixty mm/hg on room air at rest;

18 (f) Impairment by cardiovascular disease or cardiac condition to  
19 the extent that the person's functional limitations are classified as  
20 class III or IV under standards accepted by the American heart  
21 association;

22 (g) Has a disability resulting from an acute sensitivity to  
23 automobile emissions that limits or impairs the ability to walk. The  
24 personal physician, advanced registered nurse practitioner, or  
25 physician assistant of the applicant shall document that the disability  
26 is comparable in severity to the others listed in this subsection;

27 (h) Has limited mobility and has no vision or whose vision with  
28 corrective lenses is so limited that the person requires alternative  
29 methods or skills to do efficiently those things that are ordinarily  
30 done with sight by persons with normal vision;

31 (i) Has an eye condition of a progressive nature that may lead to  
32 blindness; or

33 (j) Is restricted by a form of porphyria to the extent that the  
34 applicant would significantly benefit from a decrease in exposure to  
35 light.

36 (2) A natural person who has a physical disability that  
37 substantially limits the ability to make payment at a ticket machine or

1 parking meter must receive additional special parking privileges. A  
2 natural person who meets one of the following criteria may apply for  
3 special parking privileges that provide free of charge parking to park  
4 a vehicle being used to transport that person for unlimited periods of  
5 time in parking zones or areas, including zones or areas with parking  
6 meters that are otherwise restricted as to the length of time parking  
7 is permitted:

8 (a) Cannot insert coins in parking meters or obtain tickets from  
9 ticket machines in parking lots or ramps due to a lack of fine motor  
10 control of both hands;

11 (b) Cannot reach up to forty-two inches from the ground due to the  
12 lack of a finger, a hand, or upper extremity strength or mobility;

13 (c) Cannot approach a parking meter due to the use of a wheelchair  
14 or other device; or

15 (d) Cannot walk more than twenty feet due to an orthopedic,  
16 neurological, cardiovascular, or lung condition which is so severe that  
17 the ability to walk is almost completely impeded.

18 (3) The disability under subsections (1) and (2) of this section  
19 must be determined by either:

20 (a) A licensed physician;

21 (b) An advanced registered nurse practitioner licensed under  
22 chapter 18.79 RCW; or

23 (c) A physician assistant licensed under chapter 18.71A or 18.57A  
24 RCW.

25 ((+3)) (4) A health care practitioner listed under subsection (3)  
26 of this section must provide a signed written authorization on tamper-  
27 resistant prescription pad or paper, as defined in RCW 18.64.500, if  
28 the practitioner has prescriptive authority. An authorized health care  
29 practitioner without prescriptive authority must provide the signed  
30 written authorization on his or her office letterhead. Such  
31 authorizations must be attached to the application for special parking  
32 privileges for persons with disabilities.

33 (5) The application for special parking privileges for persons with  
34 disabilities must contain:

35 (a) The following statement immediately below the physician's,  
36 advanced registered nurse practitioner's, or physician assistant's  
37 signature: "A parking permit for a person with disabilities may be  
38 issued only for a medical necessity that severely affects mobility or

1 involves acute sensitivity to light (RCW 46.19.010). (~~Knowingly~~  
2 ~~providing false information on this application is a gross~~  
3 ~~misdemeanor.~~) An applicant or health care practitioner who knowingly  
4 provides false information on this application is guilty of a gross  
5 misdemeanor. The penalty is up to three hundred sixty-four days in  
6 jail and a fine of up to \$5,000 or both. In addition, the health care  
7 practitioner may be subject to sanctions under chapter 18.130 RCW, the  
8 Uniform Disciplinary Act"; and

9 (b) Other information as required by the department.

10 ((+4)) (6) A natural person who has a disability described in  
11 subsection (1) of this section and is expected to improve within  
12 (~~six~~) twelve months may be issued a temporary placard for a period  
13 not to exceed (~~six~~) twelve months. If the disability exists after  
14 (~~six~~) twelve months, a new temporary placard must be issued upon  
15 receipt of a new application with certification from the person's  
16 physician as prescribed in subsections (4) and (5) of this section.  
17 Special license plates for persons with disabilities may not be issued  
18 to a person with a temporary disability.

19 ((+5)) (7) A natural person who qualifies for special parking  
20 privileges under this section must receive an identification card  
21 showing the name and date of birth of the person to whom the parking  
22 privilege has been issued and the serial number of the placard.

23 ((+6)) (8) A natural person who qualifies for permanent special  
24 parking privileges under this section may receive one of the following:

- 25 (a) Up to two parking placards;
- 26 (b) One set of special license plates for persons with disabilities  
27 if the person with the disability is the registered owner of the  
28 vehicle on which the license plates will be displayed;
- 29 (c) One parking placard and one set of special license plates for  
30 persons with disabilities if the person with the disability is the  
31 registered owner of the vehicle on which the license plates will be  
32 displayed; or
- 33 (d) One special parking year tab for persons with disabilities and  
34 one parking placard.

35 ((+7)) (9) Parking placards and identification cards described in  
36 this section must be issued free of charge.

37 ((+8)) (10) The parking placard and identification card must be  
38 immediately returned to the department upon the placard holder's death.

1       **Sec. 3.** RCW 46.19.020 and 2012 c 10 s 42 are each amended to read  
2 as follows:

3       (1) The following organizations may apply for special parking  
4 privileges:

- 5       (a) Public transportation authorities;
- 6       (b) Nursing homes licensed under chapter 18.51 RCW;
- 7       (c) Assisted living facilities licensed under chapter 18.20 RCW;
- 8       (d) Senior citizen centers;
- 9       (e) Accessible van rental companies registered under RCW 46.87.023;
- 10      (f) Private nonprofit corporations, as defined in RCW 24.03.005;

11 and

12      (~~(f)~~) (g) Cabulance companies that regularly transport persons  
13 with disabilities who have been determined eligible for special parking  
14 privileges under this section and who are registered with the  
15 department under chapter 46.72 RCW.

16      (2) An organization that qualifies for special parking privileges  
17 may receive, upon application, (~~(parking)~~) special license plates or  
18 parking placards, or both, for persons with disabilities as defined by  
19 the department.

20      (3) Public transportation authorities, nursing homes, assisted  
21 living facilities, senior citizen centers, accessible van rental  
22 companies, private nonprofit corporations, and cabulance services are  
23 responsible for ensuring that the (~~(special)~~) parking placards and  
24 special license plates are not used improperly and are responsible for  
25 all fines and penalties for improper use.

26      (4) The department shall adopt rules to determine organization  
27 eligibility.

28       **Sec. 4.** RCW 46.19.030 and 2010 c 161 s 704 are each amended to  
29 read as follows:

30      (1) The department shall design special license plates for persons  
31 with disabilities, parking placards, and year tabs displaying the  
32 international symbol of access.

33      (2) Special license plates for persons with disabilities must be  
34 displayed on the motor vehicle as standard issue license plates as  
35 described in RCW 46.16A.200.

36      (3) Parking placards must include both a serial number and the

1 expiration date on the face of the placard. The expiration date and  
2 serial number must be of a sufficient size as to be easily visible from  
3 a distance of ten feet from where the placard is displayed.

4 (4) Parking placards must be displayed when the motor vehicle is  
5 parked by suspending it from the rearview mirror. In the absence of a  
6 rearview mirror, the parking placard must be displayed on the  
7 dashboard. The parking placard must be displayed in a manner that  
8 allows for the entire placard to be viewed through the vehicle  
9 windshield.

10 ((+4)) (5) Special year tabs for persons with disabilities must be  
11 displayed on license plates as defined by the department.

12 ((+5)) (6) Persons who have been issued special license plates for  
13 persons with disabilities, parking placards, or special license plates  
14 with a special year tab for persons with disabilities may park in  
15 places reserved for persons with physical disabilities.

16 **Sec. 5.** RCW 46.19.050 and 2011 c 171 s 74 are each amended to read  
17 as follows:

18 (1) **False information.** Knowingly providing false information in  
19 conjunction with the application for special parking privileges for  
20 persons with disabilities is a gross misdemeanor punishable under  
21 chapter 9A.20 RCW.

22 (2) **Unauthorized use.** Any unauthorized use of the ~~((special))~~  
23 parking placard, special license ~~((plate))~~ plate, special year tab,  
24 or identification card issued under this chapter is a ~~((parking~~  
25 ~~infraction with a monetary penalty of two hundred fifty dollars. In~~  
26 ~~addition to any penalty or fine imposed under this subsection, two~~  
27 ~~hundred dollars must be assessed))~~ misdemeanor punishable under chapter  
28 9A.20 RCW. For the purpose of this subsection, "unauthorized use"  
29 includes (a) any use of a parking placard, special license plate,  
30 special year tab, or identification card that is expired, inactivated,  
31 faked, forged, or counterfeited, (b) any use of a parking placard,  
32 special license plate, special year tab, or identification card of  
33 another holder if the initial holder is no longer eligible to use or  
34 receive it, and (c) any use of a parking placard, special license  
35 plate, special year tab, or identification card of another holder even  
36 if permitted to do so by the holder.

1 (3) **Inaccessible access.** It is a parking infraction, with a  
2 monetary penalty of two hundred fifty dollars, for a person to stop,  
3 stand, or park in, block, or otherwise make inaccessible the access  
4 aisle located next to a space reserved for persons with physical  
5 disabilities. In addition to any penalty or fine imposed under this  
6 subsection, two hundred dollars must be assessed. The clerk of the  
7 court shall report all violations related to this subsection to the  
8 department.

9 (4) **Parking without placard/plate.** It is a parking infraction,  
10 with a monetary penalty of two hundred fifty dollars, for any person to  
11 park a vehicle in a parking place provided on private property without  
12 charge or on public property reserved for persons with physical  
13 disabilities without a placard or special license plate issued under  
14 this chapter. In addition to any penalty or fine imposed under this  
15 subsection, two hundred dollars must be assessed. If a person is  
16 charged with a violation, the person will not be determined to have  
17 committed an infraction if the person (~~produces in court or before the~~  
18 ~~court appearance the placard or special license plate~~) establishes  
19 that the person operating the vehicle or being transported at the time  
20 of the infraction had a valid placard, special license plate, or  
21 special year tab issued under this chapter as required under this  
22 chapter. ((A local jurisdiction providing nonmetered, on-street  
23 parking places reserved for persons with physical disabilities may  
24 impose by ordinance time restrictions of no less than four hours on the  
25 use of these parking places.)) Such person must sign a statement under  
26 penalty of perjury that the placard, special license plate, or special  
27 year tab produced prior to the court appearance was valid at the time  
28 of infraction and issued under this chapter as required under this  
29 chapter.

30 (5) (~~**Time restrictions.**—A local jurisdiction may impose by~~  
31 ~~ordinance time restrictions of no less than four hours on the use of~~  
32 ~~nonreserved, on-street parking spaces by vehicles displaying the~~  
33 ~~special parking placards or special license plates issued under this~~  
34 ~~chapter.—All time restrictions must be clearly posted.)) **Improper**  
35 **display of placard/plate.** It is a parking infraction, with a monetary  
36 penalty of two hundred fifty dollars, to fail to fully display a  
37 placard or special license plate issued under this chapter while parked  
38 in a public place on private property without charge, while parked on~~

1 public property reserved for persons with physical disabilities, or  
2 while parking free of charge as allowed under RCW 46.61.582. In  
3 addition to any penalty or fine imposed under this subsection, two  
4 hundred dollars must be assessed, for a total of four hundred fifty  
5 dollars. For the purpose of this subsection, "fully display" means  
6 hanging or placing the placard or special license plate so that the  
7 full face of the placard or license plate is visible, including the  
8 serial number and expiration date of the license plate or placard. If  
9 a person is charged with a violation of this subsection, that person  
10 will not be determined to have committed an infraction if the person  
11 produces in court or before the court appearance a valid identification  
12 card issued to that person under RCW 46.19.010.

13 (6) **Allocation and use of funds - reimbursement.** (a) The  
14 assessment imposed under subsections ~~((2))~~ (3), ~~(and)~~ (4), and (5)  
15 of this section must be allocated as follows:

16 (i) One hundred dollars must be deposited in the accessible  
17 communities account created in RCW 50.40.071; and

18 (ii) One hundred dollars must be deposited in the multimodal  
19 transportation account under RCW 47.66.070 for the sole purpose of  
20 supplementing a grant program for special needs transportation provided  
21 by transit agencies and nonprofit providers of transportation that is  
22 administered by the department of transportation.

23 (b) Any reduction in any penalty or fine and assessment imposed  
24 under subsections ~~((2))~~ (3), ~~(and)~~ (4), and (5) of this section  
25 must be applied proportionally between the penalty or fine and the  
26 assessment. When a reduced penalty is imposed under subsection  
27 ~~((2))~~ (3), ~~(or)~~ (4), or (5) of this section, the amount deposited  
28 in the accounts identified in (a) of this subsection must be reduced  
29 equally and proportionally.

30 (c) The penalty or fine amounts must be used by that local  
31 jurisdiction exclusively for law enforcement. The court may also  
32 impose an additional penalty sufficient to reimburse the local  
33 jurisdiction for any costs that it may have incurred in the removal and  
34 storage of the improperly parked vehicle.

35 (7) **Illegal obtainment.** Except as provided in subsection (1) of  
36 this section, it is a ~~((traffic infraction with a monetary penalty of~~  
37 ~~two hundred fifty dollars)) misdemeanor punishable under chapter 9A.20~~



1 RCW for any person willfully to obtain a special license plate,  
2 placard, special year tab, or identification card issued under this  
3 chapter in a manner other than that established under this chapter.

4 (8) **Sale of a placard/plate/tab/card.** It is a misdemeanor  
5 punishable under chapter 9A.20 RCW for any person to sell a placard,  
6 special license plate, special year tab, or identification card issued  
7 under this chapter.

8 (9) **Volunteer appointment.** A law enforcement agency authorized to  
9 enforce parking laws may appoint volunteers, with a limited commission,  
10 to issue notices of infractions for violations of subsections (3), (4),  
11 and (5) of this section or RCW (~~(46.19.010 and)~~) 46.19.030 or  
12 46.61.581. Volunteers must be at least twenty-one years of age. The  
13 law enforcement agency appointing volunteers may establish any other  
14 qualifications that the agency deems desirable.

15 (a) An agency appointing volunteers under this section must provide  
16 training to the volunteers before authorizing them to issue notices of  
17 infractions.

18 (b) A notice of infraction issued by a volunteer appointed under  
19 this subsection has the same force and effect as a notice of infraction  
20 issued by a (~~police~~) peace officer for the same offense.

21 (c) A (~~police~~) peace officer or a volunteer may request a person  
22 to show the person's identification card or special parking placard  
23 when investigating the possibility of a violation of this section. If  
24 the request is refused, the person in charge of the vehicle may be  
25 issued a notice of infraction for a violation of this section.

26 (~~(9)~~) (10) **Confiscating a placard/plate/tab/card.** If a person is  
27 found to have violated the special parking privileges provided in this  
28 chapter, and unless an appeal of that finding is pending, a judge may  
29 order that the person surrender his or her placard, special license  
30 plate, special year tab, or identification card issued under this  
31 chapter.

32 (11) **Community restitution.** For second or subsequent violations of  
33 this section, in addition to a monetary penalty, the violator must  
34 complete a minimum of forty hours of:

35 (a) Community restitution for a nonprofit organization that serves  
36 persons with disabilities or disabling diseases; or

37 (b) Any other community restitution that may sensitize the violator  
38 to the needs and obstacles faced by persons with disabilities.

1           (~~(10)~~) (12) Fine suspension. The court may not suspend more than  
2 one-half of any fine imposed under subsection (~~(2)~~), (3), (4), or  
3 (~~(7)~~) (5) of this section.

4           **Sec. 6.** RCW 46.61.582 and 2011 c 171 s 80 are each amended to read  
5 as follows:

6           (1) Any person who meets the criteria for additional special  
7 parking privileges under RCW 46.19.010 (~~shall~~) (2) must be allowed  
8 free of charge to park a vehicle being used to transport (~~that~~  
9 person)) the holder of such additional special parking privileges for  
10 unlimited periods of time in parking zones or areas, including zones or  
11 areas with parking meters (~~which~~) that are otherwise restricted as to  
12 the length of time parking is permitted. (~~This section does not apply~~  
13 to those zones or areas in which the stopping, parking, or standing of  
14 all vehicles is prohibited or which are reserved for special types of  
15 vehicles.)) The person (~~shall~~) must obtain and display a (~~special~~)

18           (2) A local jurisdiction may, by ordinance, provide free of charge  
19 parking or parking for additional periods of time beyond the posted  
20 time limit, or both, for a vehicle being used to transport any person  
21 who meets the criteria for special parking privileges under RCW  
22 46.19.010(1) in parking zones or areas, including zones or areas with  
23 parking meters that are otherwise restricted as to the length of time  
24 parking is permitted. The person must obtain and display a parking  
25 placard or special license plate under RCW 46.19.010 and 46.19.030 to  
26 be eligible for the privileges under this subsection.

27           (3) This section does not apply to those zones or areas in which  
28 the stopping, parking, or standing of all vehicles is prohibited or  
29 that are reserved for special types of vehicles.

30           **Sec. 7.** RCW 46.61.583 and 1991 c 339 s 26 are each amended to read  
31 as follows:

32           A special license plate or card issued by another state or country  
33 that indicates an occupant of the vehicle (~~is disabled,~~) has a  
34 disability entitles the vehicle on or in which it is displayed and  
35 being used to transport the (~~disabled~~) person with disabilities to

1 the same (~~overtime~~) parking privileges granted under this chapter to  
2 a vehicle with a similar special license plate or card issued by this  
3 state.

4 **Sec. 8.** RCW 46.63.020 and 2013 2nd sp.s. c 23 s 21 are each  
5 amended to read as follows:

6 Failure to perform any act required or the performance of any act  
7 prohibited by this title or an equivalent administrative regulation or  
8 local law, ordinance, regulation, or resolution relating to traffic  
9 including parking, standing, stopping, and pedestrian offenses, is  
10 designated as a traffic infraction and may not be classified as a
