1 AN ACT Relating to promoting economic development by providing
2 information to businesses; amending RCW 19.02.050 and 19.02.030; and
3 adding a new section to chapter 19.02 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 19.02.050 and 2011 c 298 s 6 are each amended to read
6 as follows:

18 NEW SECTION. Sec. 2. A new section is added to chapter 19.02 RCW
19 to read as follows:

20 (1)(a) Each agency required to fully participate in the
21 implementation of this chapter under RCW 19.02.050 must provide the
22 department with the name of the agency's coordinator for the purposes
23 of implementing the requirements of this section. Using a format
24 designated by the department, each agency must provide the department
25 with the following information:

- 26 (i) A listing of each business license issued by the agency;
27 (ii) A description of the persons and specific activities for which
28 the license is required;
29 (iii) The time period for which the license is issued and any
30 issuance, renewal, or reissuance requirements; and
31 (iv) Other information the department determines necessary to
32 implement this section, including links to the licensing information,
33 application, and instructions on the agency's web site, if available.

34 (b) An agency that issues licenses in accordance with (i) national
35 or federal mandates, requirements, or standards; or (ii) educational
36 standards and an examination, may alternatively comply with this
37 chapter by providing the department with a link to its licensing web

1 site, summary information about the licensing requirements or standards
2 in a format or formats designated by the department, and a designated
3 agency contact.

4 (2) In addition to the requirements in subsection (1) of this
5 section, each agency, by November 1st of each year, beginning November
6 1, 2013, must provide the department with certification on a form
7 designated by the department that all business licensing information
8 submitted by the agency is complete and up-to-date. If an agency has
9 not submitted all the business licensing information required under
10 this section, the agency must instead submit a progress report and
11 explanation to the department.

12 (3) The department must compile the information submitted by each
13 agency, and submit an aggregate report to the governor and the economic
14 development committees of the legislature by January 1st of each year,
15 beginning January 1, 2014.

16 **Sec. 3.** RCW 19.02.030 and 2011 c 298 s 5 are each amended to read
17 as follows:

18 (1) There is located within the department a business license
19 center.

20 (2) The duties of the center include:

21 (a) Developing and administering a computerized one-stop master
22 license system capable of storing, retrieving, and exchanging license
23 information with due regard to privacy statutes, as well as issuing and
24 renewing master licenses in an efficient manner;

25 (b) Providing a license information service detailing requirements
26 to establish or engage in business in this state;

27 (c) Providing for staggered master license renewal dates;

28 (d) Identifying types of licenses appropriate for inclusion in the
29 master license system;

30 (e) Recommending in reports to the governor and the legislature the
31 elimination, consolidation, or other modification of duplicative,
32 ineffective, or inefficient licensing or inspection requirements; and

33 (f) Incorporating licenses into the master license system. Both
34 the regulatory agency legally authorized to issue the license and the
35 department must agree that the license will be issued through the
36 master license system in order for the license to be incorporated.

1 (3) The department may adopt under chapter 34.05 RCW such rules as
2 may be necessary to effectuate the purposes of this chapter.
