1        AN ACT Relating to trafficking; amending RCW 9.68A.090, 9.68A.100,  
2        9.68A.101, 9.68A.102, 9.68A.103, 9A.44.020, 9A.44.128, 9A.44.150,  
3        9A.82.010, and 13.34.132; reenacting and amending RCW 9A.40.100;  
4        prescribing penalties; and providing an effective date.

5        BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6        **Sec. 1.** RCW 9.68A.090 and 2006 c 139 s 1 are each amended to read  
7        as follows:

8        (1) Except as provided in subsection (2) of this section, a person  
9        who communicates with a minor for immoral purposes, or a person who  
10       communicates with someone the person believes to be a minor for immoral  
11       purposes, is guilty of a gross misdemeanor.

12       (2) A person who communicates with a minor for immoral purposes is  
13       guilty of a class C felony punishable according to chapter 9A.20 RCW if  
14       the person has previously been convicted under this section or of a  
15       felony sexual offense under chapter 9.68A, 9A.44, or 9A.64 RCW or of  
16       any other felony sexual offense in this or any other state or if the  
17       person communicates with a minor or with someone the person believes to  
18       be a minor for immoral purposes, including the purchase or sale of

1 commercial sex acts and sex trafficking, through the sending of an  
2 electronic communication.

3 (3) For the purposes of this section, "electronic communication"  
4 has the same meaning as defined in RCW 9.61.260.

5 **Sec. 2.** RCW 9.68A.100 and 2010 c 289 s 13 are each amended to read  
6 as follows:

7 (1) A person is guilty of commercial sexual abuse of a minor if:

8 (a) He or she pays a fee to a minor or a third person as  
9 compensation for a minor having engaged in sexual conduct with him or  
10 her;

11 (b) He or she pays or agrees to pay a fee to a minor or a third  
12 person pursuant to an understanding that in return therefore such minor  
13 will engage in sexual conduct with him or her; or

14 (c) He or she solicits, offers, or requests to engage in sexual  
15 conduct with a minor in return for a fee.

16 (2) Commercial sexual abuse of a minor is a class B felony  
17 punishable under chapter 9A.20 RCW.

18 (3) In addition to any other penalty provided under chapter 9A.20  
19 RCW, a person guilty of commercial sexual abuse of a minor is subject  
20 to the provisions under RCW 9A.88.130 and 9A.88.140.

21 (4) Consent of a minor to the sexual conduct does not constitute a  
22 defense to any offense listed in this section.

23 (5) For purposes of this section, "sexual conduct" means sexual  
24 intercourse or sexual contact, both as defined in chapter 9A.44 RCW.

25 **Sec. 3.** RCW 9.68A.101 and 2012 c 144 s 1 are each amended to read  
26 as follows:

27 (1) A person is guilty of promoting commercial sexual abuse of a  
28 minor if he or she knowingly advances commercial sexual abuse or a  
29 sexually explicit act of a minor or profits from a minor engaged in  
30 sexual conduct or a sexually explicit act.

31 (2) Promoting commercial sexual abuse of a minor is a class A  
32 felony.

33 (3) For the purposes of this section:

34 (a) A person "advances commercial sexual abuse of a minor" if,  
35 acting other than as a minor receiving compensation for personally  
36 rendered sexual conduct or as a person engaged in commercial sexual

1 abuse of a minor, he or she causes or aids a person to commit or engage  
2 in commercial sexual abuse of a minor, procures or solicits customers  
3 for commercial sexual abuse of a minor, provides persons or premises  
4 for the purposes of engaging in commercial sexual abuse of a minor,  
5 operates or assists in the operation of a house or enterprise for the  
6 purposes of engaging in commercial sexual abuse of a minor, or engages  
7 in any other conduct designed to institute, aid, cause, assist, or  
8 facilitate an act or enterprise of commercial sexual abuse of a minor.

9 (b) A person "profits from commercial sexual abuse of a minor" if,  
10 acting other than as a minor receiving compensation for personally  
11 rendered sexual conduct, he or she accepts or receives money or other  
12 property pursuant to an agreement or understanding with any person  
13 whereby he or she participates or will participate in the proceeds of  
14 commercial sexual abuse of a minor.

15 (c) A person "advances a sexually explicit act of a minor" if he or  
16 she causes or aids a sexually explicit act of a minor, procures or  
17 solicits customers for a sexually explicit act of a minor, provides  
18 persons or premises for the purposes of a sexually explicit act of a  
19 minor, or engages in any other conduct designed to institute, aid,  
20 cause, assist, or facilitate a sexually explicit act of a minor.

21 (d) A "sexually explicit act" is a public, private, or live  
22 photographed, recorded, or videotaped act or show intended to arouse or  
23 satisfy the sexual desires or appeal to the prurient interests of  
24 patrons and for which something of value is given or received.

25 (e) A "patron" is a person who pays or agrees to pay a fee to  
26 another person as compensation for a sexually explicit act of a minor  
27 or who solicits or requests a sexually explicit act of a minor in  
28 return for a fee.

29 (4) Consent of a minor to the sexually explicit act or sexual  
30 conduct does not constitute a defense to any offense listed in this  
31 section.

32 (5) For purposes of this section, "sexual conduct" means sexual  
33 intercourse or sexual contact, both as defined in chapter 9A.44 RCW.

34 **Sec. 4.** RCW 9.68A.102 and 2007 c 368 s 5 are each amended to read  
35 as follows:

36 (1) A person commits the offense of promoting travel for commercial  
37 sexual abuse of a minor if he or she knowingly sells or offers to sell

1 travel services that include or facilitate travel for the purpose of  
2 engaging in what would be commercial sexual abuse of a minor or  
3 promoting commercial sexual abuse of a minor, if occurring in this  
4 state.

5 (2) Promoting travel for commercial sexual abuse of a minor is a  
6 class C felony.

7 (3) Consent of a minor to the travel for commercial sexual abuse,  
8 or the sexually explicit act or sexual conduct itself, does not  
9 constitute a defense to any offense listed in this section.

10 (4) For purposes of this section, "travel services" has the same  
11 meaning as defined in RCW 19.138.021.

12 **Sec. 5.** RCW 9.68A.103 and 2007 c 368 s 7 are each amended to read  
13 as follows:

14 (1) A person is guilty of permitting commercial sexual abuse of a  
15 minor if, having possession or control of premises which he or she  
16 knows are being used for the purpose of commercial sexual abuse of a  
17 minor, he or she fails without lawful excuse to make reasonable effort  
18 to halt or abate such use and to make a reasonable effort to notify law  
19 enforcement of such use.

20 (2) Permitting commercial sexual abuse of a minor is a gross  
21 misdemeanor.

22 (3) Consent of a minor to the sexually explicit act or sexual  
23 conduct does not constitute a defense to any offense listed in this  
24 section.

25 **Sec. 6.** RCW 9A.40.100 and 2012 c 144 s 2 and 2012 c 134 s 1 are  
26 each reenacted and amended to read as follows:

27 (1)(a) A person is guilty of trafficking in the first degree when:

28 (i) Such person:

29 (A) Recruits, harbors, transports, transfers, provides, obtains,  
30 buys, purchases, or receives by any means another person knowing, or in  
31 reckless disregard of the fact, that force, fraud, or coercion as  
32 defined in RCW 9A.36.070 will be used to cause the person to engage in  
33 forced labor, involuntary servitude, a sexually explicit act, or a  
34 commercial sex act, or that the person has not attained the age of  
35 eighteen years and is caused to engage in a sexually explicit act or a  
36 commercial sex act; or

1 (B) Benefits financially or by receiving anything of value from  
2 participation in a venture that has engaged in acts set forth in  
3 (a)(i)(A) of this subsection; and

4 (ii) The acts or venture set forth in (a)(i) of this subsection:

5 (A) Involve committing or attempting to commit kidnapping;

6 (B) Involve a finding of sexual motivation under RCW 9.94A.835;

7 (C) Involve the illegal harvesting or sale of human organs; or

8 (D) Result in a death.

9 (b) Trafficking in the first degree is a class A felony.

10 (2)(a) A person is guilty of trafficking in the second degree when  
11 such person:

12 (i) Recruits, harbors, transports, transfers, provides, obtains,  
13 buys, purchases, or receives by any means another person knowing, or in  
14 reckless disregard of the fact, that force, fraud, or coercion as  
15 defined in RCW 9A.36.070 will be used to cause the person to engage in  
16 forced labor, involuntary servitude, a sexually explicit act, or a  
17 commercial sex act, or that the person has not attained the age of  
18 eighteen years and is caused to engaged in a sexually explicit act or  
19 a commercial sex act; or

20 (ii) Benefits financially or by receiving anything of value from  
21 participation in a venture that has engaged in acts set forth in (a)(i)  
22 of this subsection.

23 (b) Trafficking in the second degree is a class A felony.

24 (3)(a) A person who is either convicted or given a deferred  
25 sentence or a deferred prosecution or who has entered into a statutory  
26 or nonstatutory diversion agreement as a result of an arrest for a  
27 violation of a trafficking crime shall be assessed a ((three)) ten  
28 thousand dollar fee.

29 (b) The court shall not reduce, waive, or suspend payment of all or  
30 part of the fee assessed in this section unless it finds, on the  
31 record, that the offender does not have the ability to pay the fee in  
32 which case it may reduce the fee by an amount up to two-thirds of the  
33 maximum allowable fee.

34 (c) Fees assessed under this section shall be collected by the  
35 clerk of the court and remitted to the treasurer of the county where  
36 the offense occurred for deposit in the county general fund, except in  
37 cases in which the offense occurred in a city or town that provides for  
38 its own law enforcement, in which case these amounts shall be remitted

1 to the treasurer of the city or town for deposit in the general fund of  
2 the city or town. Revenue from the fees must be used for local efforts  
3 to reduce the commercial sale of sex including, but not limited to,  
4 increasing enforcement of commercial sex laws.

5 (i) At least fifty percent of the revenue from fees imposed under  
6 this section must be spent on prevention, including education programs  
7 for offenders, such as john school, and rehabilitative services, such  
8 as mental health and substance abuse counseling, parenting skills,  
9 training, housing relief, education, vocational training, drop-in  
10 centers, and employment counseling.

11 (ii) Revenues from these fees are not subject to the distribution  
12 requirements under RCW 3.50.100, 3.62.020, 3.62.040, 10.82.070, or  
13 35.20.220.

14 (4) If the victim of any offense identified in this section is a  
15 minor, force, fraud, or coercion are not necessary elements of an  
16 offense and consent to the sexually explicit act or commercial sex act  
17 does not constitute a defense.

18 (5) For purposes of this section((τ)):

19 (a) "Commercial sex act" means any act of sexual contact or sexual  
20 intercourse, both as defined in chapter 9A.44 RCW, for which something  
21 of value is given or received by any person; and

22 (b) "Sexually explicit act" means a public, private, or live  
23 photographed, recorded, or videotaped act or show intended to arouse or  
24 satisfy the sexual desires or appeal to the prurient interests of  
25 patrons for which something of value is given or received.

26 **Sec. 7.** RCW 9A.44.020 and 1975 1st ex.s. c 14 s 2 are each amended  
27 to read as follows:

28 (1) In order to convict a person of any crime defined in this  
29 chapter it shall not be necessary that the testimony of the alleged  
30 victim be corroborated.

31 (2) Evidence of the victim's past sexual behavior including but not  
32 limited to the victim's marital history, divorce history, or general  
33 reputation for promiscuity, nonchastity, or sexual mores contrary to  
34 community standards is inadmissible on the issue of credibility and is  
35 inadmissible to prove the victim's consent except as provided in  
36 subsection (3) of this section, but when the perpetrator and the victim  
37 have engaged in sexual intercourse with each other in the past, and

1 when the past behavior is material to the issue of consent, evidence  
2 concerning the past behavior between the perpetrator and the victim may  
3 be admissible on the issue of consent to the offense.

4 (3) In any prosecution for the crime of rape, trafficking pursuant  
5 to RCW 9A.40.100, or any of the offenses in chapter 9.68A RCW, or for  
6 an attempt to commit, or an assault with an intent to commit any such  
7 crime evidence of the victim's past sexual behavior including but not  
8 limited to the victim's marital behavior, divorce history, or general  
9 reputation for promiscuity, nonchastity, or sexual mores contrary to  
10 community standards is not admissible if offered to attack the  
11 credibility of the victim and is admissible on the issue of consent,  
12 except where prohibited in the underlying criminal offense, only  
13 pursuant to the following procedure:

14 (a) A written pretrial motion shall be made by the defendant to the  
15 court and prosecutor stating that the defense has an offer of proof of  
16 the relevancy of evidence of the past sexual behavior of the victim  
17 proposed to be presented and its relevancy on the issue of the consent  
18 of the victim.

19 (b) The written motion shall be accompanied by an affidavit or  
20 affidavits in which the offer of proof shall be stated.

21 (c) If the court finds that the offer of proof is sufficient, the  
22 court shall order a hearing out of the presence of the jury, if any,  
23 and the hearing shall be closed except to the necessary witnesses, the  
24 defendant, counsel, and those who have a direct interest in the case or  
25 in the work of the court.

26 (d) At the conclusion of the hearing, if the court finds that the  
27 evidence proposed to be offered by the defendant regarding the past  
28 sexual behavior of the victim is relevant to the issue of the victim's  
29 consent; is not inadmissible because its probative value is  
30 substantially outweighed by the probability that its admission will  
31 create a substantial danger of undue prejudice; and that its exclusion  
32 would result in denial of substantial justice to the defendant; the  
33 court shall make an order stating what evidence may be introduced by  
34 the defendant, which order may include the nature of the questions to  
35 be permitted. The defendant may then offer evidence pursuant to the  
36 order of the court.

37 (4) Nothing in this section shall be construed to prohibit cross-  
38 examination of the victim on the issue of past sexual behavior when the



1 prosecution presents evidence in its case in chief tending to prove the  
2 nature of the victim's past sexual behavior, but the court may require  
3 a hearing pursuant to subsection (3) of this section concerning such  
4 evidence.

5 **Sec. 8.** RCW 9A.44.128 and 2012 c 134 s 2 are each amended to read  
6 as follows:

7 For the purposes of RCW 9A.44.130 through 9A.44.145, 10.01.200,  
8 43.43.540, 70.48.470, and 72.09.330, the following definitions apply:

9 (1) "Business day" means any day other than Saturday, Sunday, or a  
10 legal local, state, or federal holiday.

11 (2) "Conviction" means any adult conviction or juvenile  
12 adjudication for a sex offense or kidnapping offense.

13 (3) "Disqualifying offense" means a conviction for: Any offense  
14 that is a felony; a sex offense as defined in this section; a crime  
15 against children or persons as defined in RCW 43.43.830(~~((+5))~~) (7) and  
16 9.94A.411(2)(a); an offense with a domestic violence designation as  
17 provided in RCW 10.99.020; permitting the commercial sexual abuse of a  
18 minor as defined in RCW 9.68A.103; or any violation of chapter 9A.88  
19 RCW.

20 (4) "Employed" or "carries on a vocation" means employment that is  
21 full time or part time for a period of time exceeding fourteen days, or  
22 for an aggregate period of time exceeding thirty days during any  
23 calendar year. A person is employed or carries on a vocation whether  
24 the person's employment is financially compensated, volunteered, or for  
25 the purpose of government or educational benefit.

26 (5) "Fixed residence" means a building that a person lawfully and  
27 habitually uses as living quarters a majority of the week. Uses as  
28 living quarters means to conduct activities consistent with the common  
29 understanding of residing, such as sleeping; eating; keeping personal  
30 belongings; receiving mail; and paying utilities, rent, or mortgage.  
31 A nonpermanent structure including, but not limited to, a motor home,  
32 travel trailer, camper, or boat may qualify as a residence provided it  
33 is lawfully and habitually used as living quarters a majority of the  
34 week, primarily kept at one location with a physical address, and the  
35 location it is kept at is either owned or rented by the person or used  
36 by the person with the permission of the owner or renter. A shelter  
37 program may qualify as a residence provided it is a shelter program

1 designed to provide temporary living accommodations for the homeless,  
2 provides an offender with a personally assigned living space, and the  
3 offender is permitted to store belongings in the living space.

4 (6) "In the community" means residing outside of confinement or  
5 incarceration for a disqualifying offense.

6 (7) "Institution of higher education" means any public or private  
7 institution dedicated to postsecondary education, including any  
8 college, university, community college, trade, or professional school.

9 (8) "Kidnapping offense" means:

10 (a) The crimes of kidnapping in the first degree, kidnapping in the  
11 second degree, and unlawful imprisonment, as defined in chapter 9A.40  
12 RCW, where the victim is a minor and the offender is not the minor's  
13 parent;

14 (b) Any offense that is, under chapter 9A.28 RCW, a criminal  
15 attempt, criminal solicitation, or criminal conspiracy to commit an  
16 offense that is classified as a kidnapping offense under this  
17 subsection; and

18 (c) Any federal or out-of-state conviction for: An offense for  
19 which the person would be required to register as a kidnapping offender  
20 if residing in the state of conviction; or, if not required to register  
21 in the state of conviction, an offense that under the laws of this  
22 state would be classified as a kidnapping offense under this  
23 subsection.

24 (9) "Lacks a fixed residence" means the person does not have a  
25 living situation that meets the definition of a fixed residence and  
26 includes, but is not limited to, a shelter program designed to provide  
27 temporary living accommodations for the homeless, an outdoor sleeping  
28 location, or locations where the person does not have permission to  
29 stay.

30 (10) "Sex offense" means:

31 (a) Any offense defined as a sex offense by RCW 9.94A.030;

32 (b) Any violation under RCW 9A.44.096 (sexual misconduct with a  
33 minor in the second degree);

34 (c) Any violation under RCW 9A.40.100(1)(a)(ii)(B) (trafficking);

35 (d) Any violation under RCW 9.68A.090 (communication with a minor  
36 for immoral purposes);

37 ((d)) (e) A violation under RCW 9A.88.070 (promoting prostitution

1 in the first degree) or RCW 9A.88.080 (promoting prostitution in the  
2 second degree) if the person has a prior conviction for one of these  
3 offenses;

4 ~~((f))~~ (f) Any gross misdemeanor that is, under chapter 9A.28 RCW,  
5 a criminal attempt, criminal solicitation, or criminal conspiracy to  
6 commit an offense that is classified as a sex offense under RCW  
7 9.94A.030 or this subsection;

8 ~~((g))~~ (g) Any out-of-state conviction for an offense for which  
9 the person would be required to register as a sex offender while  
10 residing in the state of conviction; or, if not required to register in  
11 the state of conviction, an offense that under the laws of this state  
12 would be classified as a sex offense under this subsection;

13 ~~((h))~~ (h) Any federal conviction classified as a sex offense  
14 under 42 U.S.C. Sec. 16911 (SORNA);

15 ~~((i))~~ (i) Any military conviction for a sex offense. This  
16 includes sex offenses under the uniform code of military justice, as  
17 specified by the United States secretary of defense;

18 ~~((j))~~ (j) Any conviction in a foreign country for a sex offense  
19 if it was obtained with sufficient safeguards for fundamental fairness  
20 and due process for the accused under guidelines or regulations  
21 established pursuant to 42 U.S.C. Sec. 16912.

22 (11) "School" means a public or private school regulated under  
23 Title 28A RCW or chapter 72.40 RCW.

24 (12) "Student" means a person who is enrolled, on a full-time or  
25 part-time basis, in any school or institution of higher education.

26 **Sec. 9.** RCW 9A.44.150 and 2005 c 455 s 1 are each amended to read  
27 as follows:

28 (1) On motion of the prosecuting attorney in a criminal proceeding,  
29 the court may order that a child under the age of ~~((ten))~~ fourteen may  
30 testify in a room outside the presence of the defendant and the jury  
31 while one-way closed-circuit television equipment simultaneously  
32 projects the child's testimony into another room so the defendant and  
33 the jury can watch and hear the child testify if:

- 34 (a) The testimony will:
- 35 (i) Describe an act or attempted act of sexual contact performed
  - 36 with or on the child witness by another person or with or on a child
  - 37 other than the child witness by another person;

1 (ii) Describe an act or attempted act of physical abuse against the  
2 child witness by another person or against a child other than the child  
3 witness by another person; (~~(e)~~)

4 (iii) Describe a violation of RCW 9A.40.100 (trafficking) or any  
5 offense identified in chapter 9.68A RCW (sexual exploitation of  
6 children); or

7 (iv) Describe a violent offense as defined by RCW 9.94A.030  
8 committed against a person known by or familiar to the child witness or  
9 by a person known by or familiar to the child witness;

10 (b) The testimony is taken during the criminal proceeding;

11 (c) The court finds by substantial evidence, in a hearing conducted  
12 outside the presence of the jury, that requiring the child witness to  
13 testify in the presence of the defendant will cause the child to suffer  
14 serious emotional or mental distress that will prevent the child from  
15 reasonably communicating at the trial. If the defendant is excluded  
16 from the presence of the child, the jury must also be excluded;

17 (d) As provided in (~~subsection (1)~~)(a) and (b) of this  
18 subsection, the court may allow a child witness to testify in the  
19 presence of the defendant but outside the presence of the jury, via  
20 closed-circuit television, if the court finds, upon motion and hearing  
21 outside the presence of the jury, that the child will suffer serious  
22 emotional distress that will prevent the child from reasonably  
23 communicating at the trial in front of the jury, or, that although the  
24 child may be able to reasonably communicate at trial in front of the  
25 jury, the child will suffer serious emotional or mental distress from  
26 testifying in front of the jury. If the child is able to communicate  
27 in front of the defendant but not the jury the defendant will remain in  
28 the room with the child while the jury is excluded from the room;

29 (e) The court finds that the prosecutor has made all reasonable  
30 efforts to prepare the child witness for testifying, including  
31 informing the child or the child's parent or guardian about community  
32 counseling services, giving court tours, and explaining the trial  
33 process. If the prosecutor fails to demonstrate that preparations were  
34 implemented or the prosecutor in good faith attempted to implement  
35 them, the court shall deny the motion;

36 (f) The court balances the strength of the state's case without the  
37 testimony of the child witness against the defendant's constitutional

1 rights and the degree of infringement of the closed-circuit television  
2 procedure on those rights;

3 (g) The court finds that no less restrictive method of obtaining  
4 the testimony exists that can adequately protect the child witness from  
5 the serious emotional or mental distress;

6 (h) When the court allows the child witness to testify outside the  
7 presence of the defendant, the defendant can communicate constantly  
8 with the defense attorney by electronic transmission and be granted  
9 reasonable court recesses during the child's testimony for person-to-  
10 person consultation with the defense attorney;

11 (i) The court can communicate with the attorneys by an audio system  
12 so that the court can rule on objections and otherwise control the  
13 proceedings;

14 (j) All parties in the room with the child witness are on camera  
15 and can be viewed by all other parties. If viewing all participants is  
16 not possible, the court shall describe for the viewers the location of  
17 the prosecutor, defense attorney, and other participants in relation to  
18 the child;

19 (k) The court finds that the television equipment is capable of  
20 making an accurate reproduction and the operator of the equipment is  
21 competent to operate the equipment; and

22 (l) The court imposes reasonable guidelines upon the parties for  
23 conducting the filming to avoid trauma to the child witness or abuse of  
24 the procedure for tactical advantage.

25 The prosecutor, defense attorney, and a neutral and trained  
26 victim's advocate, if any, shall always be in the room where the child  
27 witness is testifying. The court in the court's discretion depending  
28 on the circumstances and whether the jury or defendant or both are  
29 excluded from the room where the child is testifying, may remain or may  
30 not remain in the room with the child.

31 (2) During the hearing conducted under subsection (1) of this  
32 section to determine whether the child witness may testify outside the  
33 presence of the defendant and/or the jury, the court may conduct the  
34 observation and examination of the child outside the presence of the  
35 defendant if:

36 (a) The prosecutor alleges and the court concurs that the child  
37 witness will be unable to testify in front of the defendant or will

1 suffer severe emotional or mental distress if forced to testify in  
2 front of the defendant;

3 (b) The defendant can observe and hear the child witness by closed-  
4 circuit television;

5 (c) The defendant can communicate constantly with the defense  
6 attorney during the examination of the child witness by electronic  
7 transmission and be granted reasonable court recesses during the  
8 child's examination for person-to-person consultation with the defense  
9 attorney; and

10 (d) The court finds the closed-circuit television is capable of  
11 making an accurate reproduction and the operator of the equipment is  
12 competent to operate the equipment. Whenever possible, all the parties  
13 in the room with the child witness shall be on camera so that the  
14 viewers can see all the parties. If viewing all participants is not  
15 possible, then the court shall describe for the viewers the location of  
16 the prosecutor, defense attorney, and other participants in relation to  
17 the child.

18 (3) The court shall make particularized findings on the record  
19 articulating the factors upon which the court based its decision to  
20 allow the child witness to testify via closed-circuit television  
21 pursuant to this section. The factors the court may consider include,  
22 but are not limited to, a consideration of the child's age, physical  
23 health, emotional stability, expressions by the child of fear of  
24 testifying in open court or in front of the defendant, the relationship  
25 of the defendant to the child, and the court's observations of the  
26 child's inability to reasonably communicate in front of the defendant  
27 or in open court. The court's findings shall identify the impact the  
28 factors have upon the child's ability to testify in front of the jury  
29 or the defendant or both and the specific nature of the emotional or  
30 mental trauma the child would suffer. The court shall determine  
31 whether the source of the trauma is the presence of the defendant, the  
32 jury, or both, and shall limit the use of the closed-circuit television  
33 accordingly.

34 (4) This section does not apply if the defendant is an attorney pro  
35 se unless the defendant has a court-appointed attorney assisting the  
36 defendant in the defense.

37 (5) This section may not preclude the presence of both the child

1 witness and the defendant in the courtroom together for purposes of  
2 establishing or challenging the identification of the defendant when  
3 identification is a legitimate issue in the proceeding.

4 (6) The Washington supreme court may adopt rules of procedure  
5 regarding closed-circuit television procedures.

6 (7) All recorded tapes of testimony produced by closed-circuit  
7 television equipment shall be subject to any protective order of the  
8 court for the purpose of protecting the privacy of the child witness.

9 (8) Nothing in this section creates a right of the child witness to  
10 a closed-circuit television procedure in lieu of testifying in open  
11 court.

12 (9) The state shall bear the costs of the closed-circuit television  
13 procedure.

14 (10) A child witness may or may not be a victim in the proceeding.

15 (11) Nothing in this section precludes the court, under other  
16 circumstances arising under subsection (1)(a) of this section, from  
17 allowing a child to testify outside the presence of the defendant and  
18 the jury so long as the testimony is presented in accordance with the  
19 standards and procedures required in this section.

5 (qq) Mortgage fraud, as defined in RCW 19.144.080;

6 (rr) Commercial sexual abuse of a minor, as defined in RCW

8 (ss) Promoting commercial sexual abuse of a minor, as defined in  
9 RCW 9.68A.101; or

10 (tt) Trafficking, as defined in RCW 9A.40.100, promoting travel for

14 (5) "Dealer in property" means a person who buys and sells property
