House Bills

HB 1430 by Representatives Shea, Overstreet, and Taylor

Reducing property tax delinquencies by modifying collection practices.

Requires a county treasurer to accept partial payments on taxes due and for delinquent taxes including interest and penalties if the payment is made electronically.

HB 1431 by Representatives Santos, Dahlquist, Bergquist, and Pollet; by request of Superintendent of Public Instruction

Regarding alternative learning experience courses.

Revises alternative learning experience provisions relating to: (1) Expanding the definition of "online course";

(2) Approval criteria for online providers;

- (3) School districts claiming state funding, assessing educational progress of enrolled students, and awarding grades for online high school courses; and
- (4) Changing the term "alternative learning experience program" to "alternative learning experience course."

HB 1432 by Representatives Stanford, Hope, Moscoso, Springer, Hayes, Roberts, McCoy, Liias, Kristiansen, and Sells

Concerning county property tax levies.

HB 1433 by Representatives Takko, Sawyer, Farrell, Haigh, Walsh, Seaquist, Haler, Fey, and Santos

Creating a sentence for treatment program for juvenile offenders.

Establishes a sentence for treatment program for juvenile offenders.

Requires the department of social and health services to maintain a medium security forestry camp at the Naselle youth camp to fulfill the department's obligation to provide education, treatment, and job training to certain juvenile offenders.

Authorizes a court to impose a sentence for treatment if a juvenile offender is subject to a disposition of more than fifteen weeks and is not deemed to require confinement in a close security facility by the department of social and health services.

HB 1434 by Representatives Pollet, Upthegrove, McCoy, Fitzgibbon, Ryu, Moscoso, Reykdal, Orwall, Fey, Hudgins, Liias, and Kagi

Regarding the inclusion of community involvement in environmental decision making.

Requires state agencies, to the extent practical, to make achieving environmental justice part of their mission by identifying and addressing, as appropriate, the disproportionately high and adverse human health or environmental effects of their programs, policies, and activities on minority populations and low-income populations in the state.

HB 1435 by Representatives Goodman and Nealey

Clarifying agency relationships in reconveyances of deeds of trust.

Clarifies agency relationships in reconveyances of deeds of trust.

Jan 28 First reading, referred to Judiciary.

HB 1436 by Representatives Rodne, Pedersen, Shea, and Jinkins

Concerning privileging and professional conduct reviews by health care professional review bodies.

Addresses hospitals' coordinated quality improvement programs and the provision of exclusive remedies in lawsuits by health care providers.

Jan 28 First reading, referred to Judiciary.

HB 1437 by Representatives Reykdal, Blake, Haigh, Orcutt, Lytton, Van De Wege, and Zeiger

Concerning small farms under the current use property tax program for farm and agricultural lands.

Provides that farms under twenty acres meeting the income requirements of the current use property tax program for farm and agricultural lands are eligible for current use valuation of the land underlying the residential structures the same as farms twenty acres and over.

HB 1438 by Representatives Buys, Blake, Chandler, Warnick, Schmick, and Fagan

Concerning de facto changes in water rights for irrigation purposes that involved conversion to more efficient irrigation technologies.

Establishes that the standards for a change of use application for certain types of water rights are the laws in place at the time the change of use was implemented.

HB 1439 by Representatives Buys and Magendanz

Concerning autonomous vehicles.

Authorizes autonomous vehicles to be operated on the public roads of the state if the manufacturer of the vehicle certifies, in a manner to be determined by the state patrol, that the vehicle meets all safety standards and performance requirements adopted by the state patrol.

HB 1440 by Representatives McCoy, Sullivan, Ryu, Sells, Green, Cody, Moscoso, Goodman, Bergquist, Riccelli, Hunt, Fitzgibbon, Pollet, Seaquist, Roberts, Ormsby, Stonier, Pettigrew, Van De Wege, Hudgins, Reykdal, Blake, Freeman, Moeller, Jinkins, Appleton, and Kagi

Ensuring fairness to employers by protecting employees.

Finds that improving compliance with wage-related laws will help address the problems of the underground economy, level the playing field for honest employers and contractors, and protect workers.

Establishes the employee fair classification act. Creates the employee fair classification act account.

Jan 31 Scheduled for public hearing in the House Committee on Labor & Workforce Development at 1:30 PM. (Subject to change)

HB 1441 by Representatives Van De Wege, Morrell, Jinkins, Cody, and Bergquist; by request of Insurance Commissioner

Addressing long-term care insurance.

Decreases the time in which denials of long-term care insurance must be made.

Requires the insurance commissioner to adopt by rule prompt payment requirements for long-term care insurance.

-- 2013 REGULAR SESSION --

Jan 28 First reading, referred to Health Care & Wellness.

HB 1442 by Representatives Schmick, Cody, Hunt, Condotta, Blake, and Sullivan

Providing increased access to parimutuel satellite locations in counties with a population exceeding one million.

Authorizes the horse racing commission to approve two parimutuel satellite locations in counties with a population exceeding one million.

-- 2013 REGULAR SESSION --

Jan 28 First reading, referred to Government Accountability & Oversight.

HB 1443 by Representatives Sells and Hope

Providing for property tax exemption for the value of new construction of industrial/manufacturing facilities in targeted urban areas.

Provides property tax exemptions to encourage new manufacturing and industrial uses on undeveloped or underutilized lands zoned for industrial and manufacturing uses in targeted urban areas.

Jan 28 First reading, referred to Technology & Economic Development.

HB 1444 by Representatives Hunt, Tharinger, Takko, Morris, Fey, and Pollet

Concerning stewardship of household mercury-containing lights.

Provides flexibility for mercury light manufacturers in order to provide a sustainable funding mechanism and effective state protections to producer-operated product stewardship programs.

Provides for termination and review, under the sunset act, of the product stewardship program for the disposal of mercury-containing lights.

HB 1445 by Representatives Cody, Green, Jinkins, and Morrell

Concerning complex rehabilitation technology products.

Requires the state health care authority to establish a separate recognition for medically necessary, individually configured, complex rehabilitation technology products and services for complex needs patients with the medical assistance program.

HB 1446 by Representatives Kirby, Nealey, and Goodman

Concerning judicial proceedings and forms.

Modifies judicial proceedings provisions relating to: (1) Notification to the county auditor of undeliverable jury duty summons;

- (2) Commencement of judicial proceeding as a new action; and
- (3) Public inspection of final order and subsequent documents or pleadings in a proceeding to adjudicate parentage.

HB 1447 by Representatives Fey, Hargrove, Clibborn, and Zeiger

Modifying the boundaries of certain heavy haul corridors. Changes the boundaries of certain heavy haul corridors.

HB 1448 by Representatives Bergquist, Ross, Cody, Harris, Green, Rodne, Tharinger, Johnson, Manweller, Magendanz, and Morrell

Regarding telemedicine.

Recognizes the application of telemedicine as a reimbursable service by which an individual receives medical services from a health care provider without face-to-face contact with the provider.

Reduces the compliance requirements on hospitals when granting privileges or associations to telemedicine physicians.

Jan 28 First reading, referred to Health Care & Wellness.

HB 1449 by Representatives Bergquist, Hope, Hunt, Buys, Orwall, Manweller, and Freeman

Making specific prosecution and defense documents and materials exempt from public inspection and copying.

Exempts from public inspection and copying under the public records act, victim impact statements and certain documents and other materials provided by the attorney for the defendant, or by the defendant when acting pro se, to the prosecuting attorney.

Jan 28 First reading, referred to Government Operations & Elections.

HB 1450 by Representatives Hunt and Pollet; by request of Superintendent of Public Instruction

Regarding assessments in public schools.

Declares an intent to: (1) Begin administering the college-ready and career-ready assessments that are being developed to measure the common core state standards in the 2014-2015 school year;

(2) Combine the current reading and writing assessments into English language arts assessments;

- (3) Reduce the number of different assessments that will be required for students to graduate beginning with the class of 2015; and
- (4) Decentralize the scoring of the collections of evidence.

Requires the student achievement council to convene a workgroup to determine how the results of the college and career assessment could be incorporated into college and university admissions, scholarship, and course placement decisions.

Requires the office of the superintendent of public instruction to develop a process for periodically auditing school districts to ensure fair and reliable scoring of the collections.

HB 1451 by Representatives Hurst, Freeman, Takko, Carlyle, and Pollet; by request of State Auditor

Providing a process for the state auditor's office to apply for investigative subpoenas.

Provides a process for the state auditor and his or her authorized assistants to apply for and obtain a superior court order approving and authorizing a subpoena in advance of its issuance.

HB 1452 by Representatives Dahlquist, Magendanz, Angel, Buys, Fagan, Pike, and Smith

Establishing accountability for student performance in third grade.

Allows school districts to exempt certain students from the performance standard for promotion to fourth grade.

Requires school districts to provide: (1) Certain remedial measures for students who did not meet the state standard on the third grade statewide assessment in English language arts in the previous school year; and

(2) Supplemental learning opportunities through an extended school day or school year or through a summer school program for certain students retained in third grade or eligible to be retained but promoted to fourth grade.

Changing state need grant eligibility provisions.

Changes eligibility requirements for a state need grant.

HB 1454 by Representatives Overstreet, Shea, Taylor, Scott, and Condotta

Creating the Washington state freedom of travel act. Establishes the Washington state freedom of travel act.

Addresses the act of a public servant committing an offense of official oppression.

Jan 28 First reading, referred to Public Safety.

HB 1455 by Representatives Overstreet, Hurst, Orcutt, Haigh, Shea, Condotta, Morris, Buys, Taylor, Kretz, Scott, Upthegrove, Short, Harris, Hargrove, O'Ban, Holy, Schmick, Fagan, and Kristiansen

Eliminating the use of automated traffic safety cameras. Repeals statutes authorizing the use of automated traffic safety cameras.

HB 1456 by Representatives Hunt, Moscoso, Seaquist, Blake, Riccelli, Reykdal, Stanford, Fitzgibbon, and Bergquist

Authorizing pretax payroll deductions for qualified transit and parking benefits.

Authorizes, under certain conditions, pretax payroll deductions for qualified transit and parking benefits.

-- 2013 REGULAR SESSION --

Jan 28 First reading, referred to Government Operations & Elections.

HB 1457 by Representatives Green, Sawyer, Reykdal, Appleton, Sells, Ormsby, Bergquist, Jinkins, Pollet, Fey, Moeller, Kagi, Freeman, and Hudgins

Implementing family and medical leave insurance.

Allows workers to care for family members with a serious health condition or to recover from their own serious health condition.

Expands duties of the employment security department. Requires each employer, for each individual, to pay a premium to the employment security department based on the amount of the employee's wages.

Provides a business and occupation tax credit for certain employers.

Changes the name of the family leave insurance program to the family and medical leave insurance program.

Changes the name of the family leave insurance account to the family and medical leave insurance account.

-- 2013 REGULAR SESSION --

Jan 28 First reading, referred to Labor & Workforce Development.

HB 1458 by Representative Green

Repealing provisions restricting outings from state facilities.

Repeals statutes that prohibit certain confined persons from leaving the facility in which they are confined.

HB 1459 by Representatives Haler, Springer, Walsh, Wylie, Seaquist, Wilcox, Johnson, Condotta, Fagan, Maxwell, and Pollet

Authorizing students under the age of twenty-one to taste wine in viticulture and enology programs.

Allows students between the ages of eighteen and twenty-one, who are enrolled in a viticulture or enology degree program at certain educational facilities, to taste but not ingest wine for instructional purposes.

HB 1460 by Representatives Manweller and Condotta

Creating a process for administrative reassignment of public employees.

Allows an employee to be placed on administrative reassignment if the employee's manager determines that administrative reassignment is necessary to ensure a full, thorough, and impartial investigation of a workplace complaint.

HB 1461 by Representatives Manweller and Condotta

Requiring notice of employees' rights related to unions.

Requires the department of labor and industries to include information regarding employees' rights related to union membership and dues in certain workplace posters.

Requires the public employment relations commission to develop language to educate and advise employees regarding their rights related to union membership and dues and transmit the language to the department of labor and industries for inclusion in the workplace poster.

Addressing compensation for injured workers.

Simplifying and adding certainty to the calculation of workers' compensation benefits.

Simplifies the calculation of workers' compensation benefits.

HB 1465 by Representatives Manweller and Condotta

Concerning recovery for purposes of legal actions under the industrial insurance statutes.

Specifies that the act is an explicit restatement of the legislature's original intent to grant the department of labor and industries or a self-insured employer the authority to reimburse itself from a third-party recovery for the amount paid on behalf of the worker or beneficiary for all economic and noneconomic damages except loss of consortium.

Requires the joint legislative audit and review committee, if the sunset review process expires before June 30, 2021, to conduct a program and fiscal review of the alternative public works contracting procedures by June 30, 2021. Expires July 1, 2022.

Updates and aligns hospital health care-associated infection rate reporting with federal requirements.

HB 1472 by Representatives Hansen, Habib, Freeman, and Magendanz

Providing initiatives to improve and expand access to computer science education.

Improves and expands access to computer science education.

Requires high school and school district boards of directors to approve AP computer science courses as equivalent to high school mathematics.

Requires the office of the superintendent of public instruction to allocate grants to certain school districts to increase the number of courses coinstructed by computer science professionals.

Requires the workforce training and education coordinating board to convene and provide staff support for a computer science professional shortage task force to develop a strategic plan to increase the number of graduates from high schools, colleges, and universities who are prepared to enter the workforce or continue their education in computer science.

Requires the office of online learning to actively seek: (1) Additional providers of online computer science courses to be made available through the office; and

(2) Funding from private or federal sources to offset the costs to school districts and students of offering and enrolling in online computer science courses made available through the office.

Requires an entity that, in the course of business, makes a payment to a construction service provider of six hundred dollars or more in a taxable year for performing construction services to report the payment to the department of labor and industries and the construction service provider.

Requires the department of labor and industries to transmit the report to the commissioner of the employment security department.

Exempts from public disclosure under the public records act, the reports filed with the department of labor and industries.

Gives voters the power to choose between the top two candidates for nonpartisan offices in a general election.

Authorizing waivers of state requirements for school districts.

Provides a process for school district boards of directors to waive certain state education requirements when the local board determines it is necessary to do so.

Establishing a performance-based grading system for schools and school districts.

Requires the accountability index developed by the state board of education to identify five categories of schools and school districts, which must be labeled using a letter A through F grading system based on relative performance on the criteria used in the index.

Providing flexibility for how school districts address truancy of students.

Provides flexibility to school districts when addressing truancy to reduce the administrative and paperwork load for school districts and the court system.

HB 1478 by Representatives Orcutt, Taylor, Short, Smith, Angel, Pike, Condotta, Vick, Haler, Hargrove, Buys, Fagan, Scott, and Kristiansen

Providing a moratorium on rule making.

Imposes a moratorium on formal and informal rule making by state agencies, except in certain specified instances, to last for three years or until the state is no longer facing financial deficits.

HB 1479 by Representatives Orcutt, Pike, Hargrove, Buys, and Morrell

Allowing leased land used for the placement of a mobile home to qualify for the senior, disabled, and veteran property tax exemption.

Exempts certain real property from taxation if it is leased to the owner of a mobile home, meeting certain requirements, who places such mobile home on the property.
