HB 1005-S by House Committee on Government Operations & Elections (originally sponsored by Representatives Moeller, Wylie, Reykdal, Appleton, Ryu, Morrell, McCoy, Seaquist, Moscoso, Hudgins, Ormsby, and Pollet)

Concerning responsibilities and funding of the public disclosure commission.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Restructures ethics functions under the public disclosure commission to unify processes and functions and cut costs.

Increases disclosure regarding the influence of money in politics by requiring electronic filing by lobbyists.

Abolishes the executive ethics board and transfers its powers, duties, and functions to the public disclosure commission.

Creates the public disclosure electronic filing account.

Concerning uniform ballot design.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the secretary of state, in conjunction with the Washington state association of county auditors, to develop a uniform ballot format to be used by each county.

Authorizes the secretary of state, in conjunction with the department of enterprise services and in consultation with county auditors, to develop a master contract for vote tallying equipment for purchase by counties.

Authorizes a county auditor to establish an equipment replacement fund that must be used to replace vote tallying equipment.

Requires the department of agriculture to rely on existing programs to develop an inventory of idle agricultural lands in certain western Washington counties to inform a focused effort on reestablishing a rural agricultural economy in western Washington that focuses on investments aimed at returning underproducing land back into a state of active agricultural production.

Requiring training of public officials and employees regarding public records and open public meetings.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the attorney general to develop and implement:
(1) A training program regarding the legal requirements and purposes of the open public meetings act and the public records act; and

(2) An intensive training seminar for public records officers.

Requires every member of the governing body of a public agency to complete the open public meetings act training course implemented or approved by the attorney general.

Requires each elected state or local official, and each person appointed to fill a vacancy in elective office, who is subject to the requirements of the public records act, to complete certain training courses implemented or approved by the attorney general.

Requires the clerk of the house and the secretary of the senate to provide appropriate training to legislators on their obligations under the public records act.

Revises the definition of "motorcycle" as a motor vehicle designed to travel on not more than three wheels, not including any stabilizing conversion kits.

Requires a person operating a motorcycle with a stabilizing conversion kit to have a valid driver's license specially endorsed for a three-wheeled motorcycle.

Allows practitioners, pharmacists, medical facilities, drug manufacturers, and drug wholesalers to donate prescription drugs and supplies to pharmacies for redistribution without compensation or the expectation of compensation to individuals who meet certain criteria.

Requires pharmacies, pharmacists, and prescribing practitioners that elect to dispense donated prescription

drugs and supplies to give priority to individuals who are uninsured and at or below two hundred percent of the federal poverty level.
