**HB 1105-S** by House Committee on Environment (originally sponsored by Representatives McCoy, Morris, Wylie, Ryu, and Pollet)

Modifying the renewable energy cost recovery program.  
(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Closes the current renewable energy system cost recovery incentive program and creates a new program to be administered by the state housing finance commission.

Allows a public utility tax credit to a utility in an amount equal to certain cost recovery incentive payments made in any fiscal year.

**HB 1106-S** by House Committee on Environment (originally sponsored by Representatives McCoy, Morris, Ryu, and Hudgins)

Regarding net metering of electricity.  
(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses third-party ownership of net metering systems.

Increases the maximum electrical generating capacity of a net metering system.

Increases the cumulative generating capacity available to a net metering system as a percentage of an electric utility's peak demand.

Increases the total amount of kilowatts allowed to be aggregated by a customer-generator under meter aggregation.

Requiring school districts to disclose information about required assessments.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires school districts to notify parents or guardians of enrolled students with certain information about standardized assessments from kindergarten through twelfth grade that are required by the state or the federal government.

Requires the office of the superintendent of public instruction to provide regularly updated information to school districts that is necessary for the districts to notify parents of the information.

Increasing the capacity of school districts to recognize and respond to troubled youth.

(AS OF HOUSE 2ND READING 3/04/13)

Increases the capacity for school districts to recognize and respond to youth in need, including emotional and behavioral distress in students and indicators of possible substance abuse, violence, and suicide, through additional training, more comprehensive planning, and emphasis on partnerships between schools and communities.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes an existing publicly owned and operated group A or group B water system to serve a proposed new development with a quantity of water that otherwise would be withdrawn for beneficial use under the permit exemption.

Allows veteran scoring criteria to be claimed upon receipt of separation orders indicating an honorable discharge issued by the respective military department.

Creating initiatives in high schools to save lives in the event of cardiac arrest.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the office of the superintendent of public instruction to: (1) In consultation with school districts and stakeholder groups, develop guidance for a medical emergency response and automated external defibrillator program for high schools; and

(2) In consultation with the department of health, assist districts in carrying out the program.

Requires school districts that operate a high school to offer instruction in cardiopulmonary resuscitation to students.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the criminal justice training commission to provide crisis intervention training to: (1) New full-time law enforcement officers employed by a state, county, or municipal law enforcement agency; and

(2) Twenty-five percent of currently certified law enforcement officers, assigned to patrol duties no later than December 1, 2017.

Makes an appropriation.

Concerning the disposition of surplus property for the development of affordable housing.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes governmental entities to sell, lease, exchange, or donate surplus property to an eligible organization at a price that is less than fair market value, or may create beneficial sales terms, if the affordable housing to be developed on the property will be occupied primarily by extremely low-income, very low-income, federally qualified low-income, or low-income households.

Providing alternatives for penalties stemming from traffic infractions.

Allows entry into a community restitution plan in lieu of paying a monetary penalty for certain traffic infractions.

**HB 1642-S** by House Committee on Education (originally sponsored by Representatives Pettigrew, Springer, Habib, Holy, Ryu, and Magendanz)

Establishing policies to support academic acceleration for high school students.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Encourages each school district board of directors to adopt an academic acceleration policy for high school students.

Establishes an academic acceleration incentive program to support teacher training, curriculum, technology, examination fees, and other costs associated with offering dual credit courses to high school students.

Requires the office of the superintendent of public instruction to: (1) Allocate half of the funds appropriated for the purposes of the incentive program on a competitive basis to provide one-time grants for high schools to expand the availability of dual credit courses;

(2) Allocate half of the funds appropriated for the purposes of the incentive program to school districts as an incentive award for each student who earned dual high school and college credit for courses offered by the district's high schools during the previous school year; and

(3) Collect and post on the Washington state report card web site certain results from the program.

Concerning assault in the third degree occurring in areas used in connection with court proceedings.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Includes in the crime of assault in the third degree, an assault on a person located in any area of a building that is used in connection with court proceedings.

Includes, as aggravating circumstances, an offense that involves a felony crime against persons that occurs in those areas in any building that are used in connection with court proceedings.

Requires the judges of the supreme and superior courts and the courts of appeals and the judicial officers within the county, city, district, and precinct in which the judicial officer is chosen to develop procedures for notifying the public that an assault offense occurring in any area that is used in connection with court proceedings is a class C felony offense.

Concerning self-supporting, fee-based programs at four-year institutions of higher education.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the state and regional universities and The Evergreen State College to: (1) When a decision is being considered to change an existing degree program that is supported by state funding to a program that is self-supporting and fee-based, notify enrolled and prospective students and undergraduate and graduate student government associations; and

(2) Establish or designate a committee to create criteria upon which to evaluate the proposed shift of a degree

program from a state-supported degree program to a self-supporting funding basis.

Exempting from disclosure and copying valuable commercial information in records pertaining to solid waste collection companies in possession of the Washington utilities and transportation commission.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Exempts from public inspection and copying under the public records act, records filed with the utilities and transportation commission by a solid waste collection company in the context of a tariff filing when such documents concern activities of the solid waste collection company that are not subject to rate regulation by the commission or are documents of affiliated interests.

Changes licensing requirements for geoduck divers.  
Prohibits the director of the department of fish and wildlife from issuing more than seventy-five geoduck diver licenses in any one year.

Requires the department of natural resources to establish a geoduck harvest safety committee to establish a safety program for geoduck diver license holders.
