"PART I

4 <u>NEW SECTION.</u> **Sec. 101.** This act may be known and cited as the 5 uniform power of attorney act.

6 <u>NEW SECTION.</u> **Sec. 102.** The definitions in this section apply 7 throughout this chapter unless the context clearly requires 8 otherwise.

9 (1) "Agent" means a person granted authority to act for a 10 principal under a power of attorney, whether denominated an agent, 11 attorney-in-fact, or otherwise. The term includes an original agent, 12 coagent, successor agent, and a person to which an agent's authority 13 is delegated.

14 (2) "Durable," with respect to a power of attorney, means not 15 terminated by the principal's incapacity.

16 (3) "Electronic" means relating to technology having electrical, 17 digital, magnetic, wireless, optical, electromagnetic, or similar 18 capabilities.

19 (4) "Good faith" means honesty in fact.

20 (5) "Incapacity" means inability of an individual to manage 21 property, business, personal, or health care affairs because the 22 individual:

(a) Has an impairment in the ability to receive and evaluate
 information or make or communicate decisions even with the use of
 technological assistance; or

26 (b) Is:

27 (i) An absentee, as defined in chapter 11.80 RCW; or

28 (ii) Outside the United States and unable to return.

(6) "Person" means an individual, corporation, business trust,
 estate, trust, partnership, limited liability company, association,

joint venture, public corporation, government or governmental
 subdivision, agency, or instrumentality, or any other legal or
 commercial entity.

4 (7) "Power of attorney" means a writing that uses the term "power 5 of attorney" and grants authority to an agent to act in the place of 6 the principal.

7 (8) "Presently exercisable general power of appointment," with respect to property or a property interest subject to a power of 8 appointment, means power exercisable at the time in question to vest 9 absolute ownership in the principal individually, the principal's 10 11 estate, the principal's creditors, or the creditors of the principal's estate. The term includes a power of appointment not 12 13 exercisable until the occurrence of a specified event, the 14 satisfaction of an ascertainable standard, or the passage of a specified period only after the occurrence of the specified event, 15 16 the satisfaction of the ascertainable standard, or the passage of the 17 specified period. The term does not include a power exercisable in a fiduciary capacity or only by will. 18

19 (9) "Principal" means an individual who grants authority to an 20 agent in a power of attorney.

(10) "Property" means anything that may be the subject of ownership, whether real or personal, legal or equitable, tangible or intangible, or any interest or right therein.

(11) "State" means a state of the United States, the District of
 Columbia, Puerto Rico, the United States Virgin Islands, or any
 territory or insular possession subject to the jurisdiction of the
 United States.

(12) "Stocks, bonds, and financial instruments" means stocks, bonds, mutual funds, and all other types of securities and financial instruments, whether held directly, indirectly, or in any other manner. The term shall also include but not be limited to commodity futures contracts, call or put options on stocks or stock indexes, derivatives, and margin accounts.

34 <u>NEW SECTION.</u> **Sec. 103.** (1) This chapter applies to all powers 35 of attorney except:

36 (a) A power to the extent it is coupled with an interest in the
37 subject of the power, including a power given to or for the benefit
38 of a creditor in connection with a credit transaction;

(b) A proxy or other delegation to exercise voting rights or
 management rights with respect to an entity; and

3 (c) A power created on a form prescribed by a government or 4 governmental subdivision, agency, or instrumentality for a 5 governmental purpose.

6 (2) Notwithstanding subsection (1) of this section, section 117 7 of this act shall not apply to a power to make health care decisions 8 under sections 217 and 218 of this act, nor shall it apply to the 9 power to nominate a guardian for a minor child under section 218 of 10 this act.

NEW SECTION. Sec. 104. The authority conferred under a power of 11 attorney created prior to the effective date of this section, and 12 also for a power of attorney created on or after the effective date 13 of this section, terminates upon the incapacity of the principal 14 15 unless the writing contains the words "This power of attorney shall 16 not be affected by disability of the principal," or "This power of 17 attorney shall become effective upon the disability of the principal," or similar words showing the intent of the principal that 18 19 the authority conferred shall be exercisable notwithstanding the 20 principal's incapacity.

<u>NEW SECTION.</u> Sec. 105. (1) A power of attorney must be signed 21 22 and dated by the principal, and the signature must be either 23 acknowledged before a notary public or other individual authorized by 24 law to take acknowledgments, or attested by two or more competent 25 witnesses who are neither home care providers for the principal nor care providers at an adult family home or long-term care facility in 26 27 which the principal resides, and who are unrelated to the principal agent by blood, marriage, or state registered domestic 28 or 29 partnership, by subscribing their names to the power of attorney, 30 while in the presence of the principal and at the principal's direction or request. 31

32 (2) A power of attorney shall be considered signed in accordance 33 with this section if, in the case of a principal who is physically 34 unable to sign his or her name, the principal makes a mark in 35 accordance with RCW 11.12.030, or in the case of a principal who is 36 physically unable to make a mark, the power of attorney is executed 37 in accordance with RCW 64.08.100.

1 (3) A signature on a power of attorney is presumed to be genuine 2 if the principal acknowledges the signature before a notary public or 3 other individual authorized by law to take acknowledgments.

<u>NEW SECTION.</u> Sec. 106. (1) A power of attorney executed in this
state on or after the effective date of this section is valid if its
execution complies with section 105 of this act.

7 (2) A power of attorney executed in this state before the 8 effective date of this section is valid if its execution complied 9 with the law of this state as it existed at the time of execution.

10 (3) A power of attorney executed other than in this state is 11 valid in this state if, when the power of attorney was executed, the 12 execution complied with:

(a) The law of the jurisdiction that determines the meaning and effect of the power of attorney pursuant to section 107 of this act; or

16 (b) The requirements for a military power of attorney pursuant to 17 10 U.S.C. Sec. 1044b, as amended.

(4) Except as otherwise provided by statute other than this act,
a photocopy or electronically transmitted copy of an original power
of attorney has the same effect as the original.

21 <u>NEW SECTION.</u> Sec. 107. The meaning and effect of a power of 22 attorney is determined by the law of the jurisdiction indicated in 23 the power of attorney and, in the absence of an indication of 24 jurisdiction, by the law of the jurisdiction in which the power of 25 attorney was executed.

26 NEW SECTION. Sec. 108. (1) In a power of attorney, a principal may nominate a guardian of the principal's estate or guardian of the 27 28 principal's person for consideration by the court if protective proceedings for the principal's estate or person are begun after the 29 principal executes the power of attorney. Except for good cause shown 30 disqualification, the court shall make 31 or its appointment in accordance with the principal's most recent nomination. 32

33 (2) If, after a principal executes a power of attorney, a court 34 appoints a guardian of the principal's estate or other fiduciary 35 charged with the management of all of the principal's property, the 36 power of attorney is terminated and the agent's authority does not 37 continue unless continued by the court.

1 (3) If, after a principal executes a power of attorney, a court 2 appoints a guardian of the principal's estate or other fiduciary 3 charged with the management of some but not all of the principal's 4 property, the power of attorney shall not terminate or be modified, 5 except to the extent ordered by the court.

6 <u>NEW SECTION.</u> Sec. 109. (1) A power of attorney is effective 7 when executed unless the principal provides in the power of attorney 8 that it becomes effective at a future date or upon the occurrence of 9 a future event or contingency.

10 (2) If a power of attorney becomes effective upon the occurrence 11 of a future event or contingency, the principal, in the power of 12 attorney, may authorize one or more persons to determine in a writing 13 that the event or contingency has occurred.

14 (3) If a power of attorney becomes effective upon the principal's 15 incapacity and the principal has not authorized a person to determine 16 whether the principal is incapacitated, or the person authorized is 17 unable or unwilling to make the determination, the power of attorney 18 becomes effective upon a determination in a writing by:

(a) A physician or licensed psychologist, unrelated to the principal or agent by blood or marriage, who has personally examined the principal, that the principal is incapacitated within the meaning of section 102(5)(a) of this act; or

(b) A judge or an appropriate governmental official that the principal is incapacitated within the meaning of section 102(5)(b) of this act.

26 (4) A person authorized by the principal in the power of attorney 27 to determine that the principal is incapacitated may act as the principal's personal representative pursuant to the health insurance 28 portability and accountability act, sections 1171 through 1179 of the 29 30 social security act, 42 U.S.C. Sec. 1320d, as amended, and applicable regulations, to obtain access to the principal's health care 31 information and communicate with health 32 the principal's care 33 provider.

34 <u>NEW SECTION.</u> Sec. 110. (1) A power of attorney terminates when:

35 (a) The principal dies;

36 (b) The principal becomes incapacitated, if the power of attorney 37 is not durable;

38 (c) The principal revokes the power of attorney;

- (d) The power of attorney provides that it terminates;

(e) The purpose of the power of attorney is accomplished; or

3 (f) The principal revokes the agent's authority or the agent 4 dies, becomes incapacitated, or resigns, and the power of attorney 5 does not provide for another agent to act under the power of 6 attorney.

7

(2) An agent's authority terminates when:

8 (a) The principal revokes the authority;

9

(b) The agent dies, becomes incapacitated, or resigns;

10 (c) An action is filed for the dissolution or annulment of the 11 agent's marriage to the principal or for their legal separation, or 12 an action is filed for dissolution or annulment of the agent's state 13 registered domestic partnership with the principal or for their legal 14 separation, unless the power of attorney otherwise provides; or

15

(d) The power of attorney terminates.

16 (3) An agent's authority which has been terminated under 17 subsection (2)(c) of this section shall be reinstated effective 18 immediately in the event that such action is dismissed with the 19 consent of both parties or the petition for dissolution, annulment, 20 or legal separation is withdrawn.

(4) Unless the power of attorney otherwise provides, an agent's authority is exercisable until the authority terminates under subsection (2) of this section, notwithstanding a lapse of time since the execution of the power of attorney.

(5) Termination of an agent's authority or of a power of attorney is not effective as to the agent or another person that, without actual knowledge of the termination, acts in good faith under the power of attorney. An act so performed, unless otherwise invalid or unenforceable, binds the principal and the principal's successors in interest.

(6) Incapacity of the principal of a power of attorney that is not durable does not revoke or terminate the power of attorney as to an agent or other person that, without actual knowledge of the incapacity, acts in good faith under the power of attorney. An act so performed, unless otherwise invalid or unenforceable, binds the principal and the principal's successors in interest.

37 (7) The execution of a power of attorney does not revoke a power 38 of attorney previously executed by the principal unless the 39 subsequent power of attorney provides that the previous power of 40 attorney is revoked or that all other powers of attorney are revoked.

NEW SECTION. Sec. 111. (1) A principal may designate in a power of attorney two or more persons to act as coagents. Unless the power of attorney otherwise provides, all coagents must exercise their authority jointly; provided, however, a coagent may delegate that coagent's authority to another coagent.

6 (2) A principal may designate one or more successor agents to act 7 if an agent resigns, dies, becomes incapacitated, is not qualified to 8 serve, or declines to serve. A principal may grant authority to 9 designate one or more successor agents to an agent or other person 10 designated by name, office, or function. Unless the power of attorney 11 otherwise provides, a successor agent:

12 (a) Has the same authority as that granted to the original agent;13 and

(b) May not act until all predecessor agents have resigned, died, become incapacitated, are no longer qualified to serve, or have declined to serve.

17 (3) Except as otherwise provided in the power of attorney and 18 subsection (4) of this section, an agent that does not participate in 19 or conceal a breach of fiduciary duty committed by another agent, 20 including a predecessor agent, is not liable for the actions of the 21 other agent.

(4) An agent that has actual knowledge of a breach or imminent 22 breach of fiduciary duty by another agent shall notify the principal 23 24 and, if the principal is incapacitated, take any action reasonably appropriate in the circumstances to safeguard the principal's best 25 26 interest. An agent that fails to notify the principal or take action 27 as required by this subsection is liable for the reasonably foreseeable damages that could have been avoided if the agent had 28 29 notified the principal or taken such action.

30 <u>NEW SECTION.</u> Sec. 112. Unless the power of attorney otherwise 31 provides, an agent is entitled to reimbursement of expenses 32 reasonably incurred on behalf of the principal and to reasonable 33 compensation.

34 <u>NEW SECTION.</u> **Sec. 113.** Except as otherwise provided in the 35 power of attorney, a person accepts appointment as an agent under a 36 power of attorney by exercising authority or performing duties as an 37 agent or by any other assertion or conduct indicating acceptance.

1 <u>NEW SECTION.</u> **Sec. 114.** (1) Notwithstanding provisions in the 2 power of attorney, an agent that has accepted appointment shall:

3 (a) Act in accordance with the principal's reasonable 4 expectations to the extent actually known by the agent and, 5 otherwise, in the principal's best interest;

6 (b) Act in good faith; and

7 (c) Act only within the scope of authority granted in the power 8 of attorney.

9 (2) Except as otherwise provided in the power of attorney, an 10 agent that has accepted appointment shall:

11

(a) Act loyally for the principal's benefit;

(b) Act so as not to create a conflict of interest that impairs the agent's ability to act impartially in the principal's best interest;

15 (c) Act with the care, competence, and diligence ordinarily 16 exercised by agents in similar circumstances;

17 (d) Keep a record of all receipts, disbursements, and18 transactions made on behalf of the principal;

(e) Cooperate with a person that has authority to make health care decisions for the principal to carry out the principal's reasonable expectations to the extent actually known by the agent and, otherwise, act in the principal's best interest; and

(f) Attempt to preserve the principal's estate plan, to the extent actually known by the agent, if preserving the plan is consistent with the principal's best interest based on all relevant factors, including:

27

(i) The value and nature of the principal's property;

28 (ii) The principal's foreseeable obligations and need for 29 maintenance;

30 (iii) Minimization of taxes, including income, estate, 31 inheritance, generation-skipping transfer, and gift taxes; and

32 (iv) Eligibility for a benefit, a program, or assistance under a 33 statute or rule.

34 (3) An agent that acts in good faith is not liable to any
 35 beneficiary of the principal's estate plan for failure to preserve
 36 the plan.

37 (4) An agent that acts with care, competence, and diligence for 38 the best interest of the principal is not liable solely because the 39 agent also benefits from the act or has an individual or conflicting 40 interest in relation to the property or affairs of the principal. 1 (5) If an agent is selected by the principal because of special 2 skills or expertise possessed by the agent or in reliance on the 3 agent's representation that the agent has special skills or 4 expertise, the special skills or expertise must be considered in 5 determining whether the agent has acted with care, competence, and 6 diligence under the circumstances.

7 (6) Absent a breach of duty to the principal, an agent is not8 liable if the value of the principal's property declines.

9 (7) An agent that engages another person on behalf of the 10 principal is not liable for an act, error of judgment, or default of 11 that person if the agent exercises care, competence, and diligence in 12 selecting and monitoring the person, provided however that the agent 13 shall not be relieved of liability for such person's discretionary 14 acts, that, if done by the agent, would result in liability to the 15 agent.

16 (8) Unless section 111(1) of this act applies, an agent may only 17 delegate authority to another person if expressly authorized to do so in the power of attorney and may delegate some, but not all, of the 18 authority granted by the principal. An agent that exercises authority 19 20 to delegate to another person the authority granted by the principal 21 is not liable for an act, error of judgment, or default of that person if the agent exercises care, competence, and diligence in 22 selecting and monitoring the person, provided however that the agent 23 shall not be relieved of liability for such person's discretionary 24 25 acts, that, if done by the agent, would result in liability to the 26 agent.

(9) Except as otherwise provided in the power of attorney, 27 an agent is not required to disclose receipts, disbursements, 28 or 29 transactions conducted on behalf of the principal unless ordered by a court or requested in writing by the principal, a guardian, a 30 31 conservator, another fiduciary acting for the principal, а governmental agency having authority to protect the welfare of the 32 principal, or, upon the death of the principal, by the personal 33 representative or successor in interest of the principal's estate. 34 Such request by a guardian, conservator, or another fiduciary acting 35 36 for the principal must be limited to information reasonably related that guardian, conservator, or fiduciary's 37 to duties. Ιf so requested, within thirty days the agent shall comply with the request 38 39 or provide a writing or other record substantiating why additional

1 time is needed and shall comply with the request within an additional 2 thirty days.

3 <u>NEW SECTION.</u> Sec. 115. A provision in a power of attorney 4 relieving an agent of liability for breach of duty is binding on the 5 principal and the principal's successors in interest except to the 6 extent the provision:

7 (1) Relieves the agent of liability for breach of duty committed 8 dishonestly, with an improper motive, or with gross negligence to the 9 purposes of the power of attorney or the best interest of the 10 principal; or

11 (2) Was inserted as a result of an abuse of a confidential or 12 fiduciary relationship with the principal.

13 <u>NEW SECTION.</u> Sec. 116. (1) Except as otherwise provided in the 14 power of attorney, the following persons may bring a petition 15 described in subsection (2) of this section:

16

(a) The principal or the agent;

17 (b) The spouse or state registered domestic partner of the 18 principal;

19 (c) The guardian of the estate or person of the principal;

Any other interested person, as 20 (d) long as the person demonstrates to the court's satisfaction that the person 21 is interested in the welfare of the principal and has a good faith 22 23 belief that the court's intervention is necessary, and that the principal is incapacitated at the time of filing the petition or 24 otherwise unable to protect his or her own interests; and 25

26

(e) A person asked to accept the power of attorney.

(2) A person designated in subsection (1) of this section may
file a petition requesting the court to construe a power of attorney
or grant any other appropriate relief, including but not limited to:

30 (a) Determination of whether the power of attorney is in effect31 or has terminated;

(b) Compelling the agent to submit the agent's accounts or report 32 the agent's acts as agent to the principal, the spouse or state 33 34 registered domestic partner of the principal, the guardian of the person or the estate of the principal, or to any other person 35 required by the court in its discretion, if the agent has not timely 36 complied with a request under section 114(9) of this act. However, a 37 government agency having authority to protect the welfare of the 38 Code Rev/AI:akl 10 H-4581.1/16 1 principal may file a petition upon the agent's refusal or failure to 2 submit an accounting upon written request and shall not be required 3 to wait sixty days;

4 (c) Ratification of past acts or approval of proposed acts of the 5 agent;

6 (d) Issuance of an order directing the agent to exercise or 7 refrain from exercising authority in a power of attorney in a 8 particular manner or for a particular purpose;

9 (e) Modification of the authority of an agent under a power of 10 attorney;

(f) Removal of the agent on a determination by the court of both of the following:

13 (i) Determination that the agent has violated or is unfit to 14 perform the fiduciary duties under the power of attorney; and

15 (ii) Determination that the removal of the agent is in the best 16 interest of the principal;

(g) Approval of the resignation of the agent and approval of the final accountings of the resigning agent if submitted, subject to any orders the court determines are necessary to protect the principal's interests;

(h) Confirmation of the authority of a successor agent to act under a power of attorney upon removal or resignation of the previous agent;

(i) Compelling a third person to honor the authority of an agent, provided that a third person may not be compelled to honor the agent's authority if the principal could not compel the third person to act in the same circumstances;

(j) Order the agent to furnish a bond in an amount the court determines to be appropriate.

30 (3) Any action commenced under this section shall be subject to31 the notice requirements of chapter 11.96A RCW.

32 (4) Upon motion by the principal, the court shall dismiss a 33 petition filed under this section, unless the court finds that the 34 principal lacks capacity to revoke the agent's authority or the power 35 of attorney.

36 (5) Except as otherwise provided in section 120(3)(b) of this 37 act, any action commenced under this section shall be subject to the 38 provisions of RCW 11.96A.150.

NEW SECTION. Sec. 117. An agent that violates this chapter is liable to the principal or the principal's successors in interest for the amount required to restore the value of the principal's property to what it would have been had the violation not occurred.

5 <u>NEW SECTION.</u> Sec. 118. Unless the power of attorney has been 6 terminated in accordance with section 108 of this act, or the power 7 of attorney provides a different method for an agent's resignation, 8 an agent may resign by giving notice to the principal and, if the 9 principal is incapacitated:

10 (1) To the conservator or guardian, if one has been appointed for 11 the principal, and a coagent or successor agent, if designated; or

12 (2) If there is no person described in subsection (1) of this 13 section:

14 (a) To any person reasonably believed by the agent to have15 sufficient interest in the principal's welfare;

16 (b) To a governmental agency having authority to protect the 17 welfare of the principal; or

18 (c) By filing notice with the county recorder's office in the 19 county where the principal resides.

20 <u>NEW SECTION.</u> Sec. 119. (1) For purposes of this section and 21 section 120 of this act, "acknowledged" means purportedly verified 22 before a notary public or other individual authorized to take 23 acknowledgments.

(2) A person that in good faith accepts an acknowledged power of attorney without actual knowledge that the signature is not genuine may rely upon the presumption under section 105 of this act that the signature is genuine.

(3) A person that in good faith accepts an acknowledged power of 28 29 attorney without actual knowledge that the power of attorney is void, invalid, or terminated, that the purported agent's authority is void, 30 invalid, or terminated, or that the agent is exceeding or improperly 31 exercising the agent's authority may rely upon the power of attorney 32 33 as if the power of attorney were genuine, valid and still in effect, 34 the agent's authority were genuine, valid and still in effect, and the agent had not exceeded and had properly exercised the authority. 35

36 (4) A person that is asked to accept an acknowledged power of37 attorney may request, and rely upon, without further investigation:

(a) An agent's certification given under penalty of perjury
 meeting the requirements of subsection (5) of this section; and

3 (b) An English translation of the power of attorney if the power 4 of attorney contains, in whole or in part, language other than 5 English.

6 (5) A certification presented pursuant to subsection (4) of this 7 section or pursuant to section 120 of this act shall state that:

8 (a) The person presenting himself or herself as the agent and 9 signing the affidavit or declaration is the person so named in the 10 power of attorney;

(b) If the agent is named in the power of attorney as a successor agent, the circumstances or conditions stated in the power of attorney that would cause that person to become the acting agent have occurred;

15 (c) To the best of the agent's knowledge, the principal is still 16 alive;

(d) To the best of the agent's knowledge, at the time the power of attorney was signed, the principal was competent to execute the document and was not under undue influence to sign the document;

20 (e) All events necessary to making the power of attorney 21 effective have occurred;

(f) The agent does not have actual knowledge of the revocation, termination, limitation, or modification of the power of attorney or of the agent's authority;

(g) The agent does not have actual knowledge of the existence of other circumstances that would limit, modify, revoke, or terminate the power of attorney or the agent's authority to take the proposed action;

29 (h) If the agent was married to or in a state registered domestic partnership with the principal at the time of execution of the power 30 31 attorney, then at the time of signing the affidavit of or declaration, the marriage or state registered domestic partnership of 32 the principal and the agent has not been dissolved or declared 33 invalid, and no action is pending for the dissolution of the marriage 34 or domestic partnership or for legal separation; and 35

36 (i) The agent is acting in good faith pursuant to the authority 37 given under the power of attorney.

38 (6) An English translation requested under this section must be 39 provided at the principal's expense unless the request is made more

1 than seven business days after the power of attorney is presented for 2 acceptance.

3 (7) For purposes of this section and section 120 of this act, a 4 person that conducts activities through employees is without actual 5 knowledge of a fact relating to a power of attorney, a principal, or 6 an agent if the employee conducting the transaction involving the 7 power of attorney is without actual knowledge of the fact.

8 <u>NEW SECTION.</u> **Sec. 120.** (1) Except as otherwise provided in 9 subsection (2) of this section:

10 (a) A person shall either accept an acknowledged power of 11 attorney or request a certification or a translation no later than 12 seven business days after presentation of the power of attorney for 13 acceptance;

(b) If a person requests a certification or a translation, the
person shall accept the power of attorney no later than five business
days after receipt of the certification or translation; and

(c) A person may not require an additional or different form of power of attorney for authority granted in the power of attorney presented.

20 (2) A person is not required to accept an acknowledged power of 21 attorney if:

(a) The person is not otherwise required to engage in atransaction with the principal in the same circumstances;

(b) Engaging in a transaction with the agent or the principal inthe same circumstances would be inconsistent with federal law;

26 (c) The person has actual knowledge of the termination of the 27 agent's authority or of the power of attorney before exercise of the 28 power;

29

(d) A request for a certification or a translation is refused;

30 (e) The person in good faith believes that the power is not valid 31 or that the agent does not have the authority to perform the act 32 requested, whether or not a certification or a translation has been 33 requested or provided; or
