1 AN ACT Relating to creating a dedicated account for elevators,
2 lifting devices, moving walks, manufactured and mobile homes,
3 recreational and commercial vehicles, factory built housing and
4 commercial structures, and contractor registration and compliance
5 activities; amending RCW 70.87.210; adding a new section to chapter
6 18.27 RCW; adding a new section to chapter 43.22 RCW; adding a new
7 section to chapter 51.44 RCW; and providing an effective date.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 **Sec. 1.** RCW 70.87.210 and 1963 c 26 s 21 are each amended to
10 read as follows:

11 All moneys, except fines and penalties, received or collected
12 under the terms of this chapter shall be deposited in the (~~general~~
13 ~~fund~~)construction registration inspection account. All fines and
14 penalties received or collected under the terms of this chapter shall
15 be deposited in the general fund.

16 NEW SECTION. **Sec. 2.** A new section is added to chapter 18.27
17 RCW to read as follows:

18 All moneys, except fines and penalties, received or collected
19 under the terms of this chapter must be deposited into the
20 construction registration inspection account. All fines and penalties

1 received or collected under the terms of this chapter shall be
2 deposited in the general fund.

3 NEW SECTION. **Sec. 3.** A new section is added to chapter 43.22
4 RCW to read as follows:

5 All moneys, except fines and penalties, received or collected
6 under the terms of RCW 43.22.335 through 43.22.430 and 43.22.432
7 through 43.22.495 must be deposited into the construction
8 registration inspection account. All fines and penalties received or
9 collected under the terms of RCW 43.22.335 through 43.22.430 and
10 43.22.432 through 43.22.495 shall be deposited in the general fund.

11 NEW SECTION. **Sec. 4.** A new section is added to chapter 51.44
12 RCW to read as follows:

13 (1) The construction registration inspection account is created
14 in the state treasury. All moneys, except fines and penalties,
15 received or collected under the terms of chapters 18.27 and 70.87 RCW
16 and under the terms of RCW 43.22.335 through 43.22.430 and 43.22.432
17 through 43.22.495 must be deposited into the account. Moneys in the
18 account may only be spent after appropriation. Expenditures from the
19 account, not including moneys transferred to the general fund, may be
20 used only to carry out the purposes of chapters 18.27 and 70.87 RCW
21 and RCW 43.22.335 through 43.22.430 and 43.22.432 through 43.22.495.

22 (2) The department shall set the fees deposited in the account at
23 a level that generates revenue that is as near as practicable to the
24 amount of the appropriation to carry out the duties specified in this
25 section.

26 (3) On the last working day of the first month following each
27 quarterly period, seven percent of all revenues received into the
28 account during the previous quarter from licenses, permits, and
29 registrations, net of refunds paid to customers, must be transferred
30 into the general fund.

31 NEW SECTION. **Sec. 5.** This act takes effect July 1, 2017.
